arrange a seat in Narayanganj.

Tushar, who initially served as a personal secretary to a ruling party leader in Dhaka, got access to prominent political party programmes.

During political rallies or programmes, he used to

capture photographs of top political party leaders and later used them to deceive people, said Rab.

“Interestingly, Tushar even made a deal with the party leader for Tk 150 crore, for whom he used to work as PS once,” said a high official of Rab involved with the investigation.

Tushar didn’t spare the media industry either, attempting to convince the owner of a private television channel to sell it for Tk 70 crore in exchange for arranging a nomination, said Rab.

“Tushar swindled at least Tk 5 crore through such dealings, while he owns twenty bighas of land, seven buses, and a couple of houses in different areas of the country,” said the official.

To mislead his victims, Tushar saved international WhatsApp numbers or

phone contacts under the guise of the prime minister’s relatives, instructing his followers to send messages or make fake calls when needed, said investigators.

Even an official of a law enforcement agency made a deal with Tushar for Tk 20 crore after he promised to secure the position of agency chief, said Rab.

Commander Khandaker Al Moin, director of the legal and media wing of Rab, yesterday told The Daily Star, “We have retrieved messages of Tushar falsely identifying

himself as the prime minister’s relative and assuring people to secure nominations for them in the upcoming election.”

“Tushar used to demand Tk 100-300 crore for the nominations, depending on seats. We have collected the footage of the meetings he used to hold with different people in different restaurants,” he said.

Moin also said they are vigilant and prepared to take legal action against anyone spreading false information regarding the national election.

There must be a strong monitoring system to analyse local government initiatives, functionality of adolescent clubs, and implementation of laws to curb child marriage and strengthen our young girls, she added.

“It’s not possible to create a gender-neutral society with gender-blind laws that have no impact analysis. Unfortunately, our social norms are

so prominent that they defeat and challenge legal procedures,” said Prof Tania Haque of the Department of Women and Gender Studies at Dhaka University.

“Voluntarism, leadership, and knowledge of basic skills can help a girl grow and take her own responsibility. Thus, educational institutes must practise these activities strictly. A little more investment could bring a massive change,” she added.
