Custodial torture or bike accident?

DMP, PBI probes come up with conflicting reports over torture of jewellery-shop worker

A jewellery-shop worker was allegedly picked up, beaten with cricket stumps and given electric shocks by errant cops on February 11, 2019.

As per allegations, the incident culminated in the seizure of gold valued at Tk 11.58 lakh and Tk 41,300 in cash. He was released upon a payment of Tk 2 lakh made by his family members to the cops

Dhaka Metropolitan Later, Police's Professional Standard and Internal Investigation Division withheld five consecutive yearly increments of three police officers, after a probe found them guilty of the crime.

DMP conducted the probe in phases between May 2019 and March 2020 before submitting the report on January 22, 2022.

However, just months after, the Police Bureau of Investigation probed the same incident and came up with a different narrative.

Submitted in December 2022, the PBI report found that the victim, Rajib Kar, was not tortured by police, but the injuries he sustained were the result of a fall from a bike.

Contacted, Rajib said PBI is trying to save the accused police officers.

On March 3, 2022, Rajib filed a case against Sub-inspector Mizanur Rahman, 40, SI Abdul Jalil, 35, and Assistant Sub-inspector Farid Miah, 35, under the Torture and Custodial Death (Prevention) Act with a Dhaka court, claiming compensation for gold jewellery seized from him during the raid.

According to the case, SI Mizan and ASI Farid, in plainclothes, picked up Rajib from his residence in Dhaka's Goalnagar area around 2:30am on February 11, 2019, and took him to the police station on a motorbike without producing any warrant.

At the station, SI Mizan and ASI Farid beat Rajib with a cricket stump in lockup, causing him to faint. When he regained consciousness, him again, this time with electric Mitford Hospital (Sir Salimullah Medical College Hospital) and given treatment there.

In response to Rajib's case, the court tasked PBI with carrying out an inquiry into the complaint.

Rahman Chowdhury, the then additional superintendent of police at PBI, ruled out any incident of custodial torture.

When the police officers were taking Rajib to the police station on a motorbike, he tried to flee and fell from the bike," his report said.

After first aid, Rajib was kept in the lockup of the police station. Sometime later, when he started feeling unwell, the duty officer sent him to Mitford Hospital.

Contacted, Kutubur, who went on retirement in January this year, said he prepared the report based on statements from witnesses and persons relevant to the incident.

Bangladesh Jatri Kalyan Samity, a group working on road safety, yesterday demanded Tk 10 lakh for the family of each victim killed in road accidents and Tk 5 lakh for those injured.

It also demanded full implementation of the existing law in all road accident

According to the existing law, families of each deceased are entitled to Tk 5 lakh and the injured Tk 3 lakh from the road accident victims' financial assistance fund.

On the eve of National Road Safety Day, Mozammel Hoque Chowdhury, secretary general of the Samity, placed the demands at a press conference at Dhaka Reporters Unity in the capital

According to the Bangladesh Road Transport Authority (BRTA), around 4,016 road accidents occurred from January to September this year, killing

3,727 people and injuring 5,781.

According to those statistics, the families of the deceased are entitled to Tk 186.35 crore and the injured are entitled to Tk 173.43 crore in compensation, he said.

On Thursday, for the first time, the government provided compensation worth Tk 7.8 crore to 162 road crash victims and their families.

Mozammel also said even though the BRTA and the Road Transport and Bridges Ministry have formed Road Safety Units, they do not have any research to prevent road accidents.

As a result, the number of road accidents and deaths is increasing every

Jatri Kalyan Samity also demanded an extension of the deadline for applying for financial assistance to one year from one month, transparency and accountability in releasing the fund, and introduction of an e-traffic prosecution system with CCTV cameras.

Abdul Jabbar, 70, had reportedly been stuck in Karachi all these years, while en route to Iran for a job arranged through a middleman, as per information from Brac and his family.

Shariful Hasan, the associate director of Brac Migration Programme, yesterday said they have handled a minimum of 10 cases in the last six years, involving the need to locate the families of returnees and reunite them following a prolonged lack of communication.

In the past six years, Brac Migration Programme provided support to about 34,000 returnee migrants. Out of these cases, Brac had to find families of 124 returnees and reunite them, Shariful told this newspaper over the phone.

As part of its initiatives, Brac Migration Programme provides various support services to both returnee and outbound migrant workers at Hazrat Shahjalal International Airport in the Shariful said they learnt about Jabbar's case

when his son Kamal Hossain communicated with them a couple of months back and sought support to get back his father.

He said Jabbar returned home on a flight on Friday night.

Later, he was taken to Brac's welfare centre in Ashkona where his family members were waiting, he said. After due procedure, Jabbar was handed over to his family around 11:30pm that night.

Kamal told this newspaper over phone that when his father left the country in 1988, he was in
