20 killed in Cameroon separatist attack

Separatist rebels yesterday killed around 20 people, including women and children, in an attack on a village in one of Cameroon's restive anglophone regions, the government said.

The overnight assault occurred at Egbekaw village, western Cameroon, the scene of deadly clashes between rebels and government forces for seven years.

"There were men, women and children, more than 20 killed," minister at the presidency Mengot Victor Arrey-Nkongho told public radio. "It's intolerable."

Cameroon's primarily English-speaking Northwest and Southwest regions have been gripped by conflict since separatists declared independence in 2017.

That followed decades of grievances over perceived discrimination by the francophone majority.

19 Ukrainian soldiers killed

Kyiv says; drones, missiles damage Odesa museum, injures 8

A Ukrainian military brigade said vesterday 19 of its soldiers were killed last week in a Russian air strike that President Volodymyr Zelenskiy described as "a tragedy that could have been avoided".

Ukrainian media reported that the soldiers were killed during an awards ceremony on Friday in the frontline Zaporizhzhia region of southeastern Ukraine, reports Reuters.

A statement issued by the 128th Separate Mountain Assault Brigade yesterday provided the death toll but gave few other details.

Russian strikes Meanwhile, overnight in the southern Ukrainian region of Odesa left eight people wounded and damaged a historic art museum, Ukrainian officials

said vesterday, in the latest barrage of drones and missiles, according to

Three more were injured in a Russian shelling attack on the southern city of Kherson on Monday, as Kyiv doubled down on its warnings that Russia was planning to pummel Ukraine's energy infrastructure ahead of the winter.

Images released by officials from inside the Odesa Fine Arts Museum showed art ripped from the walls of the 19th-century building and windows blown out by the aerial bombardment.

Ukraine's deputy foreign minister Emine Dzheppar said Kyiv was "deeply outraged" by the attack and urged the United Nations' Parisbased heritage agency Unesco to condemn the strike.

Unesco said it "strongly condemns the attack" and that "cultural sites must be protected".

Kyiv said earlier that Russian forces had launched four missiles and nearly two dozen attack drones from occupied regions of the country in the south overnight.

Ukraine's military downed 15 drones and one of the missiles, it said in a statement.

The gallery said on social media the attack had occurred on the museum's 124th birthday and the facility would be closed until further

The governor of the Odesa region, Öleg Kiper, said most of the collection had already been removed during the war. "Canvases and paintings from the current exhibition were not damaged," he added on social media

Trump testifying in civil trial

Donald Trump was in a New York court vesterday to testify in a civil fraud case threatening to cripple his real estate empire, the first former president to take the stand as a defendant in more than a century.

The 77-year-old Republican arrived shortly before 10:00 am (1500 GMT) to testify in the Manhattan courtroom before Judge Arthur Engoron.

Trump, the frontrunner for the 2024 Republican presidential nomination, denounced the case as "very unfair" as he arrived for his testimony, calling it "political lawfare" and "election interference."

"It's a very sad situation for our country," he said. "It usually takes place in third world

Trump and his two eldest sons, Don Jr and Eric, and other Trump Organization executives are accused of exaggerating the value of its real estate assets by billions of dollars to obtain more favorable bank loans and insurance terms.

New York Attorney General Letitia James, speaking to reporters before Trump's arrival, said the real estate tycoon "consistently misrepresented and inflated the value of his assets."

"Before he takes the stand, I am certain that he will engage in name-calling and taunts and race-baiting and call this a witch hunt," James said. "But at the end of the day, the only thing that matters are the facts and the numbers.

"And numbers, my friends, don't lie."

Trump has repeatedly attacked James, who is Black, and the judge overseeing the case calling him "unhinged" and a "Trump-hating radical left, Democrat operative."


Engoron has responded by slapping Trump with two fines -- one for USD 5,000, another for USD 10,000 -- when he ruled the onetime reality television star had violated a partial gag order imposed after he bashed the judge's clerk on social media.

Trump's testimony follows that of his sons Don Jr and Eric, who took the stand last week and blamed accountants for the financial statements of the company.




