

Anwaruzzaman takes charge as Sylhet mayor

Newly elected mayor of Sylhet City Corporation Anwaruzzaman Chowdhury took charge of his office yesterday, pledging to work for the development of the city.

The AL-backed mayor took charge of the SCC five months after winning the city polls.

Outgoing BNP-backed mayor Ariful Haque Choudhury greeted him in the mayor's office at Nagar Bhaban and handed over the charges to him.

Outgoing SCC mayor Ariful mentioned his 10 years of hard work to develop the city and pledged to extend his support to the new mayor.

Three BNP leaders get anticipatory bail from HC

The High Court yesterday granted anticipatory bail to three BNP leaders and lawyers — Zainul Abedin, Nitai Roy Chowdhury and AM Mahbub Uddin Khokon — for three weeks in two cases filed over vandalising the chief justice's residence and preventing police from discharging duties on October 28.

The HC, however, ordered them to surrender before the lower court concerned in three weeks.

The bench of Justice Abu Taher Md Saifur Rahman and Justice Md Bashir Ullah passed the order.

The HC granted the anticipatory bail to the accused as they are senior lawyers and said the order of their bail will not be applicable as reference for bail of other accused in the case.

During hearing of the bail petitions, the HC bench said the attack on the chief justice's residence is the attack on the heart of the judiciary, which cannot be accepted in any manner.

Metro starts at 7:10am from Uttara today

The metro rail authorities will operate two additional trains from 7:10am and 7:20am today from the Uttara end mainly to facilitate the trips of students and teachers of different educational institutions.

However, the extended services would be available only for the MRT Pass/ Rapid Pass holders (permanent pass), Tarafdar Mahmudur Rahman, deputy project director (public relations) of Mass Rapid Transit Line, told The Daily Star yesterday.

Educational institutions usually open at 8:00am and many people requested the authorities to start metro operations at least half an hour earlier so that students and teachers can avail the service, said

MAN Siddique, managing director of Dhaka Mass Transit Company Ltd.

"So, we are considering to start metro services from 7:00am," he said.

Currently, metro rails are being operated between 7:30am and 11:30am on Agargaon-Motijheel route. However, MRT Pass holders can avail the service until noon.

The Agargaon-Motijheel section of the country's first metro rail (MRT-6) opened to public on Sunday, generating huge interest among metro users, especially among the office goers.

At least 26,000 people used exit points at Motijheel, Secretariat and Farmgate stations on the first day, but the number of people who used the entry points at those stations was very low, MAN

Siddique said.

The number of passengers using the exit points at those three stations increased further in the last two days, he added.

"So, we are going to increase one exit gate each at Farmgate, Secretariat and Motijheel stations to facilitate the trips of those passengers," he said.

The three stations are among the seven on Agargaon-Motijheel section currently open to passengers. The authorities have announced to open the Dhaka University station within a month and the rest three within next three months.

After making all stations operational, the authorities will increase both the service time and frequency of trains.

approval of three housing projects — BCS Admin Housing Society; Police Officers Housing Society and Bonrupa Residential Project — are underway.

The capital's development authority also said land has been acquired for Rajuk Uttara Model Town (Sector 4 and 6) project. However, it did not clarify whether the project has been approved or not.

Five projects — East West Properties Ltd, Jolshiri Housing Project, Neptune Properties Ltd, Swadesh Residential Project and Lake City Concord — have got final approval from Rajuk.

Ashrafur Islam, Rajuk's urban planner, Nabayan Khisa, deputy urban planner and Md Hasibul Hasan, assistant urban planner, signed the document on November 5.

On November 2, the SC asked the additional attorney general to produce the papers before it during hearing of two appeals that challenged a High Court judgement which justified the Ashiyani City housing project in Dhaka's Holan and Ashkona.

Yesterday, a five-member bench of the Appellate Division, led by Chief Justice Obaidul Hassan, heard the appeals and set November 22 for verdict.

The appeals were filed by the government and eight organisations — including Bangladesh Environmental Lawyers Association, Ain o Salish Kendra, and BLAST.

Rights, International Rehabilitation Council for Torture Victims, Omega Research Foundation, Redress and World Organisation Against Torture.

"We stand in solidarity with the people of Bangladesh in their pursuit of a just, democratic, and peaceful society and call for an immediate end to the cycle of violence, repression, and intimidation against political opponents, as well as the immediate release of all the individuals who have been arbitrarily detained," it said.

"The United Nations member states must raise these concerns during the fourth cycle of the Universal Periodic Review (UPR) on Bangladesh, taking place on November 13, 2023 since the current human rights abuses result from a pattern of violence and repression of dissidents in the country," it said.
