

Bids must be delivered to the address indicated in the clause ITB 22.1 of the bidding document on or before 13.00 hours (GMT+6) on 02 January, 2024. Electronic Bidding will not be permitted. Late Bids will be rejected. All envelopes marked "QUALIFICATION" will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below on 1600 hours (GMT +6) on 02 January, 2024. All envelopes marked "BID" shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
