

Forest dept sets 5 routes to Dublar Char

The Forest Department has designated five water routes for devotees and visitors heading to Dublar Char in the Sundarbans to participate in the Rash Mela scheduled for November 25-27.

The routes are Burigoalini-Kobadak rivers to DUBLAR CHAR via Batulanadi-Balnadi-Patkotsa-Hongshoraj-Koyra-Kashiabad-Khashitana-Bojboja via Arua Shiba Shiba river-Marjat-Naliyan Station to DUBLAR CHAR via Shiba Marjat river, Dangmari-Chandpai station via Teenkona Dwip to DUBLAR CHAR, and Bogi-Baleswar-Supoti-Kachikhali station then to DUBLAR CHAR crossing Shelar CHAR.

They will have to pay an entry fee and no one will be allowed to move during night time, said Forest Department officials. Boats, launches and trawlers have to go to the festival area through the Forest Department checkpoints.

1 held over abduction of schoolgirl in Ctg

Police yesterday arrested a man for allegedly abducting a schoolgirl in the port city's Chandgaon area.

The arrestee Shakil, 23, a resident of Pathan Khejur Tala area of Chandgaon, allegedly tried to marry the girl forcibly after abducting her, but police managed to rescue her in time.

"Accused Shakil, a motor garage worker, and his two friends abducted the schoolgirl at knife-point while she was with her mother in Ishpani area on Tuesday evening, and fled the scene by a CNG run auto rickshaw," said Chandgaon OC Jahidul Kabir.

“Following the incident, the victim’s mother lodged a complaint with the police station on Tuesday night. Scrutinising the CCTV footage, police identified Shakil and conducted drives in different areas. Later in the night, police located him in Sitakunda upazila and arrested him,” he added.

Man to die for rape, murder of woman

A Manikganj court yesterday sentenced a man to death for killing a mentally challenged woman after raping her in Singair upazila.

Judge Begum Tania Kamal of Manikganj Women and Children Repression Prevention Tribunal delivered the verdict in the afternoon in presence of the convict, Rokman Hossain Tona, 35, of Bara Kaliakoir area of Singair.

Rokman Hossain Tona was caught red handed while trying to escape after killing and raping a 45-year-old mentally challenged woman in Golaidanga Basta area of the upazila on December 5, 2019, said AKM Nurul Huda Rubel, special public prosecutor of the tribunal. The victim's sister filed a case the next day, he said.

Inspector Abdus Sattar of the police station, also the case's investigation officer, submitted charge-sheet before court on April 18, 2020 accusing Rokman.

RCC announces Tk 1,015.34cr budget

SC sentences
two to life term

The Supreme Court yesterday sentenced two convicts – Mehedi Hasan Swapan and Sumon Jamadder – to life imprisonment in a case filed over the rape and murder of a girl, Fatima Akhter Eti, in Mathbaria of Pirojpur in 2014.

A four-member bench of the Appellate Division of the SC, headed by Chief Justice Obaidul Hassan, delivered the verdict after scrapping a High Court verdict that on June 30, 2021 acquitted Swapan and Sumon, who had been sentenced to death by the trial court.

The SC verdict came following an appeal filed by the state challenging the HC verdict.

Other three judges of the bench are -- Justice Md Enayetur Rahim, Justice Md Ashfaquul Islam and Justice Md Abu Zafor Siddique.

Nine-year-old Eti, a student of Hatem Ali Government Primary School and daughter of Ful Miah Hawlader from Jhatibunia in Mathbaria, used to live at her maternal grandfather's house at Bandhabpara-Bukhaitala village.

On October 5, 2014, she went to a nearby field to bring a cow back home. Mehedi and Sumon forcibly took her to an orchard and raped her. The two then strangled her to death.
