

Safeguarding intangible cultural heritage: Still a long way to go?

"It's a long way to go, yes. But with adequate assistance from the government and communities, we will be able to safeguard our cultural heritage," Lubna concludes with a hopeful smile.

Cultural heritage encompasses both tangible and intangible elements that form the bedrock of ethnic or regional practices, connecting the past with the present and future. Bangladesh, with a population of approximately 170 million across 148,460 square kilometres, boasts a rich cultural tapestry comprising unique traditions and practices.

While many countries grapple with challenges to preserve their cultural identities, Bangladeshis are intricately woven into diverse tangible and intangible cultural facets. Grandmothers impart regional fantasy stories, lullabies, and traditional recipes; evenings resonate with the melodic tones of puthi and kirtan. The concept of 'Baro Mashee Tero Parbon' remains an integral part of daily life.

However, possessing such a culturally endowed heritage raises a crucial question: is

Lubna Marium, a renowned dancer, cultural activist, and artistic director of Shadhona, asserts, "Unfortunately, culture has become a primary site for struggle." Recognising the cultural construct of the state, Marium emphasises that any threat to culture hampers societal progress, national unity, and diversity. To address this, she has spearheaded the establishment of a comprehensive Intangible Cultural Heritage Inventory (ICH) through

Lubna's non-profit organisation, Shadhona, a centre for the advancement of South Asian culture, has an impressive decade-long history of safeguarding ICH practices.

Over the past 14 years, Lubna Marium, in collaboration with Unesco and the Bangladesh National Museum, has successfully created their intangible cultural heritage and practices exclusive to their communities.

Saymon Zakaria, a prominent Bangladeshi folk researcher and deputy director of the Department of Culture at the Bangla Academy, raises a pertinent question: "Is it enough?"

Zakaria emphasises the need to engage communities on a grassroots level, creating awareness and providing training to list their intangible cultural heritage in the inventory.

Lubna Marium underscores the intricate connection between cultural elements and their respective communities, stressing the importance of safeguarding practices that have held significance for thousands of years. She proposes a four-goal approach: documentation, celebration, transmission, and ensuring sustainability through eco-tourism.

Highlighting the importance of cultural heritage as a right, Lubna notes that Bangladesh is a signatory to the Unesco Convention a national inventory and a web application. for Safeguarding of Intangible Cultural

This platform allows individuals to document *Heritage (ICH) 2003*, signed in 2009. The convention encourages member states to empower communities by safeguarding ICH While this achievement is commendable, practices and aligning them with efforts to achieve the Sustainable Development Goals (SDGs) of 2030.

Despite Shadhona's Unesco accreditation and successful inventory creation, communitylevel engagement remains a challenge due to limited government efforts. Saymon Zakaria acknowledges the government's lack of experience in collaborating with civil society on such projects but emphasises the need for enthusiasm and participation.

"It is what has been happening for the last 14 years. We have the Unesco accreditation; we have the funds; the only thing we need more of is a little enthusiasm and participation from the government's end to go to the next step of safeguarding," said the cultural activist Lubna Marium.

"We are planning to divide the project into eight divisions this time. We will divide into teams, reach a community or two in each division, and train them in safeguarding ICH practices. Recently, we concluded our first community-based fair in the National Museum in the capital, and I am really optimistic that we will be able to achieve what we envisioned," said Lubna

As Shadhona and The National Museum mark the 20th anniversary of signing the Unesco Convention, a fair titled Oitijjho was held from November 18 to 19 at The National Museum premises in the capital. Lubna Marium remains optimistic about the future, stating, "It's a long way to go, but with adequate assistance from the government and communities, we will be able to safeguard our

ject covering 43.11 acres (some 130 Bighas) of land.

Private Under the Development Projects Act 2004 (amended in 2012), any housing projects covering more than 100 Bighas of land must be approved by the deputy commissioner.

When the petition was filed in 2012, Ashiyan had obtained all the required permissions from relevant government authorities, except for the DC's approval. That permission was under process then, according to court documents.

However, since the company did not get the final approval from the DC, two judges of the three-member High Court bench in a majority decision ruled on January 16, 2014, that Rajuk's permission was without lawful authority and that the project cannot

In and around the same area, many other private and public entities, including Rajuk, have already established their projects on hundreds of bighas of land, but the petitioners challenged only the Ashiyan project, court documents show.

When the HC asked why, the petitioners said they were concerned only about the Ashiyan and not any other in this case.

In a dissenting order, one HC judge dismissed the PIL, saying it was not "maintainable on point of maintainability."

Incidentally, the DC approved the Ashiyan project on January 16, 2014, the same day the HC pronounced the verdict.

Other developers had not yet applied for the DC's approval when Ashiyan got the No-Objection for its judgment.

Besides, unidentified arsonists set a truck on fire when it was parked near a market in the Seroil Colony area of Rajshahi city yesterday around 4:00am.

The cockpit of the truck was damaged in the fire, said Abu Sama, senior station officer of Rajshahi Fire Service and Civil Defense.

Informed, firefighters rushed to the spot and doused the blaze.

and killed? I still don't understand why buses are being torched and state properties are being destroyed."

At another event earlier, she said nothing can be achieved through arson violence, expressing her hope that the BNP-Jamaat alliance will come back to its senses to put an end to the anarchy.

Nothing can be achieved through burning people to death. This is wrong. Something can be gained by the power of the general people. Working for the people's welfare and staying by them are other requirements to achieve something," the PM said while speaking at a reception at the Army Multipurpose Complex.

At Senakunja, Hasina said the government is facing one challenge after another including Covid-19.

"And we will continue to engage with the government, opposition, civil society, other stakeholders to urge them to work together for the benefit of the Bangladeshi people to ensure that outcome."
