## Need land use masterplan for every upazila: PM

Prime Minister Sheikh Hasina yesterday directed the authorities concerned to work out a masterplan for every upazila over the use of land.

She gave the directive at a cabinet meeting at her office in the city's Tejgaon.

Cabinet Secretary Md Mahbub Hossain briefed reporters at the secretariat afterwards.

He said the Local Government Division has started working to formulate the plan, which will ensure rational use of land in the development process.

Once the master plan is formulated, it will bring discipline in using land, he added.

## 23 parties want to join polls so far

Twenty-three of the 44 registered political parties, mostly ruling alliance members, little-known and recently-formed ones, have shown interest to take part in the January 7 national election until Sunday. They have also written letters to the Election Commission in this regard.

They are sending letters to the EC letting it know who will be signing nomination papers of candidates on behalf of their parties and whether they want to take part in the polls under an alliance.

EC sources said Gonoforum also sent a letter to the latter mentioning its general secretary Mizanur Rahman will sign nomination papers of their party contestants. Mizanur said he did this in response to a prior letter sent to the EC by a Gonoforum leader. He identified himself as the party's executive chairman and claimed that he would be signing nomination papers for the party, said Mizanur.

"We then sent the letter so that EC does not allocate our symbol to anyone. It has no relation with joining the polls. Our central committee on November 25 decided that we will not take part in the election," he added.

EC sources said Awami League, Jatiya Party (Manju), Krishak Shramik Janata League, Gonotantri Party, Bangladesh National Awami Party (Bangladesh Nap), Workers Party of Bangladesh, Jatiya Party, Jatiya Samajtantrik Dal (Inu), Zaker Party, Bangladesh Tarikat Federation, National People's Party, Gono Front, Bangladesh Jatiya Party (Mukit), Islamic Front Bangladesh, Islami Oikya Jote, Bangladesh Islami Front, Bangladesh Nationalist Front, Bangladesh Congress, Bangladesh Samyabadi Dal, Bikolpodhara Bangladesh, Trinamool BNP, Bangladesh Nationalist Movement, and Bangladesh Supreme Party, have shown interest to take

## Blockade tomorrow, hartal a day after BNP calls for fresh programmes; arson continues

The BNP yesterday called for a nationwide blockade on Wednesday, and a hartal on Thursday.

Senior BNP joint secretary general Ruhul Kabir Rizvi made the announcement at a virtual press briefing yesterday evening after the party's seventh spell of 48-hour blockade ended amid arson attacks on public transport.

Yesterday, Dhaka witnessed a significant increase in vehicular movement, creating traffic congestions in some places. Meanwhile, at least nine vehicles were torched in seven districts during the blockade yesterday.

## 2018 VIOLENCE CASE 28 BNP leaders, activists indicted

A Dhaka court yesterday framed charges against 28 leaders and activists of BNP, including its Publicity Secretary Shahid Uddin Chowdhury Annie, in a 2018 violence case.

BNP joint secretary generals Khairul Kabir Khokon and Habibun Nabi Khan Sohel, Jubo Dal's former president Saiful Alam Nirob and BNP's Dhaka south city member secretary Rafiqul Alam Majnu are among the accused.

Annie, Khokon, Nirob and Majnu, now in jail, and 14 others, now on bail, pleaded not guilty and demanded justice after Dhaka metropolitan Magistrate Md Ali Haider read out the charges.

The court set December 6 for starting the trial. Among the accused, Sohel, BNP's volunteer affairs secretary Mir Sarafat Ali Safu, and eight others are on the run.

According to the case statement, a group of leaders and activists of BNP and its front organisations gathered in front of Hotel Bakshi Limited at Fakirapool in the capital's Paltan area around 1:45pm on February 10 of 2018 to protest the conviction of BNP Chairperson Khaleda Zia and her son Tarique Rahman in the Zia Orphanage Trust graft case.

They blasted crude bombs, vandalised vehicles, assaulted law enforcers and prevented them from

# Abandoned, locked for a month

The BNP office has been abandoned, heavily guarded and padlocked for a month now.

Fearing arrests, leaders and activists have mostly avoided the area in and around its Nayapaltan headquarters, and few of those who tried making their presence felt have been subsequently held and dealt with, alleged party leaders.

Even a month ago, a festive mood prevailed in the place with thousands of BNP activists chanting anti-government slogans to press their demand for the government's resignation and election under a non-partisan government.

The vibrant scene changed following the violence centring the party's October 28 rally. The rally was foiled within 1 hour and 38 minutes due to clashes between party activists and police.

Now, policemen in two groups guard the office round the clock.

Meanwhile, BNP is holding press conferences virtually from "undisclosed

locations", with party leaders alleging police are preventing them from entering their office.

## No way to defer polls after Jan 28 Say 3 ECs

Three election commissioners yesterday said they are bound by the constitution to hold the national election by January 28.

Even if the BNP or any other party applies for rescheduling the polls, the Election Commission has nothing to do without following the constitutional bindings.

"We want all parties to join the polls, but we never said we will defer the election date. If any party applies for rescheduling, we will sincerely try to consider it in the commission's meeting, and decide after discussion. We have bindings to conduct the oath [for the next elected candidates] by January 28," said election commissioner Md Ahsan Habib Khan.

"If it [rescheduling] is possible by the time frame, we must do it," he said at Khulna District Commissioner's office after conducting a view-exchange meeting with government officials in Khulna division.

"The ongoing political problems are not our headache. We have no pressure. If there is any pressure [from outside] on the government, that will be taken care of by the political persons," he added.

## DECLINE OF FEMALE WORKERS

# Harassment, lack of security key reasons: speakers

Gender-based violence, sexual harassment, and inadequate security at workplace are key reasons for the declining women workers' participation in the readymade garment sector, said speakers at a roundtable yesterday.

The roundtable titled "Investing to Prevent Violence Against Women", was organised by IndustriAll Bangladesh Council (IBC) at CIRDP, marking International Day for Elimination of Violence Against Women.

According to Bangladesh Gender Platform and Institute of Labour studies, sexual complaints committee exist at most factories. However, most of them are inactive.

"The rights of female workers need to be protected to building a strong future workforce. Ratification of ILO Convention 190 and proper implementation of HC's 2009 rule can bring positive change," said Md Anamul Hoque, director of labour department.

Kutubuddin Ahmed, secretary general of IBC, asserted the importance of mandating anti-harassment committees at all factories and raising awareness on the existing laws and policies among workers to combat this issue.

"Women must hold management level positions and actively participate in decision making to ensure safety at workplaces," said Monika Hatsel, deputy country director of Solidarity Center Bangladesh.

ANM Saifuddin, chairman of Standing Committee of ILO and labour affairs, BGMEA; Md Shakil Akter Chowdhury, chairman of WRC; and Bablu Rahman, country manager of Fair Wear Foundation, also spoke.

## 4 suffer burns in chemical drum blast

Four persons were burnt in a chemical drum explosion in Dhaka's Agargaon area yesterday morning.

The injured were rushed to National Institute of Burn and Plastic Surgery.

They are Rafiqul Islam, 19, Mozaffar Haque, 26, Saralal Das, 45, and Rafiqul Islam, 35. The accident took place as they were working in the basement of an under-construction building in Taltola around 9:30am.

Mozaffar said the chemical drum was taken to the basement for use as a water storage container. As workers started cutting the upper part of the drum with a grinding machine, an explosion took place, leading to the fire.

Four of the workers suffered burn injuries.

The injured suspected that gas had accumulated inside the drum and there was an explosion when it came into contact with the spark caused by the grinding machine.
