## Cyber Security Agency exists only in name

Five years gone by but govt yet to make it functional

In December 2018, when the Digital Security Agency was formed under the Digital Security Act, it was hoped that the cybersecurity of important government sites with critical citizen data such as the Election Commission's national identity database and the Office of the Registrar of Birth and Death would be robust.

Five years on, the government sites remain vulnerable to cyberattacks and data breaches, and the agency, which has since been renamed to the National Cyber Security Agency, cannot be blamed at all for the incidents and the compromised cybersecurity of the sites.

Documents pieced together by The Daily Star show the Digital Security Agency was not provided with the equipment or the manpower to perform this critical role, in what can be viewed as sheer apathy of the government in protecting citizens' data.

Deadline for nomination submission ends today

The deadline for submitting nomination forms to the election commission expires today, and as the BNP has not backtracked on its decision to boycott the election, it is not likely that the deadline will be extended.

Several political parties requested that the deadline be extended. The election commissioners on several occasions last week said the polls schedule could be revised if the BNP joined the polls.

When a reporter asked Chief Election Commissioner Kazi Habibul Awal yesterday if the last day of nomination submission would be deferred, the CEC did not give an answer.

Only the Awami League, its allies, little-known and recently-formed parties

## Raushan won't run for JS

Blames JP chief for ignoring tested leaders; party picks candidate for her seat

Leader of the opposition in parliament Raushan Ershad has announced she will not participate in the national election because tested leaders of her party have been undermined.

"I took part in the 2014 and 2018 national elections in the interests of the country and democracy. This time, I also welcomed the announcement of the polls schedule and took preparations for the election," the chief patron of Jatiya Party told a press briefing at her Gulshan home last night.

"Tested leaders of the party were not nominated due to non-cooperation from Jatiya Party Chairman GM Quader and Secretary General Mujibul Haque Chunu," she said.

JP sources say Rahgir Almahe Ershad, better known as Saad Ershad, may also not run for parliament as the deadline for collection and submission of nomination papers ends today.

However, Raushan's followers are waiting for Prime Minister Sheikh Hasina's "guidance" for resolving the crisis facing JP, Golam Moshi, political secretary to Raushan, told The Daily Star last night.

Raushan sought an appointment with the PM around a week ago to discuss JP's participation in the polls and other election-related issues, he said.

Over 20,000 opposition men arrested since Oct 28

Says pro-BNP lawyers' forum

Bangladesh Jatiyatabadi Ainjibi Forum, a body of pro-BNP lawyers, yesterday alleged that 20,326 opposition leaders and activists were arrested in more than 837 "fabricated and ghost cases" filed after October 28.

It demanded the immediate release of all the arrestees, including lawyers, and withdrawal of the cases.

At least 73,123 opposition activists were accused in the cases and over 8,249 were injured in attacks and police action, it said.

"Seventeen people, including a journalist, were killed and 636 were sentenced to different terms in 35 cases over the last three months."

## 37 BNP, Jamaat men jailed

342 BNP leaders, activists jailed in 3 weeks; Shahjahan gets bail, Abbas, Altaf, Alal denied

BNP and Jamaat leaders and activists continue to be on the receiving end of a conviction spree in cases filed years ago over political violence.

Over the last three weeks alone, 342 leaders and activists of the BNP have been sentenced to different terms in prison in cases filed between May 2013 and September 2018 in Dhaka.

The 342 excludes 37 leaders and activists of the BNP and Jamaat who were jailed yesterday in two cases lodged in December 2012 and September 2018 over political violence in the capital.

They have been convicted for illegally gathering on the streets, vandalising vehicles, and assaulting law enforcers and obstructing them in their duties.

In the case filed in December 2012, at least 15 BNP leaders and activists, including BNP executive committee member Habibur Rashid Habib, were jailed for 30 months in connection with violence in Sabujbagh area.

None of the 15 were present yesterday when Dhaka Metropolitan Magistrate Md Mainul Islam delivered the verdict.

According to the case statement, a group of BNP leaders and activists gathered in front of China Park under Khilgaon Flyover around 9:25am on December 9, 2012. They torched a double-decker, assaulted policemen, and obstructed them from performing their duties.

The bus driver filed the case with Sabujbagh Police
