Not concerned over US policy on workers' rights

Says Momen; foreign secy holds talks with US envoy DIPLOMATIC CORRESPONDENT

Foreign Minister AK Abdul Momen yesterday said there was nothing to worry about regarding the recentlylaunched US policy on workers' rights, as businesses in Bangladesh and the US are operated by the private sector.

"Exports won't stop just because of a government directive. The private sector often doesn't care about the government. They import products because they get them at cheap prices, good quality and timely delivery," he told journalists at the foreign ministry.

He was asked about a recent letter sent by the Bangladesh embassy in Washington to the commerce ministry in Bangladesh, regarding the possible measures, like trade penalties and visa restrictions, over labour rights issues.

Momen, however, said he has not

As per the memorandum rolled out by the US Secretary of State Antony Blinken on November 16, the US could impose sanctions, trade penalties and visa restrictions on the violators of labour rights under the new policy.

Yesterday, US Ambassador Peter Haas met Foreign Secretary Masud Bin Momen at the Padma state guest house.

Asked if the policy was discussed, the foreign minister said, "It was a routine meeting after the ambassador's return to Dhaka from leave, and that there is no reason to be worried about the US policy."

Meanwhile, the US embassy in

a Facebook post reiterated Haas held a routine meeting "to discuss the ongoing developments" in the bilateral relationship.

Asked if such measures would affect Bangladesh's RMG sector, whose major markets are in the US and EU, Momen said, "We don't want the progress [in trade relations] we have made to be affected. Though we are an LDC, we are a model country of export-led growth. It will be surely be a problem if the sector is affected."

Rohingya man shot dead in Ukhiya camp

A Rohingya youth was shot dead in a refugee camp in Ukhiya upazila of Cox's Bazar last morning.

The deceased was identified as Syed Alam, 24, a resident of Camp 4, said Shamim Hossain, officer in-charge Ukhiya Police Station.

A group of unidentified criminals broke into Alam's house and shot him when he was asleep around 6:00am, he said.

With critical injuries, he was rushed to a hospital in the camp, where doctors declared him dead.

The filing of a case is underway, he said.

10 injured in BCL factional clash

Around 10 people were allegedly injured in a clash between two factions of the Chhatra League in Nabiganj upazila of Habiganj yesterday.

According to locals, leaders and activists of AL and its associate bodies started to gather in the Natunbazar area in the morning on the occasion of the submission of nomination papers by Mushfiq Hossain Chowdhury, the AL nominated candidate for Habiganj-1.

During the programme, two factions of BCL-one led by Nazimuddaula Chowdhury, the convener of upazila BCL, and another by BCL leader Zahidul Islam Rubel-locked in clashes over establishing supremacy, said Masuk Ali, officer-in-

charge (OC) of Nabiganj Police Station.
Nazimuddaula and Zahidul blamed each other for the clash. Both of them claimed that at least five of their followers sustained injuries.

"Previous enmity led to the clash," OC Masuk said, adding that police brought the situation under control.

"GSP preferences can be removed if beneficiary countries fail to respect core human rights and labour rights," the EU

For instance, on 12 February 2020, the EC decided to withdraw part of the tariff preferences granted to Cambodia under the EU's Everything But Arms (EBA) trade arrangement due to serious and systematic violations of the human rights principles enshrined in the International Covenant on Civil and Political Rights.

For Bangladesh, the EU's key concerns on labour rights are related to: legal obstacles to the right to establish trade unions, elect representatives of trade unions and organise freely trade unions' activities; minimum membership requirements to form a trade union; and the absence of trade unions in the export processing zones

Another area of concern is anti-union discrimination, including violence, harassment, dismissal, and arrest of workers with insufficient investigations and prosecutions of cases.

The EU called for increasing the pace of implementing the commitments on labour rights included in the National Action Plan (NAP) and International Labour Organisation (ILO) roadmap. Following intense and productive

technical discussions with the EU, the labour ministry in September 2021 published the NAP on the labour sector for 2021-2026 with timelines for reforms.

While the Bangladesh Labour Rules and the EPZ Labour Rules, and subrules to the Labour Act/EPZ Labour Act have been revised and adopted in 2022, they still fall short of compliance with international labour standards.

The government committed to recruiting 942 additional posts for labour inspectors by the end of 2023 but almost 200 posts of labour inspectors, making up for about one-third of the existing posts, remain unfilled.

The government needs to follow up on its commitments to remediate factories ensuring the safety of workers, including by sending closure notices to factories where necessary as per the

It should step up its efforts to investigate and prosecute alleged cases of violence and harassment against workers and their representatives.

The EU also has key concerns on human rights related to freedom of expression, both online and offline; freedom of assembly and civil society space; and allegations of torture, illtreatment, extrajudicial killings and enforced disappearances.

The authorities should also fully implement the recommendations of the Human Rights Council's Universal Periodic Review, including the abolition of the death penalty, as well as the conclusions of UN treaty monitoring

"The full compliance with the GSP relevant international conventions should also be seen in the light of

Bangladesh from LDC status, which would imply moving from the EBA arrangement to standard GSP," the

report said. Under the standard GSP, the low and lower-middle-income countries can get partial or full removal of customs duties on two-thirds of tariff lines on their

shipments to the EU. It is important that Bangladesh can demonstrate that it meets its obligations under the GSP regulation, in particular the labour rights reforms under the NAP and the respect of international human rights standards, the report said.

Muhammad Yunus is the founder and chairman of Grameen Kalyan, a charitable organisation. The labour court can give an interpretation under the law, said the

bench of Justice Zafar Ahmed and Justice Khandaker Diliruzzaman. It delivered the verdict after hearing a writ petition filed by

The Labour Appellate Tribunal had declared the demand valid going beyond its jurisdiction as it is only empowered to give an interpretation if there is any dispute over any contract between the company and the workers under section-231 of the Labour Act-2006, he told The Daily

But no contract was signed between the Grameen Kalvan and its workers, and therefore, the judgement delivered by the tribunal on April 3 is beyond the law, Mamun said.

The demand of 106 retired workers is illegal as Grameen Kalvan is merely a charitable organisation and it is not involved in industrial activities, he

LAW VIOLATION CASE

In another case filed against Yunus and three top officials of Grameen Telecom over violation of the labour law, the defence made their arguments in a Dhaka court for the third consecutive day yesterday.

Sheikh Merina Sultana, chairman of the Third Labour Court of Dhaka, set December 6 for the next hearing in the case as the defence lawyers could not complete their arguments, Khaja Tanvir Ahmed, a lawyer for Yunus, told this newspaper.

Asked if there was pressure on him to join the election, he replied in the negative.

When the AL released a list of its 298 nominees on November 26, it said BH Harun, incumbent MP from Jhalakathi-1, was nominated for the constituency again. He had earlier submitted his nomination papers to the ARO office.

Omar told reporters yesterday that the BNP should have participated in the 2014 elections and boycotted the 2018 election. "The BNP should join the coming election."

Asked whether he considered running as an independent, he said, "When I have the symbol of an established party, why should I be an independent?" Explaining his decision to desert

the BNP, he said there was a rift between him and other BNP leaders, including the acting chairman Tarique Rahman. Except for Khaleda Zia, Mirza Fakhrul Islam Alamgir, Amir Khasru

Mahmud Chowdhury, Abdul Moyeen Khan, and Mirza Abbas, all BNP leaders are extortionists, he said. Bangabandhu's politics is better than Ziaur Rahman's, he said, "That's why I

joined the Awami League.' Reflecting on BNP's programmes, he said, "I still want Khaleda Zia's release. But it is not possible for any party to fully accept the terms and conditions that the BNP set for taking part in the election."

Omar, a recognised freedom fighter, participated in most of the elections since 1991 as a BNP leader. The party had not nominated him in 2008.
