They called me make-up man, I prefer makeup artist'

"Sadly, there is no makeup learning institute in Bangladesh, so I thought of checking in the neighbouring country. Then I discovered that. even in Kolkata, there were no makeup schools. Later, I went to Mumbai,"

"I have always wanted to work in a sector where I am the first, and it will give me an identity of my own," shared Atia Rahman, the make-up artist who drew attention for her breathtaking works, particularly in OTT platforms.

Nazia Haque Orsha's 'horrific burn,' created through prosthetic make-up in Sabrina, was done by Atia. She also crafted the look of Chanchal Chowdhury as the mystery man from 150 years ago in Karagar.

The artist took home the Blenders Choice-The Daily Star OTT & Digital Content award for Best Make-up Artist this year for her work in the web-series Karagar. She was also nominated for Sabrina.

Reminiscing her journey with The Daily Star, she shared that she was born and brought up in Dhaka. Her maternal grandparent's home is in Natore, and this is where the story of make-up artist Atia started.

"Whenever I visited Natore, I would not miss any chance to get the brides ready around me," she smiled, "At that time, the bride's make-up included a red bindi, alongside designing the forehead and cheeks with snow cream." Atia

always loved doing makeups on other people and discovered the passion which later became her profession. "The most challenging part of my job is that I am responsible for elevating the beauty and, at the same time, demoting it when needed."

It was back in 2012 when Atia began her journey in the industry basic make-up and later mastered her skill development in make-up from Mumbai, taking further training in prosthetics from there. "Sadly, there is no make-up learning institute

in Bangladesh, so I thought of checking in the

neighbouring country. Then I discovered that, even in Kolkata, there were no make-up schools. Later, I went to Mumbai," she added. This designation is dominated by men,

and usually, the term 'make-up man' is used to address them. Was this a challenge for Atia, and how did she break this?—"Not only in Bangladesh, but in India, this sector is somewhat dominated by men. The transition



from the idea of 'make-up man' to 'make-up artist' was not easy at all," said Atia. "To my knowledge, I am the first female makeup artist in the ad film industry in Bangladesh and the first one to do prosthetic make-up as well." Although she stepped into

the industry through ad films in 2013, the remarkable acclaim was to explore her inner talent. She learned brought to her with the Hoichoi web project 71 in 2020, directed by Tanim Noor. "I was doing very well in the ad film sector, and earning quite well; however, I felt it is time to gear up the level of challenge," shared the artist. She is the only make-up artist who has done the highest number of projects in OTT projects.

In her career, she has worked on projects such as Ladies and Gentlemen, Boli, Kaiser, Dui Diner Duniya, Over Trump, Myself Allen Swapan, Virus, Something Like an Autobiography, and upcoming work is Kachher manush Durey Thuiya, amongst

While discussing the crisis of designated institutes in Bangladesh, she shared that the journey for aspiring make-up artists is quite difficult, as there are no proper learning institutes. "For a female, the path is even tougher here; people are very judgmental, and it takes quite a long time to prove yourself. But I am glad that the mindset is changing, and while I am working here, I can witness the changes very well, especially the directors and the team I have worked with so far, played a great role in this journey."

Three people who Atia definitely wants to remember during her whole journey are her mother, who has always supported her and stood by her side. Another is Ashfika Rahman, her sister, and her best friend Szymon Pluta. "Without these people, I would not have come this far, and I dedicate all of my achievements to them," she concluded.

"I am writing to you on behalf of Médecins Sans Frontières (MSF) to implore you to do everything within your power to ensure an immediate and sustained ceasefire in the Gaza Strip. You must demand that the Israeli government stop the deadly attacks on Palestinian civilians and allow crucial humanitarian aid to enter Gaza." MSF International President Christos Christou said in an open letter to the UN Security Council yesterday.

Ahead of the release of the open letter, MSF South Asia Executive Director Dr Farhat Mantoo held a virtual interaction with journalists working in the South Asian region on Friday, where she described the appalling condition on the ground.

Israel launched its military campaign on Gaza on 7 October, in reaction to an unprecedented attack by Hamas inside Israel, killing at least 1,200 people. Many people were also taken hostage by Hamas fighters.

In its subsequent offensive in Gaza, Israel killed more than 15,000 people, half of whom are children, the letter says, citing Palestinian health authorities.

Israel also enforced a "complete siege" on Gaza, banning the entry of water, food, fuel and medical supplies for the 2.3 million people trapped in the enclave. "Northern Gaza is being erased

from the map. The health system organisation. We have lived through has collapsed. Tens of thousands of further carnage," the letter urge.

The World Health Organisation (WHO) has documented 181 attacks on healthcare facilities that have led to 22 fatalities and 59 injuries of health workers on duty. Medical staff, including those of MSF, are having to amputate limbs from children suffering from severe burns without anaesthesia or sterilised surgical tools.

At least four MSF staff members have been killed, and many have lost family members.

In Dhaka, three crude bombs went off in the Paltan area of Dhaka yesterday between 5:30pm and 6:00pm, said Salahuddin Mia, officerin-charge of Paltan Police Station.

There were no reports of injuries, the police officer added.

Meanwhile, at Nayapaltan, law enforcers were seen guarding the BNP party office, which has been padlocked since October 28.

According to the Fire Service and Civil Defence, five vehicles -- two trucks, two autorickshaws, and a bus were torched on the second day of the two-day blockade in Feni, Gazipur, and Dhaka till 6:00pm yesterday.

In Dhaka, arsonists set a bus of Tanjil Paribahan on fire at Zero Point in the capital's Gulistan at 2:23pm. Two firefighting units extinguished the fire around 2:40pm. There weren't any casualties, said fire officials.

In Gazipur, arsonists set fire to a hay-laden truck in Chandra on the Dhaka-Tangail highway. Two fire engines doused the fire. The straw was burned, but the truck itself remained unharmed, said fire officials.

In Feni, unidentified criminals set fire to two CNG-run autorickshaws on Shaheed Shahidullah Kaisar Sarak.

Police said some people exploded crude bombs to create panic among people and then set fire to the vehicles.

BNP announces Inflation fell slightly

Inflation in rural areas went down by 37 basis points to 9.62 percent. In urban areas, it fell by 56 basis points to 9.16 percent. The rate of inflation declined

lightly but the price level is still high, said Mustafizur Rahman, distinguished fellow of the Centre for Policy Dialogue. One reason behind the decline

could be the base effect and another reason could be the government's contractionary policy, he said.

"The prices of commodities that the $low\mbox{-}income\,group\,consume\,are\,still\,high.$ As a result, the slight decline in inflation will not give any respite to them."

As people's purchasing capacity reduced, so did the aggregated demand for commodities.

"Overall, people are not getting any relief from the high prices, Rahman added. The drop in food inflation could

be because crop production has been good and the government has also allowed the import of different essential food items, said Zahid Hussain, a former lead economist of the World Bank's Dhaka office.

"Due to some progress in the supply side, the price level of food items did not decline but the pace of price hike slowed down."

It is a mixed picture when it comes to non-food inflation, he added.

Climate finance

As tensions ran high over differing visions for the future of fossil fuels, COP28 President Sultan al-Jaber defended his role after the Guardian newspaper quoted him as questioning the science behind the need to "phase out" fossil fuels.

"I am quite surprised with the constant and repeated attempts to undermine the work of the COP28 the challenges posed by climate presidency," Al Jaber told a news change.

At least 30 nominations, including those of 19 independents, were scrapped in 16 seats of Chattogram, ROs Abul Bashar Md Fakhruzzaman and Tofael Islam.

In Patuakhali-1, RO Noor Qutubul Alam declared the candidature of JP co-chairman ABM Ruhul Amin Hawladar valid after he paid a tax of Tk 88.69 lakh.

Earlier, his candidature was put on hold as he did not pay the tax.
