Sangeeta Khan, an entrepreneur and women's rights activist, passed away yesterday at Farrer Hospital in Singapore, at the age of 62, after battling cancer.

She was the managing partner of "Divine Beauty Lounge" and partner at "Time Out", said a press release.

She was also the director of the Women's Chamber of Commerce & India Bangladesh Friendship Society, and a leader in several other women's empowerment organisations.

Wife of FR Khan, the managing director of Building Technology & Ideas Ltd (bti), Sangeeta Khan was the joint secretary at Gulshan Society. Her namaz-e-janaza will be held today at Gulshan Society Mosque following the Asr prayers.

'THREATENING TO BREAK BONES' AL candidate show-caused

Awami League candidate for Panchagarh-1 constituency Naimuzzaman Bhuiyan Mukta was issued a show cause notice yesterday for violating the electoral code of conduct.

Chairman of an electoral enquiry committee and joint district judge Marjia Khatun asked him to appear at her office by 12:30pm today.

According to the notice, Naimuzzaman's supporters organised a meeting at Panimachpukuri village where Ariful Islam Pallab, AL district organising secretary, threatened people to not support independent candidate and incumbent lawmaker Mojaharul Haque Proddhan. Otherwise, he would break their bones, he said.

showed an income of Tk 34.61 lakh. Ten years ago, it was Tk 26.36 lakh.

Inu's gold ornaments have remained constant over a decade, as he received 25 bhoari as a gift in 1974, and the same amount is mentioned in the latest affidavit.

But his wife's gold jewelry has increased, initially listing 12 bhoari during the 10th parliamentary election affidavit as a gift she received in 1974, but in the latest election affidavit it is 40 bhoari.

Inu has a jeep worth Tk 4 lakh, and there is a plot of 10 katha in Purbachal in his name whose price has been shown as Tk 16.10 lakh.

Apart from the increase in income, Khokon has seen a decrease in his liabilities, such as advance payments for renting houses, apartments, and shops, as the amount has fallen to Tk 9.85 crore from Tk 19.27 crore.

According to his latest affidavit, he has import, trading, and hotel businesses, and the majority of his earnings came from house, apartment, and shop rents and savings bonds.

husband's bank deposit is Tk 41,971.

Lipi possesses over 259 decimals of land valued at Tk 44.57 lakh, while her husband's agricultural land spans 1,214 decimals (more than 12 acres) with a value of Tk 4 lakh.

Additionally, Lipi owns 101.57 decimals of non-agricultural land valued at Tk 26.10 lakh whereas her husband holds 252 decimals of non-agricultural land worth Tk 1.15 lakh.

In the affidavit, Lipi acknowledged owning a five-storied building without specifying its value, stating it was a gift. She also mentioned her husband's ownership of a five-storied building and a semi-paka building received as gifts, with no mention of their prices.

corresponding amount was Tk 1,80,000 in 2018.

Apart from a bank loan of Tk 1.25 crore from Global Islami Bank, he has taken a loan of Tk 91 lakh without mortgage. He also took a loan of Tk 12 lakh from his brothers.

Despite the increase in debt, the affidavit did not show much change in moveable and immoveable temporary assets. The moveable assets have been shown as Tk 20,57,250 this time, which was shown as Tk 19,95,000 in 2018.

BNP a violator of human rights

Says info minister

BNP cannot talk about human rights as the party itself is a violator of human rights, said Information Minister Hasan Mahmud yesterday.

"BNP's founder had killed a number of people indiscriminately and established his party through bloodshed. BNP had killed innocent people through arson attacks in 2013, 2014 and 2015," he added.

The party is doing the same now, he said while speaking to reporters after unwrapping a book titled "Suhrawardy", marking the 60th death anniversary of Huseyn Shaheed Suhrawardy" at the secretariat.

Hasan, also Awami League joint general secretary, said BNP-Jamaat is carrying out arson attacks in the name of waging movement.

They have turned into a party of miscreants, he said.

About the alliance centering the upcoming polls, the minister said, "It was already announced that the 14-party alliance will take part in the polls jointly. We have always given importance to allies."

"We have enough strength, power and support to go to election alone. But we have taken the decision to contest the election from the alliance," he added.
