## West reaffirms support for defenders of human rights

**Missions in Dhaka** issue joint statement

UNB, Dhaka

A joint statement from diplomatic missions in Dhaka yesterday reconfirmed their support and solidarity with those who work to defend and advance human rights, fundamental freedoms, and equality

The missions highlighted the fundamental role democracy plays in protecting human rights and promoting development.

"Our commitment to the principles of the Universal Declaration of Human Rights is unwavering," according to the statement issued marking the International Human Rights Day being observed yesterday.

On the 75th anniversary of the Universal Declaration of Human Rights, the statement was signed by the embassies/high commissions of Australia, Canada, Denmark, France, Germany, Italy, the Netherlands, Norway, Spain, Sweden, Switzerland, the United Kingdom, the United States, and the delegation of the European Union.

### 16 Japanese polls observers show interest to EC

Sixteen Japanese observers have shown their interest to the Election Commission to observe the next national election, according to the Ministry of Foreign Affairs, reports

Besides, observers from India, Palestine, the Organization of Islamic Cooperation (OIC) and Arab League will observe the election, said MoFA Spokesperson Seheli Sabrin said at a weekly media briefing yesterday.

She said the four-member election expert mission from the European Union (EU) will continue to stay in Bangladesh till January 21, 2024.

She said the team had a meeting with Additional Foreign Secretary M Nazrul Islam on November 30. They met Chief Election Commissioner Kazi Habibul Awal on December 3, said the spokesperson.

The spokesperson said the government has been continuing its efforts to bring back Chowdhury Mueen Uddin and Ashrafuzzaman Khan, who are living in the United Kingdom and United States of America, evading death sentence awarded to them for killing the War of Liberation in 1971.

## RU student found dead at Shamsuzzoha Hall

A Rajshahi University student was found dead in his room at Shaheed Shamsuzzoha Hall on the university campus yesterday.

The deceased, Fuad Al Khatib, was a student

of the Department of Social Work for 2017-18 academic session and the son of Aminul Islam of Gaibandha, said hall provost Ekramul Islam.

"Fuad was taken to Rajshahi Medical College Hospital (RMCH) around 3:30pm, but doctors told us that he died three to four hours ago," added the

Fuad lived alone in a single room at the dormitory.

Ekramul Islam said a student of Fuad's neighbouring room saw him lying on his bed at

At 3:00pm, when the student saw Fuad still lying in the same way, he became suspicious and informed the hall provost.

Later, some fellow students, with the help of the hall administration, took Fuad to RMCH.

Resident students of the dormitory said Fuad returned to the hall from his village home around 3:00am and went to bed.

Meanwhile, the crime scene teams of the Criminal Investigation Department (CID) and Police Bureau of Investigation (PBI) inspected the scene and collected evidence, said Md Ruhul Amin, officer-in-charge of Motihar Police Station. Police are investigating the death, said the

police official. His body was sent to the RMCH morgue for

autopsy, the OC said.

However, police and doctors have yet to confirm the reasons behind the death.

## French frigate downs drones over Red Sea

A French frigate shot down two drones in the Red Sea that were heading towards it from the coast of Yemen, the French military said yesterday.

"The interception and destruction of these two identified threats" were carried out late Saturday by the frigate Languedoc, which operates in the Red Sea, the general staff said in a press release.

The interceptions happened at 2030 GMT and 2230 GMT, it added, and were 110 km (68 miles) from the Yemeni coast.

Yemen's Iran-backed Huthi rebels on Saturday threatened to attack any vessels heading to Israeli ports unless food and medicine were allowed into the besieged Gaza Strip.

The latest warning comes amid heightened tensions in the Red Sea and surrounding waters following a series of maritime attacks by Huthi rebels since the start of the Israel-Hamas war on October 7.

In a statement posted on social media, the Huthis said they "will prevent the passage of ships heading to the Zionist entity" if humanitarian aid is not allowed into Hamas-ruled Gaza.

The Huthis have recently attacked ships they claim have direct links to Israel, but their latest threat expands the scope of their targets.

An American destroyer shot down three drones last week while providing assistance to commercial ships in the Red Sea targeted by attacks from Yemen, according to Washington, which denounced "a direct threat" to maritime security

Since October 28, many BNP leaders and activists have landed in jail or have been on the run. But yesterday, BNP leaders and activists resurfaced to join the human-chain.

Right after the human-chain programme ended, BNP Senior Joint Secretary General Ruhul Kabir Rizvi called a countrywide 36hour blockade starting at 6:00am

In Habiganj, 30 people, including two reporters and six police officers, were injured in a clash between police and BNP activists in Sayestanagar around 12:30pm. Some shops and cars were also

vandalised during the clashes, according to locals. correspondent MyTV Injured Shuvo and Desh TV correspondent

Amir Hamza were sent to hospitals. Kamal Uddin Selim, joint convener of Habiganj BNP, said police attacked BNP men when they were about to

Hasan Mahmud's recent statement that they would give a befitting reply to the BNP, Selima said, "Who is he to say this? He became a minister through a voterless election.' She said the government was

tormenting people by deploying "muscle men and helmet-wearing forces".

"Nowhere else in the world are human rights violated like in Bangladesh. The government has shuttered numerous offices, including the BNP's central office," she said.

West African leaders met yesterday for talks with the region in deepening crisis, after four countries fell under military rule and with risks growing

from Sahel jihadist conflicts. After coups in Mali, Burkina Faso, Guinea and Niger since 2020, the Economic Community of West African States bloc also saw member states Sierra Leone and Guinea-Bissau claim

attempted coups in recent weeks. A French military withdrawal from the Sahel -- the region along the Sahara desert across Africa -- is increasing concerns over conflicts spreading south to Gulf of Guinea states Ghana, Togo, Benin and Ivory Coast.
