3 Siddique brothers

The three brothers — Latif Siddique, Kader Siddique and Murad Siddique — are contesting the upcoming national elections from Tangail-4, 8 and 5 respectively.

NO HOUSE IN LATIF'S NAME
Former minister and expelled Awami League leader Latif Siddique, mentioned no house in his name in an affidavit submitted to the Election Commission.

The four-time lawmaker from Tangail-4 (Kalihati) will be contesting the upcoming polls from the constituency as an independent.

Latif mentioned having no residential or commercial building, house or apartment in his name, while his wife owns a house that was built by relatives and well-wishers.

He possesses Tk 7 lakh in cash and Tk 3 lakh in bank deposits, and has no loans. He mentioned 1.87 acres of land in Kaultila of Gazipur worth Tk 65 lakh, and 39 decimals of fallow land at his ancestral home in Chhatihati worth Tk 32,000.

He gets a yearly allowance of Tk 2,62,000 as a freedom fighter. He owns an SUV worth Tk 65 lakh.

His wife Laila Siddique, a former lawmaker, owns 6-katha land in Dhaka and 7-decimal land

in Kalihati. She has 20 tolas of gold ornaments.

KADER HAS OVER TK 21.80CR LOAN
Krishak Sramik Janata League president Abdul Kader Siddique mentioned having over Tk 21.80 crore loan with a bank in his affidavit. The two-time lawmaker from Tangail-8 (Basail-Sakhipur) will contest the polls as a

been rescheduled on November 26.

He did not mention having any movable and immovable properties.

MURAD'S ANNUAL INCOME TK 49 LAKH
Murad Siddique, an independent candidate from Tangail-5 (Sadar) constituency, mentioned an annual income of Tk 49,38,903 as a contractor.

His immovable assets include 3

candidate from his party.

Kader mentioned an annual income of Tk 10 lakh in the affidavit from agriculture, bank interests and teaching, among others.

He mentioned a loan of Tk 21,80,31,000 in Agrani Bank's Tangail branch against Sonar Bangla Engineering Company (Pvt) Ltd as its chairman and managing director. The loan has

acres and 6 decimals of agricultural land and an ancestral house on 60-decimal land. He also has 72-decimal land in Tangail and a flat worth Tk 1.07 crore in Dhaka's Gulshan in his wife's name.

Murad now possesses Tk 34,70,100 in cash, Tk 30,73,810 as deposits in banks and financial institutions, and an SUV worth Tk 37.45 lakh.

Dengue claims four more lives

At least four dengue patients died, three from Dhaka, in the last 24 hours till yesterday morning.

With this, the total number of deaths rose to 1,665, of which 961 are from Dhaka, according to the DGHS.

With 413 new dengue cases, the total number of cases this year rose to 3,17,645.

A total of 2,047 dengue patients are still undergoing treatment.

Among the total cases, 3,13,933 dengue patients have already been released.

According to DGHS, a total of 62,382 patients were hospitalised last year, while the total number of deaths was 281.



Potato supply halves in 2 weeks

The supply of potato from cold storages in Rajshahi to other districts including Dhaka has fallen by half in past two weeks.

A total 36 cold storages in Rajshahi usually supply at least 1,000 tonnes of potato to other districts daily, the cold storage authorities say.

"Our stock of potatoes is almost empty. It is natural at this time that the supply will fall," said Md Ohidur Rashid, general manager of New Uttara Cold Storage Limited in Tokipur area under Paba upazila.

"It is necessary for us to empty the storages by December when the sowing season of potatoes starts and prepare the storages for storing again by end of February when potatoes will start to arrive," he added.

The district's stock of potatoes will last for at least one week, said Mozdar Hossain, deputy director of Department of Agricultural Extension in Rajshahi, adding that newly harvested potato will be available in the markets by that time.

3-year-old dies in road accident

A three-year-old boy died in a road accident in Juri upazila of Moulvibazar on Sunday.

The accident happened in North Jangirai area, said police.

Holding his father's hand, Talha was walking on a road when an auto-rickshaw hit him, said OC Mosharraf Hossain of Juri Police Station.

Talha died on the way to MAG Osmani Medical College Hospital in Sylhet.

Talha, son of Mostakin Hossain and Fatema Begum, was buried at a local graveyard yesterday.

Qamrul's annual income surges nearly 5 times

Incumbent Awami League lawmaker from Dhaka-2 constituency Qamrul Islam saw his annual income increase by nearly five times since 2018, according to his affidavit submitted to the EC.

His movable assets also increased by more than three times in last five years.

Qamrul is contesting the upcoming polls from the same constituency with AL ticket.

According to his affidavit, his annual income from his profession as lawyer and lawmaker rose from Tk 28.69 lakh in 2018 to Tk 1.32 crore this year.

Qamrul also mentioned movable assets worth Tk 4.69 crore this year, up from Tk 1.32 crore in 2018. His bank deposits increased from Tk 41.01 lakh to Tk 2.11 crore since 2018, but his cash in hand decreased to Tk 3.77 lakh from Tk 11.50 lakh.

His immovable assets rose from Tk 53.96 lakh in 2018 to Tk 60.01 lakh now. He mentioned a 10-katha land in Purbachal worth Tk 33.31 lakh in 2018, and Tk 39.48 lakh this year. Qamrul did not mention any income or assets in his wife's name.



Anisul's wealth increases 12-fold in 10 years

Anisul Islam Mahmud, incumbent MP from Chattogram-5 constituency, saw his wealth surge by 12 times since 2013, as per his affidavit submitted to the EC.

Anisul, also co-chairman of Jatiya Party and a former minister, identified himself as a textile and readymade garment producer and exporter in the affidavit and mentioned Tk 4.07 crore annual income this year, up from Tk 30 lakh in 2013.

His movable assets, including cash and bank deposits, also rose from Tk 12.29 crore to Tk 31.56 crore in 10 years.

His wife Parveen Mahmud's total wealth also tripled from Tk 4.40 crore to Tk 13.02 crore in this time.

Presently, his income sectors have increased, and now his prime income source is interest, which is around Tk 3.57 crore annually.

The couple owns several vehicles worth total Tk 3.27 crore.

Anisul owns an apartment worth Tk 2.83 crore, while his wife owns a house valued at Tk 34 lakh.
