

## Iran petrol stations hit by cyberattack

### Says oil minister

Iran's Oil Minister Javad Owji yesterday confirmed that ongoing nationwide disruption to petrol stations was caused by a cyberattack.

A hacking group that Iran accuses of having links to Israel claimed it carried out the attack that disrupted services at petrol stations across the country yesterday, Iranian state TV and Israeli media reported.

Owji had earlier told Iranian state TV that services had been disrupted at about 70 percent of Iran's petrol stations and that outside interference was a possible cause. He later said 1,650 petrol stations were operational. The ministry supervises 3,800 petrol stations.

Iran's state TV news said the Predatory Sparrow group had claimed it was behind the disruption. Israeli local media outlets also reported the claim.

## Covid cases rise in India's Kerala

### Karnataka makes masks mandatory for seniors

The Karnataka government yesterday asked those above 60-years of age, with comorbidities, and symptoms of cough, phlegm and fever to mandatorily wear face masks, in the wake detection of a case of Covid-19 sub-variant JN.1 in neighbouring Kerala state.

Increased tests among those with such symptoms and suspected cases, and heightened surveillance in border districts are among the measures that the officials have been instructed to take up, Health Minister Dinesh Gundu Rao told reporters here.

The situation is being continuously monitored, and there is no need for any restriction on movement and gathering of people as of now, he said, adding, the government would come out with an advisory.

Meanwhile, the Indian health ministry yesterday asked all states to maintain a heightened vigil in view of the upcoming festival season like Christmas and New Year.

"There is no need for anyone to worry. We had held a meeting day-before-yesterday and our technical advisory committee headed by Dr (K) Ravi had met yesterday and there was discussion between our officials and experts regarding the measures to be taken," Rao said.

The government would, based on the situation, decide what further measures need to be taken, he said. Along with stepping up surveillance at the border, instructions have been issued to increase testing and those with symptoms and suspicious cases are being asked to compulsorily undergo testing.

"In a couple of days we will get to know if the infections are increasing or not. As we increase Covid tests, if more positive cases are recorded, we will decide on further measures that need to be taken. There is no need for imposing any curbs or restrictions now itself," Rao said.

On whether there will be any restriction on Ayyappa pilgrims returning from Kerala, Rao said, as of now there are no curbs on restriction on movement of people and gathering.

"We will not stop any such thing now, because such a situation -- where people should not move or gather -- is not there," he said.

"For those above 60 years of age, those with comorbidities and respiratory issues, wearing masks is good. We will make it mandatory. Advisory will be issued by the government today."

## Israeli govt using 'starvation' tactic

### Says rights group on Gaza war

A global rights group yesterday accused Israel of committing a war crime by starving people in the Gaza Strip who continued to face relentless attacks in the war with Hamas.

Prime Minister Benjamin Netanyahu has vowed no let up in the bombardment and siege of the densely-populated coastal enclave, where buildings lie in ruins, hunger is rife, and health authorities say around 19,000 Palestinians have been killed.

Despite rising global pressure to protect civilians, who have nowhere to go, Israel is bent on eliminating the Hamas group, according to Israeli authorities.

US-based Human Right Watch (HRW) said Israeli forces were

deliberately blocking delivery of water, food and fuel, razing agricultural areas and depriving Gaza's 2.3 million people of objects indispensable for their survival.

"The Israeli government is using starvation of civilians as a method of warfare in the occupied Gaza Strip," it said in a report. "World leaders should be speaking out against this abhorrent war crime."

There was no immediate response to the HRW report from Israel, which has denied targeting civilians and says it is trying to facilitate aid to innocents while choking off supplies to thousands of Hamas fighters operating from tunnels.

The HRW report came after Pope Francis accused Israel of "terrorism", deploring the reported killing by the Israeli military of two Christian women in a church complex.



## Security tight as HK security trial for Jimmy Lai opens

A landmark national security trial for leading China critic Jimmy Lai opened in Hong Kong yesterday amid tight security, with the pro-democracy activist battling charges that he colluded with foreign forces, including the United States.

Queues formed outside the West Kowloon Law Court building the night before, with scores of police deployed. Hong Kong's security chief warned last week any attempts to disrupt proceedings would not be tolerated.

Lai, the founder of now-shuttered pro-democracy newspaper Apple Daily and one of the most prominent Hong Kong critics of China's Communist Party leadership, has faced a salvo of litigation under a China-imposed national security law that was enacted in response to a wave of pro-democracy protests in 2019.

The 76-year-old, sporting a crew cut and a grey jacket, appeared calm and thinner than in previous court appearances, smiling and waving to the packed court.

"When fundamental rights are engaged, any protection must be interpreted generously in favour of Mr Lai and narrowly for the prosecution," Lai's lawyer, Robert Pang, told the three high court judges.

## US ARMS SALES TO TAIWAN

## China vows to take countermeasures

China vowed yesterday to "take countermeasures" against companies involved in arms sales to Taiwan after the United States approved a \$300-million deal to beef up the self-ruled island's defences.

China views Taiwan as part of its territory and has pledged to seize it one day, while the US Congress requires the supply of weapons to the self-governing democracy for its defence.

The US State Department last week approved an arms package that both sides said would strengthen Taipei's joint battle command and control system.

Beijing hit back yesterday, saying it would take "resolute and strong measures to defend its national sovereignty and territorial integrity".

"We will take countermeasures against relevant enterprises involved in arms sales to Taiwan," foreign ministry spokesman Wang Wenbin said at a regular news briefing, without giving details.

The United States "should stop the dangerous trend of arming Taiwan, stop creating tensions in the Taiwan Strait,

and stop indulging and supporting the separatist forces of Taiwan independence in their quest for achieving independence by force," he added.

"China will eventually reunify, and indeed must reunify."

Beijing has ratcheted up the pressure on Taiwan since independence-leaning President Tsai Ing-wen took power there in 2016.

It regularly sends warplanes and vessels near the island, whose defence ministry recently also reported several sightings of balloons from the mainland.

Both Washington and Taipei have warned Beijing not to seek to influence presidential elections in Taiwan next month.

Meanwhile, two Chinese balloons flew across the sensitive median line separating Taiwan from China, the self-ruled island's Defence Ministry said yesterday, the second time it has reported a sighting this month.

Chinese balloons became a politically fraught topic in February when the United States shot down what it called a spy balloon, but that Beijing said was a civilian airship blown off course.
