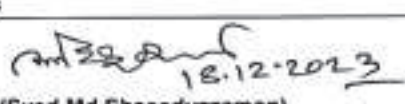

15	Brief Description of the Assignment	Ishurdi-Parbatipur corridor is one of the most important corridors of Bangladesh Railway having used as main line (Dual Gauge Single line section) of west zone of Bangladesh Railway connecting the major district of Bangladesh. There are different classes of 24 stations and 20 (Twenty) nos. of block stations in Ishurdi-Parbatipur section. The existing signalling system of the 20 (Twenty) block station are very old and worn out mechanical system. Therefore, the Government of People's Republic of Bangladesh decided to replace the existing signalling system of 20 stations by modern Computer Based Interlocking Signalling System (CBI) with the assistance of EXIM Bank of Korea through EDCF. The Government of the People's Republic of Bangladesh (GoB), through Bangladesh Railway (BR or the Employer) of Ministry of Railways, intends to engage consultants for Basic Design, Estimation & Design review and Construction Supervision works for introducing CBI Based Signaling & Interlocking system with provision of CTC system and related track works and other related works including defects liability period of the mentioned section.
