## EC can but doesn't verify claims properly

The Election Commission accepts the aspirants' wealth statements but never takes any initiative to properly verify the accounts.

This raises questions over the commission's sincerity in holding the candidates accountable and ensuring transparency, say campaigners

According to former NBR chairman Badiur Rahman, the EC could exercise its inherent powers and ask the National Board of Revenue (NBR) and Anti-Corruption Commission (ACC) to verify the wealth claims.

The Election Commission can ask the NBR to scrutinise the claims. If there are doubts, the Anti-Corruption Commission can be engaged too," he told The Daily Star.

As article 126 of the constitution makes it mandatory for all executive authorities to assist the EC, the institutions are bound to cooperate if the EC seeks their support.

On the other hand, the Representation of the People (amended) Act, 2023, does not make it mandatory for the EC to scrutinise the candidates' wealth statements.

Election Commissioner Anisur Rahman said it is not the EC's responsibility to scrutinise wealth statements.

As article 126 of the constitution makes it mandatory for all executive authorities to assist the EC, the institutions are bound to cooperate if the EC seeks their support.

If the NBR or ACC want, they can verify the claims about wealth, Anisur told The Daily Star recently.

However, Shusashoner Jonno Nagorik Secretary Badiul Alam Majumdar said even though the EC is not bound to verify wealth statements, it can and should do it for the sake of ensuring transparency.

The Election Commission's way of recording the candidates' wealth information is nothing but paperwork. We don't know if any candidate was ever quizzed about their wealth," he said.

The EC is supposed to upload the candidates' affidavits on its website immediately after receiving them, but it takes weeks to do it, he said. Former election commissioner Muhammed Sohul Hussain said the wealth details submitted by candidates must be scrutinised.

"If they could not do it on a short notice, there should be a system to do it after the election," he added.

Affidavits are a requirement for anyone participating in an election. Lying in the affidavits is punishable by up to three years in prison under the criminal law.

There is a provision in the Representation of the People Act, 2023, to cancel the candidacy of an aspirant for lying under oath.

## Won't tolerate any violence

Hasina warns AL leaders and activists, asks them to carry out electioneering peacefully

UNB, Dhaka

Awami League President Sheikh Hasina yesterday called for maintaining peace during campaigning for the January 7 national election.

"Don't interfere in another's rights. In case of any violence, even if members of my party get engaged in it, they won't be spared. I will take proper action

against them. Keep it in mind," she said.

Hasina, who is also the prime minister, issued the warning while addressing rallies in five districts Panchagarh, Lalmonirhat, Natore, Pabna and Khagrachhari -- through a virtual platform from the AL office in the capital's Tejgaon.

She said the people will cast their votes in the 12th parliamentary polls as it is their constitutional right.

"We want the people to exercise their votes freely. They can pick and vote for whoever they want."

## **POLLS VIOLENCE** US team to arrive today to analyse incidents DIPLOMATIC CORRESPONDENT A US team of experts is scheduled to arrive in Bangladesh today to record and assess incidents of electoral violence before, during, and after the January 7 national polls, a diplomatic source told The Daily Star.

Due to recent arson attacks on trains and buses, law enforcers have been deployed at metro stations across the city to assist the MRT police unit and amp up security ahead of the January 7 polls.

## 135 BNP-Jamaat men sentenced in a single day

They were sued between 2010 and 2018 over political violence

Another 135 leaders and activists of BNP-Jamaat and their front organisations were sentenced to different jail terms yesterday in five cases filed in 2010, 2013, and 2018 over political violence in the capital.

With this, at least 1,231 BNP-Jamaat activists have been jailed since November 7 this year in 69 cases lodged between November 2010 and December 2018 on charges of illegal gathering on the streets, rioting, damaging properties, arson attacks on vehicles, vandalism, and assaulting

police and obstructing them from discharging duties. In a case filed with Turag Police Station in September 2018, 93 BNP-Jamaat activists were sentenced to three years in prison by a Dhaka court yesterday. No convicts were present in the courtroom when Dhaka Metropolitan

Magistrate Md Sheikh Sadi delivered the verdict. During the trial, eight prosecution witnesses testified before the court. BNP's Turag unit President Atikur Rahman, General Secretary Md Mostofa, Organising Secretary Md Salam, Uttara Paschim unit President

Kudrat-e-Elahi Liton, and Jamaat's Turag unit General Secretary Md Muzammel are among the convicts. According to the case statement, on September 13, 2018, a group of leaders and activists of BNP-Jamaat illegally gathered near Dhour
