## **UKHIYA REFUGEE CAMPS** Two Rohingya men shot dead, another knifed to death

Three Rohingya men, including a community leader, were shot and stabbed to death in three refugee camps in Ukhiya upazila of Cox's Bazar yesterday.

Criminals from the Myanmarbased armed group Arakan Rohingyas Salvation Army (ARSA) carried out the killings, said Shamim Hossain, officer-in-charge (OC) of Ukhiya Police Station.

The deceased were identified as Md Abdullah, 23, a resident of Block C of Balukhali Camp 17, and Nadir Hossain, 39, head majhi (chief community leader) of Block F of Madhurchhara Camp 4, and Master Aiub, 35, a resident of Bhasanchar refugee camp in Noakhali.

> **Earlier on December** 6, three Rohingya men were killed and two others were injured by suspected Arsa criminals in Ukhiya upazila of Cox's Bazar.

Additional DIG Amir Zafar, commander of the 8 Armed Police Battalion, said Aiub was illegally staying at Ukhiya's Camp 15 for the last two months.

"Around 15-20 ARSA criminals attacked him at the camp and stabbed him to death," he added.

In the other two incidents, armed criminals called the victims out of their homes and shot them out on the road, leaving them dead.

"ARSA criminals committed these murders to establish dominance in the refugee camps," said OC Shamim.

On information, police recovered the bodies and sent them to Cox's Bazar Sadar Hospital morgue for post-mortem examinations.

Additional DIG Md commander of the 14 Armed Police Battalion, said additional forces have been deployed in the camp. "APBN is conducting drives to catch those involved in the incident."

Earlier on December 6, three Rohingya men were killed and two others were injured by suspected Arsa criminals in Ukhiya upazila of Cox's Bazar.

At least 11 Rohingyas have been killed at different camps in Ukhiya over the last 30 days.


We often speak of "going out, taking

### 4 killed in road crashes

At least four people were killed in road accidents in three districts between yesterday and Wednesday

In Gopalganj, a man was killed and three injured when a bus collided head-on with a car on the Dhaka-Khulna Highway in Ratail union of Kashiani upazila early today.

The deceased Mohammed Ullah, 38, of Manikganj's Sanbanda village, was driving the car, said Zillur Rahman, officer-in-charge of Kashiani Police Station.

The car also caught fire as the gas cylinder of the vehicle exploded after the accident. The injured were taken to Dhaka for better treatment, the OC added. In Dhaka, an Election Commission official died

when a lorry hit his motorbike on the Dhaka-Mymensingh Highway in the Airport area on Wednesday around 9:30pm, reports UNB. Md Al-Mamun, 48, was posted in Dhaka's Uttara

Election Office. He died undergoing treatment at Dhaka Medical College Hospital around 11:00pm.

In Joypurhat, two people were killed and two others were injured when a rickshaw van collided with an oil tanker on the Joypurhat-Bogura highway in Kalai upazila on Wednesday night.

Rafiqul Islam, 45, and Abdus Sobhan, 60, were both from Taraqul village in the district's Khetlal upazila.

The injured Munsur Ali, 32, and Suzaul Islam, 50, were sent to Bogura for better treatment, said Anwar Hossain, inspector (investigation) of Kalai

party violence, violence targeting women and other marginalised groups, and online harassment and threats, as well as the role of state institutions in addressing these types of violence, NDI said in a statement

"The assessment will seek to evaluate the drivers and implications election violence during the election cycle and provide constructive recommendations to reduce violence in future elections."

Following the conclusion of the electoral process, NDI and IRI will produce a technical assessment report on electoral violence.

#### Foreign ministry spokesperson Seheli Sabrin in a weekly briefing yesterday said nine countries have confirmed to observe the election.

Earlier, the NDI and IRI sent a joint pre-election assessment mission from October 8 to 11.

This bears significance given that the US announced a visa policy in May this year, saying that those undermining democracy in Bangladesh will be denied US visas. It has been calling for free, fair, and peaceful elections.

Meanwhile, foreign ministry spokesperson Seheli Sabrin in a weekly briefing yesterday said nine countries have confirmed to observe the election.

India, Sri Lanka, China, Russia, Uzbekistan, Japan, Mauritius, Georgia, and Palestine are sending observers, she said.

Nooh-Ul-Alam Lenin said if there is a provision for recording the candidates' wealth information, there should also be a provision for verifying it. "This might not be possible ahead of

January 7. But those concerned should consider amending the law in the next parliament. This will increase people's trust in wealth statements," he said. In Awami League's 2008 election manifesto, one of the pledges was

to "take effective steps against corruption". The manifesto reads, "Influential individuals have to disclose their

steps will be taken to prevent and erase corruption... to wipe out graft, unearned money, defaulted loans, extortion, tender manipulation, and muscle power."

In its 2014 election manifesto, the AL replaced the word Influential with citizens of all tiers". "Accountability of citizens from all

tiers regarding one's wealth, income will be ensured," it reads. In the 2018 manifesto, the AL did

not mention issues related to wealth. AL lawmaker Saber Hossain Chowdhury in 2010 placed a bill on the Code of Conduct for Members of

Parliament in the Jatiya Sangsad. The bill was aimed at ensuring that lawmakers uphold high moral standards in and outside the House.

The UK, India, Canada, South Africa, and different other countries have

codes of conduct for their MPs. However, no step was taken to pass

Shujan Secretary Badiul said if Saber's bill was passed, the MPs would have been required to disclose their wealth information every year.

Responding to a question regarding the allegations of unusual increase in the wealth of some AL nominees, the party's General Secretary Obaidul Quader on December 12 said, "If the Anti-Corruption Commission does not raise questions, and the aspirant is allowed to participate in the polls, then you cannot call them corrupt.

Rights activist and former adviser to a caretaker government Sultana Kamal said she is surprised at how the wealth of some candidates has increased.

"When I read the newspapers, I wonder if this is real... the wealth of some people has increased by 200 times, 300 times or 400 times," she said, adding the candidates' wealth information must be scrutinised.

They then vandalised vehicles, blasted crude bombs, threw brick chunks at police, obstructed them from carrying out duties, demanding the release of BNP Chairperson Khaleda Zia.

come undone, she said. Pointing at AL's rival candidates, Hasina said: "Yes, we opened the election [for its rival candidates]. There are candidates with the 'boat' symbol, independents and contestants from other parties in the race. Everyone should go to the people. The candidates who get votes would be

elected." She sought votes for her party's electoral symbol "boat" in the polls, saying that the people gained the independence of the country in 1971 by voting for this symbol.

People have attained economic emancipation and Bangladesh has gained the status of a developing nation by voting for the AL.

"If we want to continue the development trend, it is the Awami League who will have to ensure the welfare of the people by forming the government."

Hasina asked all the candidates and their supporters to run in the election

peacefully so that no one could raise any allegations regarding the polls and voters turn up in big numbers at the polling stations.

"There must be participation of the people and voters in the election. It doesn't matter which party joins or does not join the election. The BNP doesn't join the polls for one reason and there is no scope of vote-rigging

Since the BNP failed to rig the polls in 2008, it now wants to thwart and boycott the election, said Hasina, who is seeking to bring her party to power for the fourth consecutive term. "Run in the election in a fair

manner. All [candidates] should carry out campaigns freely and let the people vote for and pick the candidates of their choice. So, our democracy will be strengthened further. The people ousted BNP chief Khaleda Zia from power over vote-

rigging in 1996 and then she again

tried to steal votes in 2006 by enrolling

around 1.23 crore fake voters in the voter list. "Now it is very unfortunate that we have to hear the words [lessons] of democracy and fair votes from those who were driven out on two occasions over vote-rigging. Hasina said it was the AL who had

given back the voting rights to the "In this upcoming election, all of you will have to be careful so that no one can harm the people by resorting to terrorism and militancy. I would

like to urge all to be vigilant in this

regard." Talking about the recent violence including attacks on trains, Hasina said the BNP has again started unleashing arson and violence as in 2013 and 2014.

Without naming the BNP acting chairman Tarique Rahman, the PM said, "The person went to London giving the caretaker government a bond that he would no longer do politics, but now he is giving instructions to thwart the election from there."

"The country will have to be saved from their hands," Hasina said, adding that the BNP is a terrorist organisation.
