Explosions reported in shipping lane

Explosions in the Red Sea off the coast of Yemen were reported yesterday after sightings of unmanned aircraft and missiles in two separate incidents, a British maritime authority said.

Two unmanned aircraft were observed before two explosions occurred 5 nautical miles from a vessel located 50 nautical miles west of Hodeidah on Yemen's west coast, United Kingdom Maritime Trade Operations authority said in an advisory.

In an apparent separate incident, explosions were heard and missiles were seen 4 nautical miles from a vessel 60 nautical miles from Hodeidah, the authority said.

It was not immediately clear if the incidents involved the same vessel, which the authority did not identify. Cargo details or an indication where the vessel or vessels were sailing to or had sailed from were also not disclosed.

In both incidents the vessel and crew were reported to be safe.

Pakistan court restores ex-PM Khan's party polls symbol

A Pakistan court yesterday ruled that ex-prime minister İmran Khan's contest elections using its cricket bat lawyers winning



the jailed opposition leader a rare reprieve before polls due in February.

In a nation where the adult literacy rate is just 58 percent, election symbols are vital campaign tools for differentiating candidates on ballot papers.

But last week, the election commission stripped former cricket star Khan's Pakistan Tehreek-e-Insaf (PTI) party of the right to use its icon.

"The election commission's ruling against PTI, in which its election symbol, the cricket bat, was unjustly revoked through an illegal order, has been suspended," said PTI lawyer Syed Ali Zafar.

"It has been further directed that our symbol be reinstated," Zafar told reporters outside a High Court in the city of Peshawar, where PTI lodged an appeal.

Pakistan's election commission revoked PTI's right to use the symbol in polls set for February 8 over the party's failure to hold internal elections in accordance with its

But PTI said the decision was the latest legal hurdle erected in a campaign to prevent its 71-year-old figurehead from contesting re-election.

Hugely popular Khan was ousted last year after falling out with Pakistan's powerful military leaders, then waging an unprecedented campaign of defiance against them.

He is currently jailed and facing numerous graft cases and allegations he leaked classified state documents, a crime carrying a prison term of up to 14 years or even the death penalty.

After his arrest this year sparked unrest, PTI has been the subject of a widespread crackdown. PTI turned in nomination papers for Khan on Friday, but they may be challenged on the basis of the electoral commission having disqualified him from office over a graft conviction earlier this year.

Little space left for displaced Gazans to go

Says UN aid worker as Israel orders new evacuations in Gaza, vows to intensify war

Many Palestinians in the Gaza Strip have followed Israeli army evacuation orders and sought safety in designated areas only to find there is little space left in the densely populated enclave, a UN humanitarian team leader said.

Gemma Connell, deployed in Gaza for several weeks now, described what she called a "human chess board" in which thousands of people, displaced many times already, are on the run again and there is no guarantee a destination will be safe.

The United States, Israel's staunchest ally in its war against Hamas, has for weeks pressured Israel to take further steps to minimise civilian harm by identifying safe areas and clearing

humanitarian routes for people to escape. "People were heading up south with mattresses and all of their belongings in vans and in trucks and in cars in order to try and find somewhere safe." said Connell, who on Monday visited the Deir al-Balah neighborhood in

"I've spoken to many people. There's so little space left here in Rafah that people just don't know where they will go and it really feels like people being moved around a human deadliest nights in the 11-week-old war between chessboard because there's an evacuation Israel and Hamas, as Palestinian health order somewhere.

Al-Balah, where many of the wounded in Israeli airstrikes overnight were brought and where

"He was not in an area under an evacuation order, he was in an area that was supposed to be safe. There is no safe place in Gaza," she said, adding that new airstrikes took place when she was at the hospital and she witnessed wounded being brought in.

She shared the text of a notification from the Israeli military urging residents of at least half-a-dozen central Gazan neighbourhoods to evacuate on Friday.

It says the Israel Defence Forces will soon be operating in their neighbourhood and urges them to evacuate "temporarily and move to shelters" in Deir al-Balah.

The army spokesperson told Reuters: "The IDF will act against Hamas wherever it operates, with full commitment to international law, while distinguishing between terrorists and civilians, and taking all feasible precautions to minimize harm to civilians.'

US officials repeatedly said they expect Israel to scale down its operations to a more lowintensity phase of more targeted operations.

However, Israeli operations have intensified. Christmas Eve proved to be one of the officials in Gaza said Israeli airstrikes in central and southern Gaza killed more than 100

As Palestinians mourned their losses, Israeli Prime Minister Benjamin Netanyahu vowed to

keep up the fight against Hamas. Meanwhile, the UN Human Rights Office said yesterday it was "gravely concerned" by Israel's continued bombardment of the central Gaza Strip and urged Israeli forces to take all available measures to protect civilians.

It said all attacks had to adhere to international humanitarian law.

'11 bombs across Mumbai'

Threat email to top banks demands FM's resignation

The Reserve Bank of India yesterday received a threatening email claiming that would be planted in RBI office, HDFC Bank and ICICI Bank.

The email, demanding resignation Shaktikanta Das and Minister Finance Nirmala claimed bombs at 11 locations in Mumbai. The Police said that they visited all these places and did not find any explosives.

"RBI received a threatening email, in the email, it was said that bombs would be planted in RBI office, HDFC bank and ICICI bank and demanded the resignation of RBI governor Shaktikanta Das and Union finance minister Sitharaman," Mumbai Police said.

"Police went all these places and investigated but did not find anything... the probe is underway," it added.

The threats came from the sender claiming to be from 'Khilafat India'.

Blast near Israeli embassy in New Delhi

All staff unharmed

A blast occurred near the Israeli embassy in New Delhi yesterday evening and all staff were unharmed following the explosion, government authorities said. "We can confirm that around 5:20 there was a blast at close proximity to the embassy," Israeli Embassy spokesperson Guy Nir told Reuters. Israel's foreign ministry said all staff were unharmed following the blast and Israeli authorities were cooperating with their Indian counterparts to investigate the cause of the explosion. A team of the Delhi Police rushed to the spot but left after they searched the perimeter and found nothing suspicious. An eyewitness told the media that the blast sounded like a tireburst. According to him, the incident took place at around 5:00 pm. "This happened around 5 pm, I was on my duty and heard a huge sound. When I came out, I saw smoke coming from the top of a tree, that's all I saw...The police have taken my statement." he said. This comes amid a war between Israel and Hamas in Gaza in which thousands of Palestinians have been killed. In 2021, a low intensity blast outside the Israeli embassy in Delhi sent shockwaves across the world.

'I am your new Father Frost'

Putin foe Navalny describes harsh reality at 'Polar Wolf' Arctic prison

Jailed Putin foe Alexei Navalny yesterday confirmed his arrival at what he described as a snow-swept prison above the Arctic Circle and said he was in excellent spirits despite a tiring 20 day journey to get there. The Russian opposition politician posted an update on X via his lawyers after his allies lost touch with him for more than two weeks while he was in transit with no information about where he was being taken, prompting expressions of concern

from Western politicians. His spokeswoman said on

Monday that Navalny, 47, had been tracked down to the IK-3 penal colony north of the Arctic Circle located in Kharp in the Yamal-Nenets region about 1,900 km (1200 miles) northeast of Moscow. "I am your new Father Frost," Navalny wrote jokingly in his first post

from his new prison, a reference the harsh weather conditions there. Well, I now have a sheepskin coat, an ushanka hat (a fur hat with ear-covering flaps), and soon I will get valenki (traditional Russian winter footwear). "The 20 days of the transfer were quite tiring, but I'm still in an excellent mood, as Father Frost should be." Navalny's new home, known as "the Polar Wolf" colony, is considered to be one of the toughest prisons in Russia. Most prisoners there have been convicted of grave crimes. Winters are harsh - and temperatures are due to drop to around minus 28 Celsius there over the next week. About 60 km north of the Arctic Circle, the prison was founded in the 1960s as part of what was once the GULAG system of forced Soviet labour camps, according to the Moskovsky Komsomolets newspaper.

RUSSIA STRIKES Children among five killed in Syria

Russian air strikes on the last major rebel stronghold in Syria killed five civilians from the same family, including three children, rescuers and a war monitor said yesterday.

"On December 25 at 10:00 pm (0700 GMT) Russian warplanes targeted civilian houses" on the outskirts of the town of Armanaz, in Idlib province, said Abdel Halim Shehab of the White Helmets voluntary search-and-rescue group.

Members of the White Helmets pulled the victims from under the rubble of their house, he said.
