3 polls campaign offices set on fire in two districts Four arrested over preelection violence

Four people were arrested for their suspected involvement in incidents of pre-polls violence in Bogura, Netrakona, and Jhenidah between Sunday night and yesterday.

Meanwhile, three election camps were torched in Shariatpur and Cox's Bazar yesterday. However, no arrests were made over those incidents.

In Bogura-1, an Awami League leader allegedly assaulted a supporter of KSM Mostafizur Rahman, an independent candidate, in Sonatala upazila yesterday.

Police arrested Rafiqul Islam Matin, 39, general secretary of AL's Zorgacha union unit.

In Netrakona-1, a former union parishad chairman allegedly led an attack on supporters of independent candidate Jannatul Ferdous Ara Jhuma Talukder yesterday.

Police arrested Abdul Quddus, former chairman of Nazirpur union parishad and also a supporter of AL candidate Mustaque Ahmed Ruhi.

In Jhenidah-4, two supporters of AL candidate Anwarul Azim allegedly obstructed the election campaign of independent candidate Abdur Rashid Khokon on Sunday night.

After police arrested Dulu Mandal, 32, and Jamir Hossain, 40, Anwarul said his supporters didn't obstruct anyone's campaign.

In Shariatpur-2, two election camps were torched in Naria upazila yesterday.

Of the camps, one was of AL candidateAKM Enamul Haque Shamim in the Ahmadnagar Bazar area, and the other was of independent candidate Khaled Shawkat Ali in Tripolli village.

The camps blamed each other for the arson attack. Police are investigating the incidents, said Naria Police Station OC Mostafizur Rahman.

In Cox's Bazar-1, election camp of Kalyan Party Candidate Syed Md Ibrahim was torched in the Khojakhali area under Chakaria upazila yesterday.

Police are trying to trace the criminals, said Sheikh Mohammad Ali, OC of Chakaria Police Station.

BNP, Amnesty condemn sentencing of Prof Yunus

Foreign secy says judgment unlikely to harm Dhaka-Washington ties

Condemning the sentencing of Nobel laureate Prof Muhammad Yunus in a labour law violation case, the BNP yesterday said the entire nation was "ashamed of this judgment dictated by the Gono Bhaban".

Speaking at a virtual press briefing, BNP Senior Joint Secretary General Ruhul Kabir Rizvi said the Nobel laureate was subjected to vengeance of Prime Minister Sheikh Hasina.

He said Prof Yunus was sentenced to six months' jail in a so-called case over violation of the labour law.

The BNP leader said Prime Minister Sheikh Hasina's continued "venomous remarks" against Prof Yunus and different threats to him have proved that this for issues that belong to the civil and judgment has been delivered "out of administrative arena is a blatant abuse of

political vengeance".

"She also threatened to drop Dr Muhammad Yunus off the Padma Bridge into the river. Since then, it became clear that a deep-rooted conspiracy was on against Dr Muhammad Yunus."

He said though the Awami League leaders are plundering and siphoning off lakhs of crores of taka abroad, no action is taken against them. 'A BLATANT ABUSE

OF JUSTICE SYSTEM'

Amnesty International yesterday said the conviction of Prof Yunus is an "abuse of the justice system to settle political vendetta".

"Amnesty International believes that initiating criminal proceedings against Muhammad Yunus and his colleagues

labour laws and the justice system and a form of political retaliation for his work and dissent," read a statement published by the organisation on its X handle, formerly known as Twitter.

The conviction of Prof Yunus showcases the difficult situation of human rights in Bangladesh, where the authorities have eroded freedoms and bulldosed critics into submission, it said.

The unusual speed at which the trial was completed stands in stark contrast to the snail-paced progress in other labour rights-related court cases in Bangladesh, the human rights watchdog said.

Meanwhile, Foreign Secretary Masud Bin Momen has said the sentencing of Prof Yunus is unlikely to affect the US-Bangladesh relations.

DHAKA-COX'S BAZAR ROUTE New train to start operating Jan 10

A new non-stop intercity train "Parjatan Express" will start operating on the Dhaka-Cox's Bazar route starting January 10, Bangladesh Railway announced yesterday.

Departing from Dhaka at 6:15am and reaching Cox's Bazar at 3:00pm, the train will return from Cox's Bazar at 8:00pm, arriving in Dhaka at 4:30am.

Prime Minister Sheikh Hasina has approved the name, and the train will feature coaches newly imported from Korea.

Covering a distance of 346 kilometres, the fares for the new trains remain consistent with the existing rates.

The first train on the route, Cox's Bazar Express, started operating on December 1.

Ex-FCCI president, wife sued for illegal wealth

The Anti-Corruption Commission (ACC) yesterday sued Siddiqur Rahman, former president of the Faridpur Chamber of Commerce and Industry (FCCI), and his wife, Musreen Akhtar.

ACC's Deputy Director, Rezaul Karim, filed two separate cases in the Faridpur ACC office, accusing the couple of accumulating approximately Tk 13.90 crore illegally beyond their known sources of income.

According to the case statements, Siddiqur, 45, illegally acquired Tk 11.54 crore between the tax years 1996-97 and 2021-22, while Musreen, 45, is accused of having Tk 2.35 crore derived from her husband's illicit wealth between the tax years 2012-13 and 2021-22.

Barrister Defence counsel Abdullah-Al-Mamun told The Daily Star the judgement has been delivered in a hurried manner to blemish the image of Dr Yunus nationally and internationally.

"No offence has been committed in the eyes of the law, but they have been handed over the punishment," he said.

State counsel Khurshid Alam Khan said Yunus and the three other Grameen Telecom officials have been convicted as they appointed employees on contractual basis and did not provide them the due benefits. The company also did not regularise their job in accordance with the rules of the Labour Act, 2006.

According to the case documents, Department of Inspection for Factories and Establishments (DIFE) officials inspected the Grameen Telecom office in the capital's Mirpur on August 16, 2021, and found several violations of labour laws there.

Three days later, the department sent a letter to the Telecom, saying the company did not regularise the job of 67 of its employees although the company should have done so.

Besides, the company did not set up the employees' participation and welfare funds and did not pay the mandatory 5 percent of the company's dividends to the workers, the case statement said.

On September 9, 2021, Labour Inspector (General) SM Arifuzzaman filed the case against Yunus and the three others, rather than against the company.

During cross examination, DIFE Inspector Md Tarikul Islam, the first prosecution witness, admitted that although his complaint was against the company, he did not press charges against the company.

He added that he named only four in the case out of the 12 or 13 people listed in various positions in the company's Article of Memorandum.

Human rights activist and Supreme Court lawyer Barrister Sarah Hossain told reporters that how fast the trial proceedings have been finished and the judgement delivered is unprecedented.

Recording of depositions in the case ran till 8:00pm on one occasion, she said

The judge did not read out the whole judgement in the open court which is unusual, she added.

On Sunday, JP candidates Iqbal Hossain (Barishal-2 and 5), Kholilur Rahman (Borguna-1) and SM Niaz Uddin (Gazipur-1 and 5) announced that they would not run.

Iqbal, an adviser to the JP chairman, at a views-exchange meeting on Sunday said it seems the Election Commission is under the control of the government and the election is going to be a farcical one.

Kholilur, joint convener of Barguna district JP, told The Daily Star that some aspirants in their posters said they are supported by the Awami League while some others even printed photos of AL President Sheikh Hasina on their posters.

"If this needs to be done, then who are we?" he questioned.

Kholilur also said they were facing criticism over the party candidates' campaign strategy.

'People are not willing to cast votes for us. That's why I have decided to quit," he added.

In Brahmanbaria-1, JP candidate Shahanul Karim quit last week and extended his support to independent Syed AK Ekramuzzaman, an expelled leader of the BNP.

After a series of discussions between the top leaders of the AL and the JP, the ruling party left 26 seats for the main opposition party.

MP hopefuls were required to deposit Tk 20,000 as security money to the Election Commission.

Several JP candidates alleged that party Chairman Quader and Secretary General Chunnu were not looking after them as they were mostly busy in campaigning in their own constituencies.

"As the chairman and the secretary general of the party, GM Quader and Mujibul Haque Chunnu should look after all the party candidates. But they are not doing so. Rather, they are busy seeking votes for themselves," said Shafiqul Islam Sentu, a praesidium member of the JP.

Asked about the reasons for JP candidates withdrawing, Quader yesterday told reporters in Rangpur city that withdrawal can take place due to many reasons, including threat of reprisal, intimidation, or financial constraints.

but later downgraded. Russia and North Korea also issued

tsunami warnings for some areas.

Houses have been destroyed, fires have broken out and army personnel have been dispatched to help with rescue operations, government spokesperson Yoshimasa Hayashi told reporters, adding that authorities were still assessing the damage.

The extent of any injuries and deaths was unclear. Two people recovered from quake debris in Ishikawa prefecture were unresponsive, public broadcaster NHK reported.

More strong quakes in the area, where seismic activity has been simmering for more than three years, could occur over coming days,

JMA official Toshihiro Shimoyama said.

In comments to the press shortly after the quake struck, Prime Minister Fumio Kishida also warned residents to prepare for more disasters.

Images carried by local media showed a building collapsing in a plume of dust in the city of Suzu and a huge crack in a road in Wajima where panicked-looking parents clutched their children. There have been reports of at least 30 collapsed buildings in Wajima, a town of around 30,000 known for its lacquerware, and a major blaze has engulfed several buildings.

The quake also jolted buildings in the capital Tokyo, some 500 km from Wajima on the opposite coast.
