

25 hurt as Chhatra Dal, police clash in Habiganj

UNB, Habiganj

At least 25 people, including 10-12 policemen, were allegedly injured in a clash between police and leaders and activists of BNP student front Jatiyatabadi Chhatra Dal (JCD) in Shayestanagar area of Habiganj yesterday afternoon.

A police van was vandalised during

Habiganj Sadar Circle Additional Superintendent of Police Khalilur Rahman claimed 10-12 policemen were injured in the clash.

Locals said Chhatra Dal leaders and activists brought out a rally on the occasion of their founding anniversary. A clash broke out when police obstructed them in the city's Shayestanagar area.
District Chhatra Dal General

Secretary Zillur Rahman said as part of the central programme, Chhatra Dal brought out a peaceful rally.
"At least 15 leaders and activists

were injured in the police attack," he claimed.

NATIONAL POLLS Fire guts camps of AL, independent candidates

Two election camps in Shariatpur-2 constituency -- one belonging to an Awami League candidate and the other to an independent -- were set on fire by unidentified arsonists

However, activists of AKM Enamul Haque Shamim, the AL candidate, and Khaled Shawkat Ali, the independent candidate, blamed each other for the incidents.

Naria Police Station Officer-in-Charge Mostafizur Rahman said two separate fire incidents in the morning gutted the AL candidate's camp at Ahmad Nagar Bazar and the independent candidate's camp at Dhamaran Tripalli Bazar of Naria upazila.

Kalam Azad, mayor of Noria municipality and the chief coordinator of the election campaign of AL candidate, said supporters of Shawkat Ali set their camp on fire.

Contacted, Shawkat Ali, a presidium member of the Jubo League, alleged that supporters of Shamim, deputy minister of water resources, set fire to his camp.

Both candidates lodged verbal complaints with the police.

OC Mostafizur said legal action would be taken against those responsible after an investigation.

M'singh-Birisiri road turns a death trap

Sand-laden trucks causing accidents regularly

With hundreds of sandladen trucks plying daily, the Mymensingh-Birisiri road in Netrakona's Durgapur upazila has turned into a death trap with frequent road accidents.
At least 11 people were

killed and seven others injured in four separate accidents involving sand-laden trucks on the road between November 13 and December 25.

On December 25, a Dhakabound train and a sand-laden truck collided at Shambhuganj Railway Crossing, leaving four persons dead and two injured.

"Minor incidents are not reported, meaning we have details only of the more devastating ones," Durgapur OC Uttam Chandra

He blamed trucks used in sand lifting from Someswari River for the situation.

Kamal Pasha, former Durgapur municipality mayor,



said, "Some 4,000 trucks and 1,000 sand-laden lorries ply the road round the clock, causing damage to it while making it risky for other vehicles. Also, road tailbacks and congestion have become regular on the

the road adds to the menace, he added.

Netrakona, said, "The trucks are often overloaded, carrying 30-40 tonnes of sand each, ignoring the road's 16-tonne maximum capacity limit."

Teacher show caused for campaigning

The election inquiry committee on Sunday issued a show cause notice to a government primary school teacher for participating in electioneering for a candidate in Pabna.

Md Ashraful Alam, an assistant teacher of Handial Government Primary School in Chatmohar upazila, allegedly participated in an election campaign for independent candidate Abdul Hamid of Pabna-3 constituency and breached the electoral code of conduct, said the notice.

The committee's chairman and Pabna's Joint

District Judge, Md Tazul Islam, issued the notice. The teacher has been asked to submit his reply

by today. Awami League's Handial union unit president and secretary submitted a written complaint against the teacher. According to the electoral code of conduct, Ashraful, as a public servant, cannot join any election campaign for any candidate or political party.

PADMA, GANGES Combined water measurement begins

Like previous years, monitoring of water level at different points of the Ganges and Padma, the two major rivers of India and Bangladesh, kicked off yesterday morning under the Ganges Water Sharing Treaty 1996.

A two-member Indian team comprising of Ankit Dudeja, executive engineer of India's Central Water Commission, and Mukesh Kumar Sharma, assistant director of the commission, along with Bangladeshi experts started measuring water level at 4,500 feet upstream of the Hardinge Bridge point of the mighty Padma in the morning, said Md Rezaul Karim, executive engineer of regional hydrology department, Pabna.

A four-member Bangladesh team headed by Md Riadur Rahman, executive engineer of Joint River Commission, started measuring the flow of water in Ganges at the Farrakah point of India, he said.

"Under the Ganges water sharing treaty, the experts of the two countries monitor the flow of water in Ganges and Padma from January 1 to May 31 every year," said Rejaul Karim.

ILLEGAL WEALTH ACC sues RCC councillor, wife

Anti-Corruption Commission on Sunday night filed a case against Rajshahi City Corporation ward-17 councillor Shahadat Ali Shahu for illegally amassing wealth worth over Tk 7 crore.

The ACC also filed another case accusing Shahu's wife Nazma Ali for illegally amassing wealth worth over Tk 1 crore.

Aminul Islam, deputy director of ACC Rajshahi divisional office, lodged both the cases with the Coordinated District Office in Rajshahi.

Shahu gave his statement of accumulating both movable and immovable assets worth Tk 9,68,53,505 while his wife Nazma stated properties worth Tk 1,96,54,377.

But later, the ACC during investigation found Shahu owned properties worth Tk 11,93,15,505 while Nazma owned properties worth Tk 2,36,34,626. Here, Shahu concealed wealth amounting to Tk 2,24,62,000 and Nazma Tk 39,80,249.

If found guilty of the offences, the law has provisions for the highest three years of imprisonment and fines against the accused persons for each of the two offences.

Two killed in bike collision

Liakat Ali, 25, from Sejia village in Maheshpur; and Riad Hossain, 16, son of Hafizur Rahman from Shyamkur village died on the spot.

The injured were admitted to Maheshpur Upazila Health Complex, said Dattanagar Police Camp Sub-Inspector Ashish Das.
