IRREGULARITIES HC orders withdrawal of 4 polls officials

The High Court yesterday directed authorities to immediately the withdraw four polls officials of the Gaibandha-5 constituency, including a UNO, as they were allegedly involved in irregularities during a by-polls held on October 12, 2022.

The officials are Isahaq Ali, upazila nirbahi officer of Shaghata, who was an assistant returning officer of the by-polls; Md Sadequzzaman, upazila Shaghata agriculture officer; Md Ahsan Habib, secondary education officer of the upazila; and Belal Hossain, Phulchhari upazila primary education officer.

The Election Commission and the deputy commissioner of Gaibandha have been asked to comply with the order.

The bench of Justice Md Iqbal Kabir Lytton and Justice SM Maniruzzaman passed the order after Farjana Rabbi Bubli, an independent for Gaibandha-5 (Saghata-Phulchhari), filed a writ petition seeking necessary directives.

The four were involved in irregularities in the Gaibandha-5 by-polls, ABM Altaf Hossain, the petitioner's lawyer, told The Daily Star.

They supported Awami League nominee Mahmudul Hasan Ripan in that by-polls and they are doing the same now, he said, citing the petition.

Bubli submitted an application to the EC on January 1 to withdraw the four officials from all process for holding the January 7 election, but the EC did not take any action, Altaf said.

Yesterday, the HC also issued a rule asking the government and the EC to explain in four weeks why their inaction to take appropriate measures pursuant to the application should not be declared illegal, the lawyer added.

The EC stopped the by-election saying that the situation went "out of control" due to widespread electoral irregularities.

Shankar Kumar Majumder, superintendent of Bagerhat district jail, said Kamal fell sick in the jail around 10:30am vesterday. Following primary treatment at the jail, he was rushed to Bagerhat District Hospital where he died around 11:15 pm.

"My full solidarity with my dear friend, Nobel laureate and social justice champion Prof Muhammad Yunus. The baseless conviction handed against him in #Bangladesh for alleged labour violations is yet another example of the government's vendetta against its critics," she said in X (formerly Twitter) yesterday.

"The unjust conviction must be immediately reversed."

Irene Khan, a UN special rapporteur who was at the court on Monday, told AFP that the conviction was "a travesty of justice".

"A social activist and Nobel laureate who brought honour and pride to the country is being persecuted on frivolous grounds," she said.

Yunus and three other top officials of Grameen Telecom were sentenced to six months' imprisonment in a labour law violation case.

The four have denied the charges and were granted bail pending appeals.

The court is scheduled to hold the hearing of the cases from January 24 to 27.

"We are expecting the court will take cognisance of the charges and issue arrest warrants against them," he added.

About Tk 4,500 crore was siphoned out of the state-owned BASIC Bank between 2009 and 2013 when Bacchu chaired its board, according to a Bangladesh Bank investigation.

On July 14, 2014, the central bank forwarded the investigation report to the ACC with details on how the amount was embezzled from the bank through shell companies and dubious accounts.

September Between and November 2015, the ACC filed 59

His name was included when the ACC submitted charge sheets in 58 cases with the trial court this year.

Between August and October, Bacchu sought anticipatory bail in all the cases. He maintains that he is innocent and was implicated without any material evidence.

Syed Mahsib Hossain, a filing lawyer for Bacchu, said his client has instructed not to move the bail petitions at this moment as he is indisposed to appear before the court.

In a statement, signed by its Chairman Professor Dr Mohammad Shahidullah, published early yesterday, it also suggested keeping testing and treatment facilities ready for emergencies.

Besides, the committee also recommended screening travelers coming from abroad.

The NTAC also advised high-risk individuals, such as those with other health issues, to take the fourth dose of the Covid vaccines.

They said the highest 131 violations were reported in Dhaka region followed by Rajshahi and Cumilla regions with 103 and 81 incidents

Besides, 64 incidents took place in Mymensingh region, 59 in Khulna, 40 in Rangpur, 38 in Chattogram, 28 in Barishal, 24 in Faridpur, and 21 in Sylhet, according to the EC data.

Talking about the violation, Election Commissioner Anisur Rahman said, "Several incidents of violations [of the code of conduct] have been reported this time, but the number is less than those of the previous polls."

In many cases, clashes are taking place over previous enmities, he said. The electoral enquiry committees were formed for each of the 300

constituencies in line with the Representation of the People Order, 1972. The law stipulates that after conducting an enquiry, the committee shall inform the EC about its findings and may make recommendations.

The commission may issue necessary orders or instructions to the person or registered political party concerned to implement the recommendation.

The EC may fine the person or the registered political party concerned Tk 20,000 to Tk 1 lakh and also cancel the candidature of an aspirant.

In line with the recommendation from an enquiry committee, the EC scrapped the candidacy of independent Md Habibur Rahman Paban (Lakshmipur-1), also a presidium member of Jubo League, for violating the code of conduct.

The commission also fined the AL aspirant for Cumilla-6, AKM Bahauddin Bahar, Tk 1 lakh, and Barguna-1 AL nominee Dhirendra Debnath Shambhu Tk 50,000 for breaching the code of conduct.

The EC decided to sue AL's picks Mostafizur Rahman (Chattogram-16) and Abdul Hyee (Jhenaidah-1) for violating the electoral rules.

The campaign for the January 7 polls, which began on December 18, will end at 8:00am tomorrow.
