5 candidates term polls 'rigged'

Four candidates, including an incumbent lawmaker, at a press conference yesterday demanded re-election in Sylhet-2, alleging that the ruling party rigged the January 7

Meanwhile, another candidate from Sylhet-3, in a separate press conference, described how the ruling party supporters staged irregularities in the election.

The Sylhet-2 candidates are incumbent lawmaker and Gono Forum candidate Mokabbir Khan, former lawmaker and Jatiyo Party candidate Yahya Chowdhury, Trinamool BNP candidate Abdur Rab Mallik and independent candidate Muhibur Rahman.

On the day of the election, all four of them boycotted it by 2:00pm.

In a press conference held at a restaurant in the city, the candidates demanded re-election and said that they would be urging the Supreme Court to fight against the election results legally.

Yahya Chowdhury said, "I was barred from entering a centre for two hours, while Awami League men stuffed the ballots. I did not get any support from the election officials and administration. After that, I boycotted the election and did not cast my vote.'

Muhibur Rahman said, "The election was rigged and a farce. We were betrayed as we trusted the prime minister and the chief election commissioner. From forcing our agents out of the polling station to ballot stuffing by the ruling party men, everything took place in the polls."

Mokabbir Khan echoed the same. Abdur Rab Mallik said, "All four of us spent a long time in foreign countries, where we practised clean politics. But the reality here was different."

In Sunday's election, AL candidate from Sylhet-2 Shafiqur Rahman Chowdhury won the polls with 78,388 votes, while his nearest rival Muhibur Rahman got 16,611 votes. The JP candidate secured 6,874 votes, the Gono Forum candidate 1,922 votes and the Trinamool BNP candidate 944 votes.

Dr Ihteshamul Huq Chowdhury, an AL-backed independent candidate for Sylhet-3, at a separate press conference, said, "My agents were forced to leave from 47 centres, where ruling party men stuffed the ballots. They also beat up an agent at Boaljur School centre and confined the injured agent for hours."

He also alleged that the ruling party lawmaker forcibly delayed vote casting till 9:30am at Kamalbazar Jalalia School centre, to cast his own vote first.

All BNP can do is wait for next five years Says Quader

BNP has no other choice but to wait another five vears till the next



elections, Awami League General Secretary Obaidul Quader said yesterday.

"BNP-Jamaat has failed this time too. The people have countered all their conspiracies through ballots. After repeatedly boycotting the elections, BNP has nothing to do except wait for the next five years," said Quader while addressing a post-election press conference at the AL Dhaka district office in the capital's Tejgaon yesterday.

Quader, road the transport and bridges minister, dismissed allegations made by BNP leader Moyeen Khan as "baseless and fabricated".

"All their complaints are devoid of reality. BNP leader Moyeen Khan appeared before the media with a series of lies. Such lies are responsible for their tragic consequences," he said.

Calling the elections a milestone in Bangladesh's democratic journey, Quader said, "Foreign journalists, observers, various institutions, both domestic and international media, have reviewed the election and expressed satisfaction. This election will fortify Bangladesh's global image.'

62 more get hospitalised with dengue

At least 62 dengue patients were hospitalised in the last 24 hours till yesterday morning.

The total number of cases this year rose to 440, according to the Directorate General of Health Services.

So far, three persons have died of dengue this year.

A total of 362 dengue patients are still undergoing treatment at different hospitals across the country while 772 dengue patients have already been released.

Last year, the country witnessed 1,705 denguerelated deaths and 321,179



stores in remote upazilas," said a CMCH staffer.

"However, the other drugs they steal from the hospital can easily be sold in city pharmacies," he

At least 20 people, including 10 CMCH staffers, were caught redhanded with stolen medicines in the past two years and were sued in cases filed with the police, while government medicines worth Tk 6 lakh were seized from them, said Nurul Alam, in-charge of CMCH Police Camp.

However, stealing of medicines could not be stopped at the hospital, he said.

On December 5 last year, police at CMCH arrested a hospital staffer with government

medicines worth Tk 14,000 from the hospital pharmacy.

information from him, police recovered government medicines worth Tk 8,000 from his house adjacent to the hospital and also arrested two more CMCH staffers in this connection, he said

The arrestees are Azizur Rahman, 50, an office assistant at CMCH ticket counter; Daud Ishak, 52, assistant pharmacist at CMCH; and Simon Hossain, 46, an electrician at CMCH.

Contacted, Nurul Gani, senior vice president of Bangladesh and Chemist Druggist Association in Chattogram district, said the hospital authorities should take strict

action against those staffers. Contacted, CMCH Director

Brig Gen Shamim Ahsan said they have taken steps in this regard. "When a staff member is detained with stolen medicines, we suspend and file a case against them," he said.

"Our inquiry found that they sell the stolen medicine to remote upazilas and Hazari Goli, the wholesale hub of medicines in the port city, at a cheaper price."

"We have tightened the security in every ward, with Ansar men deployed at the entrances of the wards and the hospital," he

Contacted, Protik Dutta, executive magistrate Chattogram, said they are drives conducting regular against the illegal sale of stolen government medicines.

The journey took a devastating turn after a truck rammed their auto-rickshaw in the Autpara area of Betila Mitra Union on the Hemayetpur-Singair-Manikganj road around 10:00am.

Jasim and Yasin lost their lives in the accident,

Josna and Hamza are currently in a critical condition at Manikganj Colonel Malek Medical College Hospital.

lder sister Labani Akhter, her husband Mi Mia and nephew Yasin [Labani's son] lived with my parents. He [Jasim] was the lone earning member of the family."

"Labani is devastated since learning about the incident, having lost her baby boy and father simultaneously. Meanwhile, our mother and youngest sister are fighting for their lives. We don't have money for their treatment," said Meem.

"We did not have much... but we were happy. All we had was each other, now we lost that too."

Manikganj Sadar Police Station's Officer-in-Charge Md Habil Hossain said they are looking for the truck driver and his assistant.
