RMG workers block highway for pay hike

Hundreds of garment workers protested in Konabari and Targach areas of Gazipur, demanding adjustment in salaries under the new wage board.

Traffic movement on Dhakaremained highway Tangail suspended as around 700 workers of Meigo Bangladesh (Bay-Economic Zone) Ltd blocked the highway around 7:45am to realise their sixpoint demand.

According to police and factory sources, the workers took position beside the Dhaka-Tangail highway around 7:30am. Later, they blocked the road around 7:45am.

Referring to their six-point demand, the workers said according to the new wage structure announced by the government, they have to be included in Grade 1 to 4.

However, most of the workers have been included under Grade 3 and 4 to reduce the authorities' costs, they said.

Meanwhile, over 100 workers of Moonlight Garments Ltd and Ehsan Garments workers started demonstration in Targach area around 8:00am.

Contacted, Sub-inspector Sharmin, a duty officer of Gacha Police Station, said they do not know about the demonstration but will look into the matter.

Labour leader Azizul Islam said over 100 workers of the two factories have been demonstrating.

JP only secured victory in 11 seats, marking the party's poorest performance since 1991, with 90 percent of its candidates, including several prominent ones, losing their deposit.

AL total vote dips

This time, JP won only 11 seats despite fielding 264 candidates, while ruling AL withdrew its candidates from 26 seats in support of JP.

A staggering 236 JP candidates even lost their deposits, as they bagged even less than one-eighth of the total votes casted in their respective constituencies.

Former election commissioner Brig Gen (retd) Sakhawat Hussain said this proves that JP is losing its popularity. The party got 5.38 percent and 7

percent votes in 2018 and 2014 elections respectively. În 2008, 2001 and 1996 June and 1991 elections held under caretaker government, JP bagged 7.04, 7.25, 16.40

and 11.92 percent votes respectively. JP is on the verge of extinction as a political entity, and is now depending on others to join polls and win it, said Badiul

JP chairman GM Quader, however, said his party's popularity is not receding and attributed the polls debacle to "ballot stuffing and widespread irregularities".
