Dhaka grapples with 'unhealthy' air amid cold

As a mild cold wave is sweeping across the country, Dhaka's air quality has been marked "unhealthy".

With an air quality index (AQI) score of 175 at 9:29am yesterday, Dhaka ranked 5th on the list of cities worldwide with the worst air quality.

India's Delhi and Kolkata and Pakistan's Karachi and Lahore occupied the first four spots, with AQI scores of 243, 212, 212 and 195 respectively.

An AQI between 151 and 200 is considered "unhealthy" while between 201-300 is "very unhealthy", and 301-400 is "hazardous", posing severe health risks to residents.

The AQI, an index for reporting daily air quality, informs people how clean or polluted the air of a certain city is and what associated health effects might be a concern for them.

The AQI in Bangladesh is based on five pollutants: particulate matter (PM10 and PM2.5), NO2, CO, SO2, and ozone.

Dhaka has long been grappling with air pollution issues. Its air quality usually turns unhealthy in winter and improves during the monsoon.

As per World Health Organization, air pollution kills an estimated seven million people worldwide every year, mainly due to increased mortality from stroke, heart disease, chronic obstructive pulmonary disease, lung cancer, and acute respiratory infections.

Dense fog damages boro seedbeds

Dense fog amid winter has caused considerable damage to boro paddy seedbeds in different areas across Jashore region.

Seedlings were seen fading and turning yellow-reddish in colour, and eventually dying. In some places, seedlings did not germinate in the seed beds.

Farmers were seen desperately trying to protect the seedlings by covering the seedbeds with polythene, sprinkling ash, and spraying medicine in some places.

They expressed concern that the seedlings would be completely damaged before those could be

planted to crop fields.

The sun has not been visible amid the severe cold since Friday. The average temperature in Jashore was 10.8 degrees Celsius from Sunday, according to the meteorological office in Jashore.

"Due to dense fog in the last few days, my paddy seedlings are turning yellow. I have been trying to protect those with polythene sheets. If the situation persists, the seedlings will be damaged in the seed beds," said A Rahman, a farmer in Jashore Sadar upazila.

"If the fog remains intense and the temperature falls below 10 degrees in winter, the paddy seedlings are affected. The

temperature in Jashore is above 10 degrees at the moment," said Sushant Kumar Tarafdar, deputy director of Department of Agricultural Extension in Jashore.

In order to protect the seeds planted using conventional method, the DAE official recommended to drain water from the fields during daytime and cover seed beds with polythene until the sun rises, while irrigating the lands at night.

The DAE has a target of cultivating boro paddy on 1,60,500 hectares of land in Jashore this year, including Ufshi variety on 1,30,000 hectares and hybrid varieties on 30,500 hectares.

Farmers find it tough to cope with cold spell

Dense fog and low temperatures are disrupting agricultural work across the northern districts of Kurigram and Lalmonirhat as a cold wave persists in the region.

The shivering cold is making it extremely difficult for farmers and agricultural workers to continue working in the fields for a long time.

However, for the sake of livelihood, many are being compelled to work, defying the cold.

The situation is particularly worse in the char (shoal) areas along the Brahmaputra, Teesta, Dharla, Dudhkumar, and Gangadhar rivers.

The minimum daytime temperature in the region has been fluctuating between 11 and 12 degrees Celsius for the past few days, said Subal Chandra Sarkar, in-charge of Rajarhat Agricultural Meteorological Observatory in Kurigram.

"The chilling cold is disrupting our work. But we have to grow our crops

anyway, so we are working amid the cold and fog. After working in the field for a while, we light up straws to build a fire and get some warmth before starting work again," said Dhiren Chandra Barman, 60, of Bishbari village under Lalmonirhat Sadar upazila.

"Due to the cold, I am unable to work in the farmland. At the same time, agricultural workers are also not much available, as many are reluctant to work in this harsh weather," said Nazir Hossain, 65, a farmer in Shimulbari village under Phulbari upazila of Kurigram.

"Earlier, we would work on daily wages. But now, due to the cold weather, we are working on contract," said Altaf Hossain, 50, a farm labourer in the same village.

Hamidur Rahman, deputy director of Department of Agricultural Extension in Lalmonirhat, expressed concern that if the cold wave continues longer, it might cause significant damage to the crops.

Submit probe findings by February 8

HC asks ACC on Murshedy's Gulshan house

The High Court yesterday ordered the Anti-Corruption Commission (ACC) to submit the findings of the probe into the issues regarding Awami League lawmaker Abdus Salam Murshedy's Gulshan house before this court by February 8.

The ACC has been asked to submit the updates, including the documents found by the commission's inquiry officials, through an affidavit to the HC.

The bench of Justice Md Nazrul Islam Talukder and Justice Kazi Ebadoth Hossain passed the order during the hearing of a petition filed in 2022 by Supreme Court lawyer Barrister Syed Sayedul Haque Suman.

After the HC passed the order yesterday, Barrister Suman told reporters at the SC that the ACC lawyers say that the commission does not bow to anyone.

"But I think the Anti-Corruption Commission is silent about Abdus Salam Murshedy," he said.

2 shot dead over 'gold smuggling dispute'

Two persons were shot to death in a clash allegedly between two gangs of gold smuggling syndicate in Maheshpur upazila of Jhenaidah yesterday.

The deceased are Shamim Hossain, 28, and Montu Mia, 35, of Baghadanga-Kalyanpara under Nepa union.

Quoting locals, Mahabubur Rahman, OC of Maheshpur Police Station, said there had been an altercation between known gold smugglers Shamim and Tariqul over a transaction two months ago.

Following the issue, Shamim along with three others, including Montu, attacked Tariqul's house in the afternoon.

At that time, Tariqul opened fire at the attackers, leaving Shamim dead on the spot and Montu injured, the official said, adding the arms used by Tariqul was not licensed.

Locals rescued Montu and took him to nearby Chuadanga's Jibannagar Upazila Health Complex where doctors declared him dead.

The OC said Shamim, Tariqul and Montu are accused in several cases.

No one has been arrested yet, he added.
