## **8TH FIVE-YEAR PLAN** Health, education got way less than outlined

Shows planning commission's study

The government has made lesser allocations for the education and health sectors than what is projected in the 8th five-year plan, raising questions about its commitment to these critical areas.

The 8th five-year plan is being implemented from fiscal 2020-21 to fiscal 2024-25.

Several sectors including health, education, agriculture and social protection got less allocation in the last four fiscal years than what is projected in the five-year plan, according to a document placed in the planning commission

meeting on Wednesday. For instance, the health sector got 6.16 percent ADP allocation this fiscal year against the projection of 11.1 percent, while education got 13.38 percent against the projection of 16.5 percent.

8.3kg cocaine seized at HSIA in biggest haul

Malawi woman held at the airport; gang transporting drugs to India from Africa via Bangladesh: DNC MOHAMMAD JAMIL KHAN

Drug traffickers have been transporting cocaine through Bangladesh from certain East African countries to India for years, said officials at the Department of Narcotics Control.

The trafficking gang has two to three suspected members from Bangladesh, and several others from some East African countries, a DNC official told The Daily Star.

Tanvir Momtaz, director (operations) at the DNC, told a briefing yesterday that the DNC along with the Airport Armed Police Battalion (APBn) on Wednesday night seized 8.3kg of cocaine, a record bust in the

## More areas to feel the chill

### Nighttime temperature may fall from tonight STAFF CORRESPONDENT

A mild cold wave is sweeping over several districts and is expected to spread further.

The areas affected are Naogaon's Badalgachi upazila, Saidpur district in Rangpur division,

Panchagarh's Tentulia upazila, Nilphamari's Dimla upazila, and Kurigram's Rajarhat upazila.

"The cold wave sweeping over these places and will spread as night

temperatures in those areas may dip further from tonight [last night]," said Hafizur Rahman, meteorologist of Bangladesh Meteorological Department.

The country's lowest temperature yesterday was recorded at 8.3 degrees Celsius in Dinajpur.

Even though the temperature in Dhaka had risen a little to 14.2 degrees Celsius yesterday, cold gusty wind was present

## NBR considering duty waiver for essential imports STAFF CORRESPONDENT

The National Board of Revenue is considering waiving the duties on essential commodity imports as part of the government's efforts to keep the prices affordable for Ramadan, said its chief yesterday.

"We have received a proposal from the commerce ministry [on this] -- are working on it," said Abu Hena Rahmatul Muneem, chairman of NBR, at a press briefing at the NBR's headquarters in the capital.

However, he didn't disclose any product list.

On Monday, the commerce ministry sought a waiver of import duties on edible oil, sugar and dates as the newlyformed Awami League government looks to make good on its top election promise of reining in inflation, which has stayed above 9 percent for nine months in a row.

Asked about the possibility of meeting of the International Monetary Fund's revenue collection target, Muneem said: "This is really a challenging for us. We have taken some specific strategies in all three wings -- income tax, VAT and customs -- to meet the challenges."

The revenue collection target set for this fiscal year by the IMF is Tk 394,530 crore, meaning the NBR's collection must increase 20.4 percent year-on-year.

The government has set a Tk 430,000 crore collection target for the NBR.
