

# Either GM Quader resigns or we form 'Trinamool JP'

### Warn party leaders who recently resigned, got expelled

Just before the national election, 'Trinamool BNP" caused quite a stir, with two former BNP leaders at its helm. However, they failed to win a single seat in the polls, with its top leaders losing by big margins.

Meanwhile, it looks like a section of expelled Jatiyo Party leaders have decided to take inspiration from the "other" BNP, and decided to form a party of its own named "Trinamool Jatiyo Party".

Leaders who have resigned and been expelled from within the party ranks are now gathering under the banner of JP chief patron Raushan Ershad.

They want to convince the widow of JP founder HM Ershad to stage a coup within the party and oust JP Chairman GM Quader and Secretary General Mujibul Haque Chunnu. If not, they plan to form "Trinamool JP" with Raushan at its helm, say aggrieved leaders.

Earlier, the JP split over conflict among its top leaders in 1991, 1996, 2001, and 2014.

Raushan will hold a viewsexchange meeting with the former JP leaders today, said Lutful Kabir, special assistant to

the spokesperson of Raushan. Sources said the resigned leaders are trying to hold a council of JP under the leadership of Raushan. Around 668 leaders of JP's DhakanNorth unit resigned on Thursday showing no confidence in GM Quader and Chunnu.

The leaders led by Shafiqul Islam Sentu, a presidium member of JP who was recently expelled from the party, also demanded resignation of GM Quader and Chunnu

their alleged for irregularities centring giving nomination to the party's aspirants in the lead up to January 7 polls.

"We are trying to get united under the leadership of Raushan

Ershad to save the party. She will declare our next course of action," Sentu told The Daily Star. "Many of us have proposed to form a new political party named Trinamool Jatiyo Party. We will discuss this with Raushan

Ershad," he said. Another axed JP leader Shunil Suvho Roy echoed him.

Contacted, Chunnu said, "We have many leaders and activists. Everyone has the right to form new political parties or resign from one. We are not worried."

Kitchen markets across Barishal division have recently been flooded with jatka (hilsa fry of length less than 10 inches).

The fisheries department complained that the upazila administrations across the division have not been conducting enough drives against

catching and sale of jatka. Īt is а punishable offence to

jatka catch during its eight-month conservation period from November to June. Visiting

kitchen markets in Bhola and Barishal yesterday, including Barishal Port Road Market and Bhola Sadar Upazila Fish Market, this correspondent saw jatka is being sold in large amounts for Tk 270-350 per kilo.

According to Divisional fisherman in Paranganj Bazar Fisheries Office, 700-1000 maunds of hilsa are being sold of Bhola Sadar upazila. daily in hundreds of markets across Barishal. However, fisheries officer in Barishal,

The data also revealed that among the 98 university students who died by suicide last year, 26 studied in National Universities, while 19 studied in public universities.

Dhaka and Chittagong universities emerged as the institutions with the highest number of student suicides, each recording five cases.

Aachol Foundation suggested monthly mental health screenings and mentorship programs for students, along with mental health corners in schools.

They also proposed integrating mental health education into teachers training, destigmatising mental health, and offering support hotlines for quick access to assistance.

Speakers at the press briefing stressed the significance of instilling emotional regulation skills in students to prevent suicide, urging the students to develop social skills to avoid feeling isolated.

A lack of emotional expression and societal biases against women contribute to the higher incidence of suicide among female students, especially those of younger ages, the

Saidur Rahman additional secretary, Health Services Division, Ministry Additionally, 2.5 percent of Health & Family Welfare, of suicides were linked to said students often face emotional, academic, and family pressures, leading some to develop suicidal thoughts. There is a lack of

support for students within educational institutions to address these issues, he said, stressing the need for government agencies with to coordinate

organisations dedicated to suicide prevention efforts. Dr Helal Uddin Ahmed, associate professor, Dept of Child Adolescent & Family Psychiatry, National

Institute of Mental Health, highlighted the need to assess teaching methods and curricula to enhance students' emotional regulation skills, along with shifting societal attitudes towards women.

DU criminology assistant professor ABM Nazmus Sakib stressed the need to strengthen social ties among students to reduce suicide rates and urged the establishment of supportive environments where students feel free to express their emotions.

Tansen Rose, founding president of Aacho Foundation, chaired the conference, while Farzana Akhter, team leader of the organisation's research and analysis division, presented the keynote.
