The 'big boss' and his narco syndicate

DNC says so far they found citizens of 5 countries involved in cocaine trade

The citizens of at least five countries were involved with the transnational syndicate that was smuggling narcotics from East African countries to India using Bangladesh as a transit route.

Under the guise of a readymade garment trader, a Nigerian citizen – Don Franki alias Jacob Franki – is the mastermind behind it.

Franki is known as the "Big Boss" among syndicate members. He has been living in the country for the last nine years. During the stay, he recruited a couple of Bangladeshis as local aide.

Mustakim Billah Faruqi, director general of the Department of Narcotic Control, disclosed

the findings yesterday following arrest of five people including

Nigeria, Cameroon, and Bangladesh nationals.

The arrestees are Kelvin Yenge, 42, a Cameroon national, Nonso Ezema Peter alias Oskar, 30, and Ndulu Ebuka Stanley alias Podosky, 31, both Nigerians, and Saiful Islam Rony, 34, and Asaduzzaman Apel, 27, both Bangladeshis.

But the DNC failed to arrest Franki as he left the country for Nigeria nine months back. Franki's brother Wissly, who was taking care of the syndicate in his absence, also went into hiding.

Faruqi said they found out about the syndicate after 8.3 kilogrammes of cocaine were recently seized in Dhaka.

'SHARIFA'S STORY' CONTROVERSY

An agenda to dismantle secular, inclusive education

Speakers tell conference

The Ekattorer Ghatok Dalal Nirmul Committee yesterday said the "hijra/transgender" controversy in the textbook serves as a camouflage for a hidden agenda to dismantle secular and inclusive education in the country.

At a press conference at Dhaka Reporters Unity, they termed the act of tearing up the textbook page by a teacher unconstitutional, saying that the activities that followed the tearing up incident are a threat to Bangladesh's existence, and demanded punishment for the instigators.

Shahriar Kabir, president of the organisation, said, "The new curriculum is very contemporary, but the religious extremists don't like it. Their goal is to create anarchy by making it a focal point."

"We urge the government not to yield to this community and make any change to the content of the book," he added.

Students and teachers of all universities should come forward and protest against the ill intentions of this group, said Shahriar Kabir.

Prof Muntassir Mamoon expressed shock at the "shameful" acts of the teacher, saying, "A

teacher should not act in such a manner; it sets a harmful and bad example for future society."

Previously, on many occasions, the government was seen bowing down to this community and catering to their interests. Prof Mamoon said such weakness undermines secularism.

Justice AHM Shamsuddin Choudhury Manik said, "Our constitution prioritised gender equality and their rights. But the way a teacher tore the pages of a textbook and misled the content of the book is a violation of constitution."

'How many died in 15 years due to negligence?'

Asks HC on United Group hospitals

The High Court yesterday wanted to know how many patients died at the hospitals of United Group "due to medical negligence" in the last 15 years.

The court ordered the director general of Directorate General of Health Services to submit a report to this effect in three months.

The HC also asked Deputy Attorney General Tushar Kanti Roy to submit the probe report on the death of five-year-old Ayaan.

Earlier in the day, the DGHS placed the probe report through the DAG before the HC bench of Justice Mustafa Zaman Islam and Justice Md Atabullah, in compliance with HC's January 15 directive.

The court did not disclose the contents of the report.

On January 15, the HC bench ordered the DG of DGHS to take steps to inquire into Ayaan's death at United Medical College Hospital and submit a report to the court in this regard.

The court issued a rule asking the authorities concerned of the hospital and government to explain why they should not be directed to give Tk 5 crore to the family of Ayaan, who died following a circumcision at the hospital allegedly due to "negligence and wrong treatment".

'AL can't hold back democracy-loving people'

Says Moyeen Khan

BNP standing committee member Abdul Moyeen Khan yesterday said the party was not able to achieve what they expected on January 7, but there is no point in being disappointed about it.

"Don't be disappointed. Keep your morale high," he said, addressing the party men at a discussion organised by Gonoforum and Bangladesh Peoples Party in the capital.

He said the BNP wants to bring back a "democratic environment" in the country, not terrorism.

"Awami League will not be able to hold back the democracy-loving people of the country," Moyeen said.

Opposition parties have been most "oppressed" during AL's regime, while BNP never oppressed opposition parties when it was in power, he said.

Moyeen said black flag marches are a globally recognised form of peaceful protest.

"It's the language of protest. This is the language we will not stop using until this government is overthrown," he added.

India played its part as 'honest neighbour': Quader

India has played its due role in the 12th parliamentary election as an "honest neighbour", Road Transport and Bridges Minister Obaidul Quader said yesterday.

Quader, also the general secretary of ruling Awami League, was speaking to reporters after the Indian High Commissioner to Bangladesh Pranay Verma met him at the former's Secretariat office.

"Many tried to destabilise the country centring the general elections. At that time, India stood beside us. We have to admit it," Quader said.

The minister said they talked about ongoing and potential projects to be implemented with Indian finance.
