Celebrities, masterclasses, and premieres of Bangladeshi and international films marked the conclusion of the 22nd Dhaka International Film Festival (DIFF), organised by the Rainbow Film Society, which captivated the town's attention. The festivities commenced on January 20, with nearly every session making headlines in the media.

degrees Celsius in Cox's Bazar's and other vegetables, from various Teknaf and Chattogram's Sitakunda upazilas. Dhaka saw a minimum temperature of 12.7 degrees Celsius.

A mild to severe cold wave is sweeping Rangpur, Rajshahi, Dhaka, Khulna, and Barishal divisions and Cumilla, Sitakunda, and Moulvibazar districts, according to the BMD. Temperatures between eight and

10 degrees Celsius are considered mild cold waves; six to eight degrees Celsius are moderate cold waves; and less than six degrees Celsius are severe cold waves.

Moderate to thick fog may occur at places over the river basins and light to moderate fog at places elsewhere across the country from midnight to morning.

BMD officials, however, said the temperature across the country is expected to start improving.

"At places, the temperature will start getting warmer from Sunday [yesterday] night and will continue to do so till February 3, after which the country will not likely see any more moderate or severe cold waves this season," said BMD Meteorologist Omar Faruq yesterday.

People living in the northern districts of Dinajpur and Thakurgaon continue to experience a cold spell that is significantly disrupting daily

Liakat Ali, a resident of the Rajbari area of Dinajpur town, said he had to drive his rickshaw van early in the morning, but the cold was so intense that his fingers went numb.

All educational institutions in the districts remained closed yesterday. The weather also affected flight

operations at Saidpur Airport in Nilphamari. Airport Manager Suplob Kumar Ghosh said the operation of flights

suffered disruptions for an hour due to low visibility caused by dense fog. "Operations resumed after 1:00pm." Thakurgaon, low-income groups are suffering the worst, with

limited income for the last week. Rickshaw puller Rafiqul Islam said his daily income has been dropping for a week as people chose to stay indoors unless there was an emergency. "It's also very hard to pull

a rickshaw in this bone-chilling cold."

Footage showed about 30 bodies were piled up in Nasser Hospital in Khan Younis as families continue to bury their children in a mass grave inside the courtyard, reports Al Jazeera online.

Palestinians are fleeing further south from Khan Yunis towards Rafah, close to the Egyptian border, where the United Nations says most of Gaza's estimated 1.7 million displaced people have gathered.

#### PM calls

Meanwhile, farmers fear losses parliamentary delegation led by Vice Chair of All-Party Parliamentary Group on Bangladesh and Chair of APPG on Indo-British, Virendra Sharma, MP, paid a courtesy call on her at the Gono Bhaban.

PM's Speechwriter M Nazrul Islam briefed journalists after the meeting.

This is the first parliamentary visit from the UK since the national election was held in Bangladesh on January 7.

During the meeting, Hasina said they gave shelter to Rohingyas after their mass exodus in face of inhuman torture in 2017.

Myanmar has agreed to take back its nationals, but has yet to take any measure to this end despite the fact that six years have already passed, she

Mentioning that the global monetary assistance has decreased since the Covid-19 pandemic and Russia-Ukraine war, she said, "So, Rohingvas are now becoming a huge burden for a small country like Bangladesh."

She also alleged that many JP candidates quit the race as the two did not look after them.

The party leaders and activists have the right to protest against the leadership for the election failure. Atmosphere in the party has been damaged as GM Quader and Chunnu did not discuss or console the party activists after the polls disaster, rather expelled many activists, Raushan said.

To resolve the ongoing crisis in JP, Raushan said she removed the duo from their posts and took charge of the party chairman on request of the party leaders and activists.

She also made her Spokesperson Kazi Mamunur Rashid the new JP secretary general until a JP council is

Raushan added that those relived from the party or kept outside the

Jatiyo Party: where drama never stops organisation would be reinstated.

Around an hour after her announcement, Chunnu said they are least bothered about the "baseless move" by Raushan, claiming that she has no jurisdiction to make such

"As per our party's charter, she has no power to become JP chairman or dismiss anyone from any post," he said at an emergency press conference in the JP chairman's Banani office.

Chunnu also mentioned that Raushan had announced expulsion of GM Quader thrice and later backtracked.

"Her post is ornamental and as such she is no one in the party. Therefore, she has no such power in the party constitution."

The JP competed in 265 seats in the recently held polls. After a deal with the ruling party, the AL agreed

to withdraw its candidates from 26 constituencies. But the JP could manage to win in only 11 seats, making the worst result of the party since 1991.

Around 90 percent JP nominees, including several heavyweight ones, lost their security deposits. Raushan and her son did not run

"due to a conflict with GM Quader over party nominations". Around 668 JP leaders of Dhaka (city) north unit resigned from the party on January 25, saying they have

no confidence in GM Quader and

Chunnu. On January 14, JP grassroots leaders at a programme in the capital held GM Quader and Chunnu responsible for the party's election disaster.

They alleged that the duo got money for taking part in the polls, but did not spend any for party candidates' campaigns.
