More than 12 celebrities are set to publish their books this year. Here are the details of their published works:


Abul Hayat, the recipient of the coveted Ekushey Padak, will publish a new novel

AR Rahman clarifies use of AI to recreate voices of late singers

Renowned composer AR Rahman has addressed the controversy surrounding his use of Artificial Intelligence (AI) to recreate the voices of late singers Bamba Bakya and Shahul Hameed

for the song Thimiri Yezhuda in Rajinikanth's upcoming film Lal Salaam.



The move sparked mixed reactions from fans, prompting Rahman to provide clarification.

Taking to his X account on Tuesday, Rahman shared a post of Sony Music South, emphasising the utilisation of AI to replicate the

late singers' voices. In the caption, he stated, "We took permission from their families and sent deserving remuneration for using their voice algorithms... technology is not a threat and a nuisance if we use it right."

'Suits' sets new streaming record, surpassing 'The **Office'**

Legal drama *Suits* took the top spot as the most streamed title ever from another audience favourite The Office in 2023, while shows on Netflix dominated overall streaming charts, according to Nielsen data.

Available for streaming on Netflix and Comcastowned Peacock, Suits racked up 57.7 billion viewing minutes in 2023. The Office had generated 57.1 billion viewing minutes in 2020 amid pandemicinduced lockdowns, according to the report.

Some of the other widely streamed shows last year were Bluey, NCIS, Grey's Anatomy and The **Big Bang Theory**

the maiden session of 12th parliament. The speech was earlier approved by the cabinet.

Shahabuddin said the free, fair and impartial 12th national election, which has been appreciated at home and abroad, is a watershed moment in the history of the country's democracy.

"I firmly believe this is the victory of the people and also of democracy. He lauded the efforts of all the authorities concerned, including the Election Commission and the armed forces, for successfully conducting a free, fair and impartial election through upholding the spirit of the constitution.

Regarding the election, the president said a quarter tried to obstruct the peaceful course of democracy in Bangladesh by carrying out violence. Their anti-democratic and violent activities temporarily made people anxious, but those did not deter voters from casting ballots, he said.

"The parties who stayed away from the polls carried out their political programmes without any hindrance." He hoped the political parties

will shun violence and anarchy and observe constructive programmes in a non-violent way to establish the constitutional rights of the people and ensure democracy.

Islami Bank

In its meeting minutes, Sonali said it extended the liquidity support despite having no counterparty credit limit for Islami Bank considering the Shariah-based bank's financial health, including satisfactory credit rating and tolerable classified loan rate.

A counterparty credit limit is a perimeter imposed by a bank or financial institution to cap its maximum possible exposure to a specified counterparty.

The liquidity support was given in the interest of the country's overall banking system as the Shariah-based bank was facing a temporary liquidity crisis, the meeting minutes said.

Islami, which accounts for the highest volume of deposits and loans among the 61 scheduled lenders in Bangladesh, has a deficit in its current account with the central bank for a long time.

Banks have to maintain a current account with the central bank for different clearing payment systems and they have to maintain a hefty balance in the account.

As of January 11, Islami had a Tk 3,647 crore deficit in its current account that it maintains with the BB, according to an internal document of the central bank.

ruling. "We don't accept this illegal decision," Khan's lawyer, Naeem Panjutha, posted on social media platform X.

The PTI has not called for protests or demonstrations before the election. A bomb in Pakistan's Balochistan region killed three PTI members yesterday, the party said, hours after Khan was sentenced. There were no details of who was responsible.

Khan aide Zulfikar Bukhari told Reuters that the legal team was given no chance to represent Khan or cross examine witnesses. The proceedings were carried out in maximum security Adiala jail in Rawalpindi.

Another of Khan's lawyers, Ali Zafar, told ARY television that given the circumstances of the trial and sentencing, the chances of the case being quashed on appeal were "100 percent".

Bukhari called the conviction an attempt to weaken support for Khan. "People will now make sure they come out and vote in larger numbers," he told Reuters.

Khan was previously sentenced to three years in a corruption case, which had already ruled him out of the election next week.

His legal team was hoping to get him released from jail, where he has been since August last year, but

the latest conviction means that is unlikely even as the charges are contested in a higher court.

The party of three-time Prime Minister Nawaz Sharif, Khan's main political opponent, said the verdict was not harsh enough.

"I think, based on his carelessness and crime - pertaining to important national interests - this is a very light sentence," Ahsan Iqbal, a senior Sharif aide, said in a TV interview.

Analysts believe Sharif's party is the frontrunner to form the next government. Sharif and his daughter, Maryam Nawaz, were convicted and jailed over graft allegations days before the last general election in 2018.

that a senior international lawyer lead a small team of independent legal experts to conduct a review of the cases against Prof Yunus.

Asked, Hasan Mahmud said the statement on Prof Yunus was published in the Washington Post as an ad, not as news. Such ad was also published before.

He, however, did not elaborate on the government not being any party to the case involving Prof Yunus.

On January 1, Prof Yunus and three other top officials of Grameen Telecom were sentenced to six months in jail in a case filed on September 9, 2021, by Labour Inspector (General) SM Arifuzzaman over labour law violations.

Lawyer Md Yousuf Ali, a lawyer for Grameen Telecom workers, on May 22, 2022, had told The Daily Star that

all the other cases filed against Prof Bangladesh. There are scopes for Yunus and Grameen Telecom were withdrawn by the latter's employees after they reached a settlement over the claim of payments.
