Destroying croplands for brick kilns

Local influentials stealing topsoil from fields near Arial Kha, other rivers

Agricultural land along the Arial Kha river is scarred by huge holes, 8-12 feet deep, from illegal topsoil extraction for brick kilns. This not only destroys the land's fertility and reduces crop yields, but also weakens riverbanks, making them vulnerable to erosion. Despite farmers' protests, authorities are yet to take action, leaving many losing their arable lands.

The situation is particularly worse in Commissioner Char (shoal) in Barishal's Muladi upazila. The status quo is more or less the same in shoals under Hijla, Mehendiganj, Babuganj and Bakerganj upazilas of the

A section of influential people, including Moshiur Rahman, owner of NRB Bricks at Auliapur village in Bakerganj, is behind these illegal activities, according to farmers and authorities concerned.

On January 23, Moshiur was fined Tk 20,000 on the charge of stealing topsoil and using it in his brick kiln.

Contacted, Moshiur denied the allegations. When asked as to why he was fined, he evaded

Altaf Payada, a resident of Commissioner Char, said the culprits are using excavators to extract the soil late at night and transporting it using trawlers to brick kilns.

"The topsoil from around 10 percent land of the shoal, around three square kilometres area, has already been extracted. Due to the rampant soil extraction, farmlands are turning into ponds in many places," he added.

Mohammad Ali, a resident of Janpur village, said, "People are losing their agricultural

lands along the Meghna river, while many are becoming homeless due to erosion. At least 10 brick kilns are operating with soil extracted from the riverbanks in Hijla upazila alone."

Md Shawkat Osman, deputy director of Department of Agricultural Extension in Barishal, said, "Extraction of topsoil causes removal of gypsum and zinc from it. Due to this, the organisms present in the soil become

less functional and reduce the soil's fertility."

Locals in Kalaskathi union under Bakergani upazila formed a human chain in August last year, protesting the illegal soil extraction from riverbanks. Many of the affected shared their ordeal there.

"Every day, around 30-35 trawlers transport soil extracted from the banks of Pandab river SEE PAGE 4 COL 4

Man sentenced to 6yrs in prison in DSA case

The Cyber Tribunal in Rajshahi yesterday sentenced a man to six years imprisonment in a case filed under Digital Security Act-2018.

Mizan Ali Tuhin, 25, of Shibganjin Chapainawabgani was given three years imprisonment under section 25 (1), two years in prison under 26 (1) and one year iail under 29 (1) of the DSA, said Ismat Ara, public prosecutor of the tribunal.

Judge Md Ziaur Rahman gave the verdict.

According to the case statement, a victim filed a case against Mizan with a Chapainawabganj court, accusing him of taking her photographs on February 3 last year, while they were studying at Rajshahi New Degree College in 2022.

A man was found dead at his farm in Savar vesterday. Police recovered the

throat-slit body of Kazim Uddin, 50, from the cattle farm adjacent to his house at Dendabar Uttarpara in Ashulia.

Criminals might have killed him sometime between early morning and 10:00am yesterday, said OC AFM Syed of Ashulia Police Station.

According to police and the victim's family, Kazim, a contractor of Dhaka Palli Bidyut Samity, stayed in the office room of his farm at night as he did so often.

On information from a farm employee that the office door was locked from outside, his wife rushed to the spot and found the bloodstained body inside.

Stop construction on Karnaphuli bank **Demand port city residents**

A section of residents of Chattogram city at a human chain yesterday demanded that the authorities concerned take effective measures to stop construction of structures on the bank of Karnaphuli river.

The event, held on the premises of Chattogram Port Authority's office, was organised by Bangladesh Environmental Lawyers Association, Bangladesh Environment Forum, Chattogram Nodi O Khal Rokkha Andolon and Rezaul Karim Shikder

Speakers said a new ghat is being constructed on the foreshore of Karnaphuli in the port city's Fishery Ghat area with the land being illegally leased by CPA.

"While the High Court directed CPA to demolish all illegal structures constructed by encroaching the Karnaphuli riverbank several years ago, the state agency took no visible action against the grabbers," said Aliur Rahman, secretary of the Chattogram Nodi O Khal Rokkha Andolon.

The platform's president Chowdhury Farid said they will file a petition with the HC.

Chattogram district administration earlier demarcated the Karnaphuli and identified 2,187 illegal structures on both its banks as per the HC orders in
