#### Pak senators decry alleged rigging in Feb 8 polls

Berate CEC for his 'failure' to ensure transparency

A number of Pakistan senators in the upper house of Parliament yesterday decried alleged rigging in the February 8 elections and berated Chief Election Commissioner (CEC) Sikandar Sultan Raja for his "failure" to ensure transparency in the polls.

Jamaat-e-Islami (JI) Mushtaq Ahmed demanded CEC Raja to step down from his position over the failure to hold transparent polls.

The JI senator, while addressing a Senate session in Islamabad, said the elections were fake and they would procreate a fake government. During the session, a number of senators also raised concerns regarding allegations of polls rigging.

Levelling serious allegations against the Election Commission of Pakistan (ECP), Mushtaq said the electoral body committed treason for which it should seek an apology from the nation.

"A legal proceeding should be carried out against the CEC under Article 6 of the constitution, for the ECP was given Rs50 billion from the national exchequer but it failed to hold transparent polls," he alleged.

The senator also rebuked the authorities over the suspension of social media platform, X, saying that it inflicted economic and educational damage as well as it was tantamount to robbing people's rights.

Imran Khan's PTI yesterday also demanded that CEC Raja immediately resign, saying that the CEC failed to hold elections in a free, fair and transparent manner.

Meanwhile, PPP Chairman Bilawal Bhutto-Zardari has said that he foresees a stalemate in government formation "if someone is not ready to change their stance".

## **US vetoes UNSC push** for Gaza ceasefire

The United States yesterday again vetoed a draft United Nations Security Council resolution on the Israel-Hamas war, blocking a demand for an immediate humanitarian ceasefire.

Thirteen council members voted in favor of the Algerian-drafted text, while Britain abstained. It was the third such US veto since the start of the Israeli offensive in Gaza on October 7.

"A vote in favor of this draft resolution is support to the Palestinians right to life. Conversely, voting against it implies an endorsement of the brutal violence and collective punishment inflicted upon them," Algeria's UN Ambassador Amar Bendjama told the council before the vote.

US Ambassador to the UN Linda Thomas-Greenfield signaled on Saturday

that the US would veto the draft resolution over concerns it could jeopardize talks between the US, Egypt, Israel and Qatar that seek to broker a pause in the war and the release of hostages held by Hamas in the Gaza Strip.

"Any action this council takes right now should help, not hinder these sensitive, and ongoing negotiations. And we believe that the resolution on the table right now would, in fact, negatively impact those negotiations," Thomas-Greenfield told the council ahead of the vote.

"Demanding an immediate, unconditional ceasefire without an agreement requiring Hamas to release the hostages will not bring about a durable peace. Instead, it could extend the fighting between Hamas and Israel," she said.

The United States has since proposed a rival draft resolution calling for a temporary ceasefire in the Israel-Hamas war and opposing a major ground offensive by its ally Israel in Rafah, according to the text seen by Reuters. It said it plans to allow time for negotiations and will not rush to a vote.

Until now, Washington has been averse to the word ceasefire in any UN action on the Israel-Hamas war, but the US text echoes language that President Joe Biden said he used last week in conversations with Israeli Prime Minister Benjamin

The US draft resolution would see the Security Council "underscore its support for a temporary ceasefire in Gaza as soon as practicable, based on the formula of all hostages being released, and calls for lifting all barriers to the provision of humanitarian assistance at

#### **India SC declares** AAP's Kumar winner of Chandigarh polls

India's Supreme Court yesterday made history by declaring the Aam Aadmi Party's Kuldeep Kumar the winner of last month's Chandigarh mayoral election, ending weeks of controversy after Returning Officer Anil Masih was caught on camera invalidating and discarding eight votes in his favour. The order - preceded by the counting of votes, including those erroneously rejected, in the courtroom rather than a counting centre - cancels the earlier result that saw the BJP's Manoj Sonkar elected Mayor. Masih also faces a contempt of court action initiated by the top court. Should Masih be prosecuted - in an earlier hearing the SC called his actions a "mockery of democracy" and indicated it would do just that - it will be a historic first in independent India, and a stern warning to potential hijacking of polls results weeks before the Lok Sabha election. The judgement also means the AAP and Congress have recorded the INDIA bloc's first win as it bids to defeat the BJP.

#### First brain chip patient can control mouse by thought Says Elon Musk

The first human patient implanted with a brainchip from Neuralink appears to have fully recovered and is able to control a computer mouse using their thoughts, the startup's founder Elon Musk said late on Monday. "Progress is good, and the patient seems to have made a full recovery, with no ill effects that we are aware of. Patient is able to move a mouse around the screen by just thinking," Musk said in a Spaces event on social media platform X. Musk said Neuralink was now trying to get as many mouse button clicks as possible from the patient. Neuralink did not immediately reply to Reuters' request for further details. The firm successfully implanted a chip on its first human patient last month, after receiving approval for human trial recruitment in September.

"The corporate groups produce chicks as per their demand and gave chicks to their contract farmers. The remaining low-quality chicks are being sold at a premium price of Tk 70 to Tk 80 per piece to the marginal farmers through their distributors," Sumon alleged.

In reply to the query whether the price will go up before Ramadan, he said due to the shortage of chicks, the price will increase before Ramadan. The price will start decreasing from the first week of Ramadan as the demand for eggs and chicken will be low

Asked about the marginal farmers' demand to keep the market stable during Ramadan, he said, "Extortion and police harassment across the country should be stopped. At the same time, it is important to take steps so that the chicken and egg carts of the marginal farmers can ply during the daytime.' Bangladesh Poultry Association
