Dengue claims one more life

Bangladesh reports another Covid death

STAFF CORRESPONDENT

One more dengue patient died while 16 others were hospitalised in the last 24 hours till yesterday morning.

The total number of deaths rose to 17 this year, according to the Directorate General of Health Services.

The total number of cases now stands at 1,316.

Last year, the country witnessed 1,705 dengue related deaths and a total of 321,179 reported cases. Meanwhile, country saw

another Covid-19 death in the last 24 hours till 8:00am yesterday.

So far, DGHS has reported 10 Covid-related deaths in this year.

DGHS data shows that Covid infection rate rose to 10.18 percent from Wednesday's 8.93 percent. The number of fatalities

now stands at 29,486, taking the overall fatality rate to 1.44 percent.

Of fake visas and shattered European dreams

Syndicate comprising Biman, foreign airline, travel agency staffers involved in trafficking youths

An organised syndicate is trafficking youths to Schengen and Middle Eastern nations by collaborating with a group of lower-ranked officials from several agencies at the airport, as well as airline and travel agency staffers.

The syndicate also involves some manpower export companies and professional computer operators who arrange visas for them, which are mostly fake.

For processing the documents and other arrangements, the syndicate charges Tk 16 lakh to Tk 18 lakh.

The Detective Branch of police yesterday disclosed the findings following the arrest of five people on Tuesday in a joint operation with Airport Armed Police Battalion.

The arrestees are Asaduzzaman,

at least 250 to 300 youths from Bangladesh so far," he said. Police also recovered three passports, three fake visas, four NIDs, a special card to enter Hazrat Shahjalal International Airport, four visa cards, five cell phones, three e-tickets, and a fake work permit, among other things.

Harun Or Rashid, additional commissioner of the Detective Branch of Dhaka Metropolitan Police, said falling prey to the syndicate, many trafficked victims were arrested at the airport, while some got arrested in intermediate transiting countries and were repatriated to Bangladesh.

In many cases, these victims have to spend a miserable life in jails after they get arrested in the destination country for using fake visas or for using a tourist visa to work, he said.

Depending on the syndicate's capacity, only a few people may succeed in settling in the destination country, but the majority lose everything, added the DB chief.

Have to use vast maritime resources for our progress: PM

Minister Sheikh Prime Hasina yesterday stressed on extracting marine resources Bangladesh's from vast maritime zones maintaining friendly relations with the neighbouring countries to tap potential of the "Blue Economy" for the country's socio-economic advancement.



Hasina made the remarks at an event marking the golden jubilee of enacting the law titled "The Territorial Waters and Maritime Zones Act, 1974" at Bangabandhu International Conference Centre (BICC) in Dhaka.

"We will have to be cautious in extracting our marine resources and in continuing business and trade using seaways maintaining our foreign policy -- Friendship to all, malice to none.'

She said conflicting situations are being seen in many areas across the globe. But there is no conflict in this region, she said.

The prime minister said the Bay of Bengal is a part of the Indian Ocean and it is a very important marine route as international business and trade have been continuing on it since ancient times.

Hasina reiterated that Bangladesh always believes in peace, and said, "We don't want war; we want peace. Peace shows the path of development and progress and helps the nation march forward.'

She said, "We will never engage in war. But, we have to have capability to protect our sovereignty."

Ten members of mugger gang arrested

Their 'big brothers' won't be spared, says DB chief STAFF CORRESPONDENT

The Detective Branch of Dhaka Metropolitan Police vesterday claimed to have arrested 10 members of a gang over mugging and other offences during a drive in Tajmahal Road, Geneva Camp, and Basila areas of the capital on Wednesday.

The arrestees are Raja, 35; Md Jalal, 25; Md Mridul, 26; Md Jahangir, 35; Md Shamim Mia, 24; Md Shahid, 25; Md Shimul, 25; Monirul Islam, 27; Sohel Khan, 23; and Nur Mohammad, 20.

Each of them faces multiple charges, with Raja alone having 11 cases lodged against him while Mridul has four.

Pay retirement benefits to nongovt teachers HC directs govt

The High Court yesterday directed the government to pay retirement benefits to the teachers and staff members of non-government educational institutions under the Monthly Payment Order in six months into their leaving from services.

Delivering verdict on a petition, the HC said the teachers and staff members of non-government educational institutions are harassed and victimised over the years to get retirement benefits.

"It should be thought how much salary a teacher gets. They should not have to move from door to door for years to receive the retirement facilities," the HC bench of Justice Naima Haider and Justice Kazi Zinat Hoque observed.

The bench delivered the verdict after holding hearing on a petition filed by 131 teachers and staff members in 2019 seeking necessary directives.

Petitioners' lawyer Mohammad Siddique Ullah Miah said more than 5 lakh teachers and staff members will receive benefits following the HC verdict.

Siddique said the government had earlier deducted total six percent from the salaries of the teachers and other employees of the non-government educational institutions under MPO till 2017, for giving retirement benefits to them.

The same year the government issued two gazettes for deducting total 10 percent from their salaries, he said, adding, the government did not increase the benefits in proportion with the 10 percent of the deducted amount.
