5 JMB men jailed for sabotage

Among the convicts, Md Morshed Alam, Md Saiful Islam, Md Zahirul Islam and Md Maqsudur Rahman were sentenced to six years' imprisonment while Tariqul Islam for five

They are from Satkhira, Pirojpur and Bagerhat.

According to the case statement, on November 3, 2016, the JMB men themselves positioned in the Gobar Dia area adjacent to Daratana bridge to carry out sabotage.

Acting on information, police went to the scene and arrested them.


