political and post-election violence continued, while incidents such as abduction in the name of law enforcers, death in custody, and death in torture, have occurred.

Misuse of cyber and digital security laws, obstructing the exercise of constitutional rights to investigative journalism and expression, is taking place, said the report.

In February, violence against women and children such as rape, gang rape, murder, suicide and domestic violence continued as in previous months which is very alarming, said MSF.

The MSF data shows there were 291 cases of violence against women and children last month. Meanwhile, 13 journalists were tortured while performing their duties in February, according to MSF. Among them, 10 were attacked and injured, while three were threatened.

The report also said three cases were filed under Cyber Security Act in February in Noakhali, Mymensingh and Sylhet, with nine people charged in the cases. Two of them were arrested.

In February, three Bangladeshis were injured in BSF firing on the border, while 26 Bangladeshis were taken into custody by BSF and the strangled body of a Bangladeshi teenager was recovered inside the Indian border, said the MSF report.

"I want to say that when this law was passed in 2002, it was intended to persecute the Awami League and other parties who opposed the BNP. However, if you [MPs] observe how this law has been enforced over the last 15 years, your [Chunnu] concern is unfounded," he said.

"Since 2009 to 2024, it [the law] has not been used against political activists or leaders. Many types of violence, chaos have been prevented by this law. This is why this law should be made permanent," he said while defending the move.

The bill does not propose any amendment other than making the law permanent. Therefore, the all the existing sections of the law will remain as it is now.

UP chairman suspended over threat to US envoy

The Local Government Division has suspended a union parishad chairman for saying on November 6 last year that he wanted to assault US Ambassador Peter Haas.

Mujibul Haque Chowdhury, chairman of Chambol UP in Chattogram's Banshkhali, was addressing an anti-hartal rally of Awami League when he said he would beat up Haas. Video footage of the incident went viral on social media.

As per a notice of the LGD on Tuesday, Mujibul was suspended on the recommendation of Chattogram DC Abul Bashar Mohammad Fakhruzzaman.

Banshkhali UNO Jesmine Akter confirmed the matter yesterday. Mujibul could not be contacted for comments.

Doctor set on fire by ex-husband dies after 4 days

A female doctor, who was set on fire by her former husband in Narsingdi four days ago, died at the National Institute of Burn and Plastic Surgery in Dhaka yesterday.

The deceased is Lata Akhter, 32, of Narsingdi's Raipurapazila.

The ex-husband, Khalilur Rahman, 40, of Gazipur, who also suffered burn injuries, died on Monday.

Lata's uncle Faruk Miah said Lata got married to Khalil two years ago after a relationship. However, they divorced around two months ago over a family feud, Faruk said.

Since then, Lata had been staying at her family home.

Faruk said Khalil hid his job identity from Lata before marriage. Khalil claimed that he was an expatriate, but he was an auto-rickshaw driver. This led to their divorce, he added.

On February 25, Khalilur went to Lata's residence, entered her room, poured petrol on both of them and set her and himself on fire. Later, family members rescued them in critical condition, Faruk added.

Khalilur was admitted to Dhaka Medical College Hospital where he died a day later. Lata was admitted to the burn institute.

Raipur Police Station's Sub-inspector Alamgir Hossain said, "We come to know from her family members that Lata died today [yesterday]."

to increase the number of beds in all government hospitals in phases.

In reply to another query of independent lawmaker Md Nasser Shahrear Zahedee, the minister informed that there are only five graduate pharmacists in all the government hospitals.

Replying to a supplementary question

of opposition chief whip Mujibul Haque Chunnu, he said he can certainly close illegal clinics and diagnostic centres with support from the lawmakers.

"If the treatment of marginalised population is ensured, there will be no crowd of patients in cities like Dhaka and Chattogram, and no one will have to lie on hospital floor," he also said.

following legal hassles, after at least 73 cases were filed by the encroachers. The cases are still pending with courts.

"The encroachers had prepared fake documents to show the river's land in their names, and constructed numerous structures," said Md Mosharaf Hossain, assistant director of BWDB.

"We have earlier identified 1,053 illegal structures that have

been built, encroaching Ichamati's land, according to a survey by experts from Buet," he also said.

Shudhanshu Kumar Sarkar, the project's director and superintendent engineer of BWDB, said, "Ichamati was significantly disconnected from its mother rivers -- Padma and Jamuna. The project will restore the connection."

The project will be completed within three years, he added.

Under this project, 10 courtrooms in nine districts have been refurbished.

The minister also said they have incorporated effective rules in the Children Act.

Adequate logistics support, separate courtrooms, congenial environment and trained manpower are needed

to ensure the effective enforcement of this law. Simultaneously, relevant knowledge and competence of all concerned are vital, he noted.

Huq said his ministry has been working to enhance the capacity of the training institutions to execute relevant laws related to child rights and set up separate courts for children.

former additional secretary to the Ministry of Agriculture, said malnutrition has stunted growth among children in Rangamati and Khagrachhari.

"While nationally the average height of children matches their age, it is 90 percent in Rangamati and 94 percent in Khagrachhari," he said. Also, 59 percent of people in Rangamati and 57 percent in Bandarban have access to safe water, while the national figure is 99 percent, he added.

Aungsuipru Chowdhury,

chairman of the Rangamati Hill District Council, stressed that the region is lagging significantly behind in nutrition related statistics, and urged the CHT affairs ministry to take more initiatives to this end.

Zakir Hossain Akanda, former secretary to the Planning Commission, emphasised on education, high-value crop cultivation, market linkages and economic development to improve quality of life and nutrition among indigenous people.

Raja Devasish Roy,

chief of Chakma Circle, stressed coordinated implementation of nutrition programmes at district, upazila and village levels.

Mashiur Rahman, secretary to the CHT affairs ministry, said, "Government efforts are on to ensure food and nutritional development among people of CHT region. Strengthening economic stability will further enhance their well-being."

Mohsin Ali, general secretary of Right to Food Bangladesh, presided over the discussion.

His jail sentence was effective from March 14, 2003 and ended on September 28, 2003. But he is still languishing behind bars in a Feni jail for unknown reasons.

This is the story of one man, but it echoes the plight of 156 others -- serving time in Bangladeshi prisons long after their sentences ended, according to the report.

The court had earlier sought the report in response to the petition filed by Supreme Court lawyer Bivuti Tarolder, challenging the government officials' inaction in releasing and repatriating Govinda Uriya to India's Tripura from Bangladesh upon completion of his jail term for illegal entry.

Deputy Attorney General Amit Das Gupta represented the state during hearing of the petition.
