'No one can rig votes in EVM' Says EC Anisur ahead of **Cumilla by-polls**

Election Commissioner Anisur Rahman yesterday said there is no scope for vote rigging in the EVM (electronic voting machine) system and urged candidates to accept the result of the polls.

He said this during a discussion with the candidates of Cumilla City Corporation by-election at the Cumilla Circuit House.

EC Anisur also exchanged views with officials and employees involved in the by-polls.

"This election is being monitored by local and foreign organisations. This is also as important as the national election," he told the candidates at the discussion.

He also denied that there was a controversy over the results of five polling stations and that a phone call delayed the announcement of the results of the last city elections. The CCC by-polls will be held on March 9.

MAR 9 PATUAKHALI POLLS Electioneering in full swing

Candidates for mayoral and councillor posts are campaigning at full throttle ahead of the Patuakhali municipality polls slated for March 9.

The election campaigns began following distribution

of symbols on February 23. The 132-year-old Patuakhali municipality was established on April 1, 1892, across 30 square kilometres area, and was upgraded to first class on August 5, 1989. It has a total population of around 2.5 million at present.

Khan Abi Shahanur Khan, district election officer and also returning officer, said there are a total of 50,699 voters in the municipality -- 26,750 female, 23,947 male, and two voters from third gender.

A total of 61 candidates are contesting the polls -- five for mayoral post, 41 for councillor post, and 15 for reserved seats for councillors -- in nine wards. The voting will be conducted in a total of 24 centres using electronic voting machines, he added.

The five mayoral candidates are incumbent mayor Mohiuddin Ahmed; his elder brother Abul Kalam Azad; former mayor and also organising secretary of district Awami League unit Dr Md Shafiqul Islam; and vice presidents of AL's municipal unit Md Enayet Hossain and Nasir Uddin Khan.

Among the mayoral candidates, incumbent mayor Mohiuddin Ahmed and former mayor Shafiqul Islam are ahead in their campaigns, while two other candidates Mohammad Enayet Hossain and Nasir Uddin Khan are also trying to draw voters' support. Only Abul Kalam Azad has yet to begin electioneering.

"I have tried to beautify Patuakhali town during my tenure in the last five years, alongside much development works. However, projects worth Tk 3,000-4,000 crore are still incomplete. I promise to complete those works if I am elected again," said Mohiuddin.

"After being elected in 2011, I served for eight years and carried out significant development works during my tenure. I have a master plan to transform Patuakhali into a developed and smart municipality," said Shafiqul.

Tk 1,554cr project to revive dying Ichamati

Ichamati, once a mighty river and a major lifeline for Pabna residents, has long been struggling to survive due to pollution and encroachment. Originating from the Padma,

the 82-kilometre-long river flows through the Pabna district headquarters, eventually reaching the Hurasagar area in Bera upazila.

It has long been a cherished dream of Pabna residents to see the river revived to its former glory.

That dream may soon come true. The government has taken a Tk 1,554.90 crore mega project aimed at "Rejuvenating River Ichamati". They have handed it over to the Engineering Division of Bangladesh

As part of the project, extensive dredging work will be conducted across a 33.77km stretch of the river, 44.07km long canals connecting it, 20km of Sutikhali river, and 12.37km of Bharara canal. Also, numerous construction works will also be carried out, which include 10km retaining wall, 10km drainage, 23 new bridges, 56 ghats, and a 10km walkway on the riverbank.

Army to conduct the project work. a tourist spot, while also restoring Board is the implementing authority of the project.

As part of the project, extensive dredging work will be conducted across a 33.77km stretch of the river, 44.07km long canals connecting it, 20km of Sutikhali river, and 12.37km of Bharara canal. Also, numerous construction works will also be carried out, which include 10km retaining wall, 10km drainage, 23 new bridges, 56 ghats, and a 10km walkway on the

riverbank. A total of 42,310 trees will also e planted along this walkway.

"After the project is complete, Ichamati river will return to its

former glory and will transform into

Bangladesh Water Development river communication with Pabna,' said Md Afsar Uddin, executive engineer of BWDB in Pabna.

SM Mahabub Alom, founder of a citizens' platform, said the connection between the Padma and Ichamati snapped over the decades, which reduced the river's flow. Taking advantage of it, encroachers occupied Ichamati's land on both sides over the years.

Additionally, rampant pollution has turned the river into a garbage dump, he added.

Facing demands from locals, BWDB earlier initiated a Tk 8.13 crore project to evict encroachers and dredge the river in 2021. However, it was stopped

'RECRUITMENT ANOMALIES' PSTU VC, UGC chairman sued

A case has been filed against four people, including the vice chancellor of Patuakhali Science and Technology University (PSTU) and the chairman of University Grants Commission of Bangladesh, on charges of irregularities in recruitment.

The accused are PSTU VC Prof Swadesh Chandra Samanta, Additional Registrar (Acting) Prof Santosh Kumar Basu, Treasurer Prof Muhammad Ali, and the UGC chairman.

Israt Jahan, an applicant for the post of section officer, filed the case with Patuakhali Senior Assistant Judge's Court on Tuesday.

Humaun Kabir Badsha, lawyer for the complainant, confirmed the matter. "My client filed a case with the court on February 27, and the court issued summons to the accused." Contacted, PSTU Registrar (Acting) Prof

Santosh Kumar stated, "I can't comment on whether the case has been filed or not as no official documents have been received yet.

"If a case is filed, we will respond officially," said PSTU VC Prof Swadesh Chandra.
