

# Three killed, seven injured in road accidents

At least three people were killed and seven others injured in road accidents in Sylhet and Dinajpur vesterday, according to reports received from our local correspondents.

Two passengers of a CNG-run auto-rickshaw were killed after it was hit by a truck on the Dhaka-Sylhet highway in Habiganj's Nabiganj upazila.

Two other people, whose identities could not be ascertained immediately, were injured in the accident.

The deceased were identified as Abdul Hakim, 38, and Mulchan Bibi, 50, of Mithamoin upazila in Kishoreganj district.

Parimal Chandra Deb, officer-in-charge of Sherpur Highway Police Station, said an auto-rickshaw was hit by a Sylhet-bound truck in Aushkandi around 11:30am, leaving the two dead on the spot.

The highway police rescued the injured and sent them to Habiganj 250-bed District Hospital.

Following the accident, a tailback was created on the Dhaka-Sylhet highway.

The situation became normal after an hour. Meanwhile, a policeman was killed when a bus ran over

his motorcycle in Golapganj upazila of Sylhet. The dead was identified as Abul Hussain, a constable,

said police.

The officer, stationed at Bahubal Police Station in Habiganj, was going to Zakiganj village when the accident occurred, said Masudul Amin, officer-in-charge of Golapganj Police Station.

A bus coming from the same direction ran over the motorcycle, killing him instantly, he said.

"We are trying to arrest the bus driver," he added.

His body has been sent to Sylhet MAG Osmani Medical College Hospital for autopsy, and no case has been filed yet.

While in Dinajpur, five people were injured after two buses collided head-on in Bochaganj upazila yesterday.

The incident happened when a Dhaka-bound bus from Hanif Enterprise crashed into another from Shyamoli Paribahan at Gangapur village on Pirganj-Dinajpur road around 9:00am, said Nazrul Islam in-charge of Bochaganj Fire Service and Civil Defence.

Four injured passengers and one staff member of Hanif Enterprise were taken to a hospital, while others received primary treatment and were discharged, Nazrul said.

# **Teaching social skills can** boost academic performance

#### Reveals study on primary students

Providing primary-level students with socioeconomic skills at an early age can immensely impact their mental growth and intelligence, revealed a new study yesterday. This can help them improve their

patience, self-control and ability to socialise, especially for students studying between the second and fifth grade, it added. The training involves offering

weekly lessons on social and emotional skills for 28 weeks. The lessons are based on social and emotional learning programmes Clubs developed by Lions International Foundation.

Teaching children basic life and social skills can improve their academic performance by up to 20

percent, according to the study. Shyamal Chowdhury, a professor at economics department of the University of Sydney in Australia, unveiled the findings while presenting his research paper "Formation of Socio-Emotional Skills and Their Effects on Educational Attainment" -- at a seminar in the capital.

Bangladesh Institute Studies (BIDS) Development organised the event at its conference room in Agargaon, with its Director General Binayak Sen moderating the session.

Chowdhury said these three central social-emotional skills(patience, self-control and educational attainment, labour sustained in Bangladesh.

The research programme was conducted among students from the second to fifth grade across 69 elementary schools in Bangladesh, in cooperation with LCIF and the Ministry of Primary and Mass Education. During their programme, they provided various training sessions to the teachers and parents. There is no alternative to focusing



### **MURSHEDY'S HOUSE** HC verdict March 10 STAFF CORRESPONDENT

The High Court will deliver a verdict on March 10 on the writ petition seeking its directives to recover the Gulshan house allegedly occupied by Awami League lawmaker Abdus Salam Murshedy illegally.

The bench of Justice Md Nazrul Islam Talukder and Justice Kazi Ebadoth Hossain yesterday fixed March 10 as the date for delivering judgement after hearing the petition.

Supreme Court lawyer Sayedul Haque Suman, now an independent lawmaker, submitted the petition as a public interest litigation to the HC on October 31, 2022.

In the petition, Suman said Rajdhani Unnayan Kartripakkha (Rajuk) had given ownership of the luxurious building of Housing and Public Works department to Murshedy, lawmaker from Khulna-4 constituency, by making forged documents.

During the hearing, the Anti-Corruption Commission's lawyer Khurshid Alam Khan told the HC that the commission, in a probe, found that fraudulence, forgery, and abuse of powers occurred during the allocation of the Gulshan house and plot of Murshedy.

ACC has filed a criminal case against 11 people under the Penal Code and Section 5(2) of the Anti-Corruption Act of 1947 following the inquiry report. ACC will now investigate the case and take the next course of action.

Murshedy's lawyer Mohammad Sayed Ahmed Raza prayed to the HC to examine the probe reports earlier submitted by Rajuk and ACC so that nobody involving the property is prejudiced.

Barrister Aneek R Haque appeared for writ petitioner Suman, while DAG Saifuddin Khaled and Advocate Zakir Hossain Masud represented the state and Rajuk, respectively, during the hearing.
