

Newlywed's body recovered from husband's residence

The body of a newlywed woman was recovered from her husband's residence in Pallabi area of Dhaka on Sunday evening.

The deceased was identified as Mahfuza Motaleb, wife of Aminul Islam.

Pallabi police station Officer-in-Charge Apurbo Hasan, quoting Mahfuza's family, said, Aminul used to torture Mahfuza, demanding dowry since their marriage as his mother-in-law has a FDR of Tk 7 lakh.

On Sunday evening, Aminul phoned Mahfuza's family, asking them to come to his residence as she fell sick. When they reached, they found her dead.

On information, a police team recovered the body from the house and sent it to Suhrawardy Medical College Hospital morgue for autopsy, the police officer said.

Police arrested the husband in connection and Mahfuza's family filed a case.

# Rod-laden truck causes bridge collapse

Hampers traffic movement on Barishal-Bhola highway

Vehicular movement on Barishal-Bhola highway has remained suspended since Sunday after a newly constructed bailey bridge collapsed on Saheber Haat Canal in Barishal Sadar upazila.

An overloaded truck carrying iron rods plying the bridge caused it to collapse on Sunday morning, leaving its driver and helper injured while cutting off the road communication on the route, said Abdur Rahman Mukul, officer-in-charge of Bandar Police Station.

Since then, traffic movement has been suspended on the highway, leaving hundreds of good-laden trucks, passenger buses and other vehicles stranded for one kilometre on both ends of the bridge, said Mizanur Rahman, assistant engineer at Roads and Highways Department in Barishal.

Since yesterday morning, RHD has been trying to build an alternative road to restore communication on the highway. Another 24 hours will be required to this end, the official also said.

People are using an alternative route on foot to cross the



canal and reach their destinations, he added.

Azad, a truck driver, was stuck at one end of the bridge carrying 18,000 litres of diesel and petrol from Mongla.

"I started at noon on Saturday. By the time I reached the spot, vehicles were no longer moving

due to the collapsed bridge. Around a hundred goods-laden trucks are stuck here. Now the officials are saying that we would have to remain here for another day," he said.

"As the road communication is suspended, there is a shortage of essential products in the local shops and market," said Nadira Rahman, chairman of Tungbaria union parishad.

Locals alleged that the bridge, built just about a month ago, has

been vulnerable from the very beginning.

Visiting the spot, Masud Mahmud Suman, executive engineer of RHD in Barishal, said the bailey bridge had a capacity to sustain 20 tonnes of load.

The accident occurred as a truck carrying more load than the bridge's capacity tried to ply it, he also said.

Efforts are on to restore Bhola-Barishal road connection as soon as possible, Masud added.

## Missing schoolgirl's body recovered

Police recovered the body of a schoolgirl from the Kaliganga River in Kuserchar area of Manikganj Sadar upazila yesterday, two days after she had gone missing.

The deceased was identified as Samia Islam, 14, daughter of Saiful Islam of Chandina village of Cumilla district.

According to police and family sources, Samia, a ninth grader, remained missing since she left home on Saturday afternoon for tuition. A general diary has been filed with Sadar Police Station.

"The body has been sent to Manikganj General Hospital morgue for autopsy. We are investigating the matter," said Officer-in-Charge of the station Md Habil Hossain.

AL's Agriculture and Cooperative Affairs Secretary, Faridunnahar Laili, earns Tk 24 lakh per year, while she has movable assets worth around Tk 2 crore. Others whose movable assets exceed

crores include Ashrafun Nessa, Shamima Harun, Parveen Zaman, Runu Reza, Nadia Binte Amin, and Bedora Ahmed Salam.

from Nepal through Indian company GMR is almost final while import of renewable energy is also progressing. The import and export from Meghalaya, Tripura or Assam can be discussed.

He said the process of importing LNG and gas through H Energy is almost final.

"We want to increase the connectivity with neighboring countries including India. We need Indian cooperation."

Nasrul Hamid said that power trade will get momentum if there is a dedicated line from Nepal to Bangladesh. This will also benefit India.

He also said that it is essential to have the stakeholders' meeting of both sides every month to increase the area of cooperation.

We can also work together on bio-fuel and LPG, he said.

The High Commissioner acknowledged that India's cooperation with Bangladesh in the power and energy sector is growing.

Import of hydropower from Nepal to Bangladesh is ongoing, he said, adding India is also importing about 600 MW of electricity from Nepal.

The issues on high voltage transmission lines, renewable energy, import-export of electricity, R-LNG, fuel capacity enhancement, energy efficiency, and future regional connectivity came up for discussion in the meeting.
