Building fires acts of 'culpable homicide'

Say experts, blame govt agencies and building owners

Experts at a press conference vesterday termed the frequent incidents of fires in buildings in the capital as acts of "culpable homicide"

They also called for holding the government agencies concerned and building owners responsible and accountable for the incidents.

Bangladesh Environmental Movement (Bapa), Bangladesh Institute of Planners (BIP), and Bangladesh Environmental Lawyers' Association (Bela) jointly organised the press conference titled "City Overwhelmed by Risky Buildings: What Needs to be Done?" at Jatiya

Architect Iqbal Habib, also vice-president of BAPA, emphasised a lack of enforcement as a significant cause

Approval process for businesses like restaurants require permits from 10 government agencies, but the approvals are often issued without proper inspections, he said.

In many cases, businesses operate without approval entirely, he also said.

"Therefore, these 10 government agencies, including city corporations, environment department, district administrations, fire service, as well as the business operations, should be held accountable under the law for culpable homicide," he added.

TAQI MURDER

11 yrs on, probe yet to be completed

Yet another year of the killing of Tanwir Muhammad Taqi in Narayanganj passed by and the investigating body, Rab, like the past nine years, said the investigation is still ongoing, prolonging the wait of Taqi's parents

The grieving parents saw a glimpse of hope days before Taqi's first death anniversary when Rab claimed that it had cracked the murder mystery and even prepared a draft probe report.

The draft probe report was leaked in the media, revealing involvement of 11 people, including Azmery Osman, in the killing.

Azmery is the son of late Jatiyo Party lawmaker Nasim Osman and nephew of ruling Awami League MP Shamim Osman. A day before Taqi's first death anniversary,

Col Ziaul Ahsan, the then additional director general of Rab, told the media they had evidence of the involvement of the 11 and insisted the charge sheet would be submitted

That day, however, has yet to come, even after 10 long years, highlighting the authorities' unwillingness to end it.

"Rab prepared the charge sheet, but it did not press it in last 10 years as members of Narayanganj's influential Osman family are involved in this murder," Rafiur Rabbi, Taqi's father, told The Daily Star recently.

The family has an 'undeclared indemnity' by the government, he alleged.

According to the leaked probe findings, Azmery not only masterminded the murder of the bright teenage boy in Narayanganj but also directly took part in it.

At his directives, his accomplices followed Taqi and forcefully took him to his "torture centre" at Winner Fashion on Allama Iqbal Road on March 6, 2013.

Later that night, Azmery and his cohorts beat and strangled the seventeen-year-old boy to death. His body was then put into a sack and taken to Charargop area in Azmery's

From there, the killers took the body to Kumudini Jora Khal in a boat and dumped it in the Shitalakkhya sometime between 1:00am and 1:30am on March 7.

Taqi's body was recovered from the river the next day, according to the findings.

Taqi went missing after he left his Shaista Khan Road home in Narayanganj for Sudhijon Pathagar, a local library, around 4:00pm on March 6, 2013.

A day after his body was found, his A-level results were out, which showed he got the world's highest mark in physics in that exam, obtaining 297 out of 300.

FIRE RISKS IN BUILDINGS Rajuk to start

10-day drive STAFF CORRESPONDENT

Rajdhani Unnayan Kartripakkha (Rajuk) will be conducting a 10-day inspection across eight zones to identify buildings at risk of fire hazards, said Rajuk Chariman Anisur Rahman Miah.

The comments came during a views exchange meeting with the City Development Journalist

Inspectors of Rajuk will inspect buildings which are at risk of fire hazards and submit a report within 10 working days and will also warn those violating fire safety regulations.

Anisur also said that they will put banners on building that are at risk.

If the owners, who are in violation of fire safety rules do not make changes even after the warning, then they will face action from Rajuk, said Anisur.

A survey conducted after the fire at Siddique Bazar last year found that 683 buildings were using their basements to store flammable items, violating rules. Rajuk issued several warnings and notices, but most of them did not fix the issue, the Rajuk chairman noted.

We have decided to issue another notice to clear their basements within the next seven days. We will check again and if rules are still being violated, action will be taken, he added.

'It will foster more money laundering' Say JP MPs on offshore

Opposition Jatiyo Party lawmakers vesterday in parliament feared that money laundering from the country will increase through offshore banking following the passage of "Offshore Banking Bill, 2024." Finance Minister Abul Hasan Mahmud Ali placed

the bill in the House, which was passed by voice vote. Participating in a discussion before passage of the

bill, four JP MPs -- Opposition Chief Whip Mujibul Haque Chunnu, Hafiz Uddin Ahmed, Masud Uddin Chowdhury, and Ruhul Amin Hawlader -- demanded the bill be sent to a committee to elicit public opinion on it. The proposal was rejected by a voice vote.

This is the first time the government is making offshore banking law in the country.

"Big thieves, big fishes, state leaders, and smugglers use offshore banking in island nations like the Bahamas to make their black money legal and to launder money abroad," said Chunnu.

"Names of some people from Bangladesh have appeared in newspapers. They laundered money through offshore banking and built houses and hotels

Chunnu fears increasing money laundering from the country through offshore banking.

The other JP lawmakers echoed him. As per the proposed law, non-resident individuals or foreign firms can open offshore bank accounts in Bangladesh to invest here, with a license from SEE PAGE 4 COL 5
