Banking outlook revised to stable from negative

US rating agency Moody's Investors Service yesterday changed its outlook for Bangladesh's banking system to stable from negative, which will relieve the central bank boss of stress.

It comes at a time when there is a negative perception at home and abroad about the country's banking sector.

The changed outlook reflects "our expectation that profitability and liquidity stress has eased despite ongoing asset-quality difficulties", Moody's said in a report.

It said profitability would be stable due to steady net interest margins (a profitability indicator that measures the difference between interest income and interest paid out by financial institutions) and credit costs. Capital will also be stable because internal capital generation will

be in line with capital consumption, it said, adding that the lenders' funding and liquidity will be tight but stable.

The stable outlook also reflects our expectation that the government will continue to support banks when needed to maintain systemic stability," it said.

Zahid Hussain, former lead economist at the World Bank's Dhaka office, said Moody's latest outlook is a positive sign for Bangladesh's banking sector.

"There has been an erosion in global confidence about Bangladesh's banking sector. The latest outlook will prevent this," he said.

The central bank has implemented several reform measures in the banking sector in line with the International Monetary Fund's \$4.7 billion loan programme, a Bangladesh Bank official told The Daily Star yesterday.

It has been a year since the reforms were taken up and some improvements are already visible, he said, adding, they expect more progress

ahead. Moody's latest outlook could be a reflection of the reforms, he

Moody's had downgraded the outlook to negative from stable in March last year when Bangladesh went for the IMF loan programme. Moody's in its latest outlook mentioned that the economy's operating environment would deteriorate as economic growth slows and inflation

Bangladesh's real GDP growth, which historically has been about 6.5 percent, is expected to slow to 6 percent in the fiscal year ending June

2024 and 6.3 percent in the fiscal year 2025, Moody's said. It also said the moderation in economic growth will be due to a weakening of external demand and persistently high import prices and inflation. As a result, the country's trade deficit will moderately widen.

In the banking sector, Moody's said despite rising asset risks, loan-loss provisions would be broadly steady because of regulatory forbearance that allows banks to actively restructure or reschedule problem exposures and continue classifying those loans as performing.

Petroleum prices cut as automatic pricing kicks in

The government has reduced the price of octane by Tk 4, petrol by Tk 3, diesel and kerosene by Tk 0.75 per litre.

The new prices based on the previous month's average rate in the global market were put in effect at 12:00am yesterday.

Each litre of diesel and kerosene now cost Tk 108.25, petrol Tk 122, and octane Tk 126, according to a statement issued by the energy and mineral resources ministry. Fuel prices will be adjusted every

month from now on, it said. The government introduced a system of automatically setting fuel prices on

February 29, complying with a condition for the International Monetary Fund's In India, a litre of diesel costs Tk 133

and petrol Tk 152, the statement added.

According to a ministry gazette, Bangladesh Petroleum Corporation (BPC) now sells a litre of diesel at Tk 99.98, petrol at Tk 111.29, octane at Tk 115.12 and kerosene at Tk 100.85 to three state owned oil distributors

Sujanagar upazila had never dreamed of the life she has now. Equipped multiple certificates and

degrees, she could not land a job despite going from door to door. Akhi, 33, is now the

proud owner of a handicraft business in her village, from where her products are going even to Europe.

Her success, however, was not served

on a silver platter. Over the last decade, Akhi had to face one struggle after another - torture, deprivation, discriminations, financial troubles, job crisis, and even suicidal

Born in a rural family, Akhi was determined to get a good education and build a successful career. However, after she got married at the age of 23, her academic pursuits came to an abrupt halt. She then faced a failed marriage, which led to intense flak

from society. Akhi, however, did not give up and went on to complete her master's degree.

After getting remarried and birthing two sons, she left with her family to Qatar for work but then came back empty-handed in 2020

in the face of the Covid-19 pandemic. Then began a dire financial crisis, through which she and her husband would have to starve at times to be able

to provide food for their children. "That was when I really considered committing suicide. But my husband pushed me. He had confidence in me.

Tikka Khan was handed over the responsibilities of both the governor and martial law administrator in East Pakistan. He was also the chief of Eastern Command. However, the all-powerful governor could not find a judge to swear him in as Justice BA Siddiqui, chief justice of the East Pakistan High Court, refused to administer the oath, citing "ill health" as the reason.

The martial law officer in Dhaka tried to make alternative arrangements but failed. According to the President's legal parchment, the swearing-in ceremony must be administered by the chief justice of the concerned province. His nominee, or a local judge of the Supreme Court, can't perform the task. General
