## Journo beaten up by supporters of ward councillor

A journalist from Jamalpur's Bakshiganj upazila was assaulted allegedly by supporters of a local ward councillor last evening.

Matin Rahman, the Bakshiganj correspondent of The Daily Bhorer Darpan, was admitted to the upazila health complex.

He was attacked in the Namapara area of Bakshiganj municipality while collecting information on a clash between the supporters of councillorelect Kamruzzaman Sujan and the supporters of defeated councillor candidate Zainal Abedin around 6:30pm.

On Saturday, Kamruzzaman Sujan was elected councillor of Ward No 5 of Bakshiganj municipality in the by-election.

The supporters of the winning candidate launched an attack on the residence of the defeated candidate, said local journalists.

On information, Matin and another journalist went to the spot to collect the news about the incident, they added

## Man dies after attack by ward councillor's men

A man died at a Chattogram hospital yesterday while being treated for injuries he sustained after being attacked at his home by a local ward councillor's men, during a dispute over the due rent of a flat in the port city's Panchlaish area.

The victim, Nayan Chowdhury, 34, was assaulted early Saturday by followers of Mobarak Ali, councillor of Paschim Sholoshohor Ward under the Chattogram City Corporation, said Chattogram Metropolitan Police Assistant Commissioner (Panchlaish) Arif Hossen.

"Nayan, along with his two brothers, used to rent a flat in Muradpur, but haven't paid rent for four years. To collect the due rent, the landlord complained to Mobarak's office. Following this, Mobarak's men showed up at the flat early Saturday and assaulted Nayan, leaving him seriously injured."

He was first taken to Chattogram Medical College Hospital (CMCH), from where he was transferred to a private hospital as his condition deteriorated, said the police official.

"The victim's family did not inform police following the incident. Police learned the matter after his death," said Sontosh Kumar Chakma, officer-in-charge (OC) of Panchlaish Police Station.

A case was lodged in this connection and the body was handed over to the family after an autopsy at the CMCH morgue, he added.

Police detained one Hossain-ul-Islam in this connection.

## US trying to meddle in **Russian presidential polls**

Says Moscow's spy service; Sweden joining Nato shows Putin 'failed': Nato chief

President Vladimir Putin's foreign intelligence service yesterday accused the United States of trying to meddle in Russia's presidential election and said that Washington even had plans to launch a cyberattack on the online voting system.

Putin, who is almost certain to win the March 15-17 presidential election, has warned the West that any attempts by foreign powers to meddle in the ballot would be considered an act of aggression, according to Reuters.

Russia's SVR Foreign Intelligence Service said in a statement it had information that US President Joe to meddle in the election, state media reported.

the SVR was cited as saying. "With the participation of leading American IT specialists, it is planned to carry out cyberattacks on the remote electronic voting system, which will make it impossible to count the votes of a significant proportion of Russian voters," the SVR said.

The SVR, the main successor to the KGB's First Directorate foreign spying service, did not set out any evidence for its assertions. There was no immediate reaction from Washington.

The West casts Putin as a dictator, a war criminal and a killer who has led Russia into an imperial-style land grab that has weakened Russia and forged Biden's administration had set out Ukrainian statehood, while uniting the West and handing Nato a post-Cold War mission.

Putin casts the Ukraine war as an

after the fall of the Soviet Union. The Kremlin last week said that Russia will not meddle in the November US presidential election, and dismissed American findings that Moscow orchestrated campaigns to sway both the 2016 and 2020 US presidential elections.

Elsewhere, Nato chief Jens Stoltenberg said yesterday that Sweden's accession to the US-led alliance showed Russian President Vladimir Putin had "failed" in his Ukrainian war strategy of weakening it, reports AFP.

## TK 600CR INCOME TAX SC asks HC to rehear Grameen Kalyan's petitions

The Supreme Court yesterday asked its High Court Division to hold further hearing on two writ petitions that challenged the NBR orders asking Grameen Kalyan to pay around Tk 600 crore as income tax.

The HC bench, led by Justice Muhammad Khurshid Alam Sarkar, has been ordered to hold the rehearing and dispose of the petitions in three months.

A five-member bench of the Appellate Division of the SC, headed by Chief Justice Obaidul Hassan, passed the order after hearing two leave to appeal petitions filed by the National Board of Revenue (NBR) against the HC verdict on the writ petitions.

The four other judges of the bench are Justice M Enayetur Rahim, Justice Md Ashfaqul Islam, Justice Md Abu Zafor Siddique and Justice Jahangir Hossain Selim.

The NBR reassessed Grameen Kalyan's income tax for the tax years 2011-12 to 2016-17 and asked Grameen Kalyan to pay the amount.

Disposing of the two writ petitions, the HC bench led by Justice Muhammad Khurshid Alam Sarkar last year allowed the Grameen Kalyan to lodge an appeal with the appellate authority of the NBR challenging its reassessment of the income tax.

Grameen Kalyan is a non-profitable and charitable organisation founded by Nobel laureate Professor Muhammad Yunus.

The NBR in its appeal said Grameen Kalyan has filed the review petition with a declaration that the organisation will not lodge any appeal against the reassessment.

So, the HC has no authority to allow Grameen Kalyan to move an appeal against the reassessment order, Assistant Attorney General Tahmina Poly told The Daily Star, citing the NBR's appeal.

Attorney General AM Amin Uddin appeared for the NBR while Sarder Jinnat Ali argued for Grameen Kalyan during the hearing.

## Woman gets death penalty for killing husband

A Joypurhat court yesterday sentenced a woman and her accomplice to death for killing her husband over a domestic dispute in Khetlal upazila of Joypurhat.

The convicted are Jotsna Begum, 45, of the upazila's Durgapur village and her accomplice Bulu Mia, 50, of the upazila's Khanpara village.

Nurul Islam of Additional District and Sessions Judge's Court-1 handed down the verdict in the presence of the accused.

The court also fined each Tk 50,000.

Public Prosecutor Nripendranath Mondal said the Jotsna and her husband Jamirul Islam started to grow apart after she got involved in an extramarital affair with Bulu.

On November 9, 2015, the duo murdered Jamirul Islam in a planned way.

## Nagad's user info in public domain

The information that was obtained within a second include NID number, name, date of birth, father's a functioning account. This is name, mother's name and address. They are unable to access, or output transaction data of customers.

The Telegram bot started operating in November 2023, while the channel was created on January 31, 2024. The website was created on January 27, 2024.

All of the Telegram channels had names with the word "Nagad" in it.

In a written response on March 7. Nagad said that "personal information of Nagad customers remains completely secure and free from all forms of risks."

In order to verify if only Nagad's information was being user returned, The Daily Star ran searches from February 23-March 6 with phone numbers not linked to Nagad, or phone numbers linked to other mobile financial services, and neither this specific bot nor this specific website returned any results.

Within the Telegram channels and bots, the user data requested was shared publicly, such that all those within those groups could have access to it.

It was impossible for The Daily Star to ascertain who ran the Telegram channel, bot or the website since all the information was masked.

The Telegram channel claims that it was reproducing the information from the "KYC" or "Know Your Customer" database.

Nagad denied this, calling it a 'smear campaign.'

"Nagad stores all personal identification of customers in encrypted format. However, it is disheartening to observe that vested interests are trying to take advantage of this situation by launching a smear campaign against Nagad across various platforms including social media," it said in its response

to The Daily Star.

KYC is a step that customers must complete in order to have mandatory under Bangladesh Mobile Financial Services Regulations 2022 The step entails uploading scans

of the NID of the customer, following which, the app extracts all relevant information from the card and autofills them into the customer's profile.

Although the KYC database also stores photos of the user, the bots and websites tested out by this newspaper were unable to return those.

"We have promptly taken effective measures in response even though there may not have been any data breach from our end. Besides, we have also got our systems reviewed by security consultants to ensure no system vulnerability persists. It needs to be mentioned that Nagad uses state-of-the-art technology and security infrastructure & framework to secure its system above all customers' information," said Nagad.

Nagad has over 80 million registered users making it one of the two leading mobile financial service operators in Bangladesh. Their daily transactions go over \$111 million, according to a Nagad press release issued in August 2023.

This probable leak follows the heels of multiple similar leaks of citizen data last year. One such leak was from the government's land tax portal.

Security Index updated on January 31, 2024, Bangladesh scored a zero in the category of protection of personal data.

Bangladesh however scored highly in "cyber incident response" which judges how effectively breaches or leaks are managed. Its global ranking is 24.

All of the information found

in these leaks is classified as personal data, according to the data protection bill, which upholds the right to privacy.

The bill was approved in principle by the cabinet, but it is yet to be passed as a law. It states that personal data cannot be collected or processed by anyone without the user's consent.

It acknowledges that data privacy is a right. It also legally puts the onus on the data collector to alert "data subjects" within 72 hours in case there is a personal data breach.

Violations of the law carry administrative fines.

The Bangladesh MFS Regulations 2022 protects confidentiality of customer transactions information, but mentions nothing about personal data.

In the case of traditional banks, however, customers' data are confidential and the banks cannot share the data except with relevant regulatory or law enforcement authorities as per the local laws, said Md Saimum Reza Talukder, a senior lecturer who teaches cyber law at BRAC University. Even then, they need authorisation from a court.

Around the world, failure to comply with data protection laws may bring serious consequences for businesses both in the short and long term. It not only results in legal and financial penalties and sanctions, but also diminishes a company's reputation, he said.

"For example, according to According to the National Cyber General Data Protection Regulation (GDPR) of the European Union, if client's data is infringed due to a company's failure to use appropriate technical measure, a temporary or definitive ban on data processing and a fine up to 20 million euros or 4 percent of the business's total annual worldwide turnover, whichever in higher, can be imposed," said Talukder.
