22 migrants die as boat sinks off Turkey

7 children among them

Twenty-two migrants including seven children have drowned after a boat capsized off the Turkish coast, local officials said yesterday.

Two people were rescued by the Turkish coastguard and another two managed to make it out of the water on their own, officials said. The victims' nationalities were not yet

The boat capsized off Turkey's largest island, called Gokceada or Imbros, which is located in the Aegean Sea off the coast of the northwestern province of Canakkale, near Greece's Lemnos island.

'The Turkish coastguard found the bodies of 22 people including seven children," the local governor's office said in a statement.

The search and rescue operation was backed by one airplane, two helicopters, a drone, 18 boats and 502 personnel, it added.

Turkey is hosting nearly four million refugees, mostly Syrians.

Many migrants try to reach the Greek islands from Turkey's western coasts hoping to eventually reach prosperous European Union countries, with many dying in the perilous sea crossing.

There has been an increase in migrant crossing attempts in the waters between Turkey and Greece in recent weeks.

The Turkish coastguard indicated that it had rescued or intercepted several hundred migrants, including children, attempting to cross to Greece since the start of the week.

The EU border agency Frontex said this week that the number of irregular border crossings into the bloc in the first two months of this year reached 31,200 -- similar to the level from a year ago, according to preliminary calculations.

In the eastern Mediterranean, the second most active migratory route after the Western African route, the number of detections more than doubled to 9,150 in the first two months of the year, it said.

The Mediterranean Sea has for several years been the centre of migrant flows from Africa and the

Middle East to Europe. The influx peaked in 2015 as migrants, many fleeing the Mideast upheaval caused by Syrian civil war, sought refuge in Europe.

Indian SC to hear pleas seeking stay on CAA rules

New Delhi dismisses Washington's concern about its citizenship law as 'misplaced'

India's Supreme Court yesterday said it will hear a batch of petitions seeking a stay on the implementation of the contentious Citizenship Amendment Rules, 2024.

Several petitioners, including the Indian Union Muslim League, moved the apex court after the union government notified the rules, by filing interlocutory stay applications in their pending writ

A bench, consisting of Chief Justice D Y Chandrachud and justices J B Pardiwala and Manoj Misra, acknowledged the arguments put forth by senior lawyer Kapil Sibal, representing the IUML. Sibal asserted that once citizenship is granted to migrant Hindus, it cannot be revoked, thus emphasizing the need for an expedited hearing on the matter.

"We will hear this on Tuesday. There are 190 plus cases. All of them will be heard," CJ Chandrachud said.



Under the Citizenship Amendment Act, 'persecuted" Hindus, Christians, Sikhs, Buddhists, Parsis and Jains who entered India from three of its neighbouring countries till 2014 are eligible to get citizenship.

The rules for implementing CAA were notified on March 12, more than four years after the law was passed by Indian parliament.

Meanwhile, Indian the foreign ministry yesterday said comments by the United States expressing concern about India's implementation of the citizenship law are "misplaced, misinformed, and unwarranted".

India's move this week sparked sporadic protests, with critics, including Muslims groups and opposition parties, saying the law was discriminatory and undermined the country's secular constitution.

In a statement, the US State Department said it was "concerned" about the notification of the law, citing "respect for religious freedom and equal treatment" as a fundamental democratic principle.

We are of the view that it is misplaced, misinformed, and unwarranted," Randhir Jaiswal, a spokesperson for India's Foreign Ministry, said yesterday, in response to the US statement.

3 killed, 27 wounded as Al-Shabaab's Mogadishu hotel siege ends

Three people were killed in an hours-long siege by Al-Shabaab jihadists at a popular hotel near the presidential palace in the Somali capital Mogadishu, police said yesterday.

Armed fighters stormed the SYL hotel in a hail of bullets late on Thursday before security forces announced they had brought the situation under control after more than 13 hours.

It broke a relative lull in violence by the Al-Qaeda-linked group, demonstrating its continued ability to strike despite a major military offensive against the militants.

"Three people died in the attack and 27 others including 18 civilians and nine soldiers were wounded," Somali police spokesman Colonel Qasim Ahmed Roble told a press conference, adding that the injury toll included three lawmakers.

Security forces also killed five assailants in a gunbattle, he added.

"The situation at the hotel is back to normal now," Roble said.

The attack on the SYL hotel -- which has been targeted several times in the past - occurred at the start of the holy Muslim month of Ramadan and was claimed by Al-Shabaab.

"What is more important is that the supply is increased and the costs at producer and wholesale levels are reduced. Otherwise, fixing the prices of some products won't work," he

observed. On March 11, the commerce ministry fixed the price of dates, one of the key items for iftar. The price of low-grade dates was fixed at Tk 150 to Tk 165 per kg. However, traders did not follow the rate.

Visiting Shewrapara, Ibrahimpur, Kochukhet, and Karwan Bazar kitchen markets in the capital yesterday, The Daily Star found that retailers were selling the cheapest dates for Tk 200 a kg. However, the quality of the dates was not good.

Traders said they were unable to

purchase dates at the government- prices. set rate.

proprietor Akhter Hossain, of Modina Fruits Collection at Kochukhet kitchen market, said he was selling dates for Tk 300-Tk1,800

The Daily Star also found that the prices of local and imported fruits increased by Tk 20-50 a kg.

a kg, depending on varieties.

A kg of apple (gala) was being sold for Tk 360-380, up from Tk 320-340 last week; malta for Tk 360-380, up from Tk 320-330; grape for Tk 280-300, up from Tk 240-260, and papaya for Tk 160-200, up from Tk 140-180.

The prices of oranges and pears have also surged by Tk 10-20 per kg, according to traders.

Kanu Miah, a fruit seller at Kochukhet kitchen market, said customers blamed them for increased

"The price fluctuation is not within our control. When our purchase prices increase, we are forced to sell fruits at higher prices," he said.

The price of potatoes has gone up by Tk 5 per kg compared to last week. Yesterday, potatoes were sold for Tk 35-40 a kg, up from Tk 30-35.

Although the prices of some essentials including aubergine, lemon, green chillies and coriander leaves have come down, those were still being sold at prices higher than those fixed by the government.

at Karwan Bazar, said the prices of some vegetables have dropped as the demand has decreased.
