## AL leader blamed for lifting sand from Jamuna

#### Erosion may worsen as a result, fear locals

Influentials with political support are extracting sand illegally from raised shoals of Jamuna river in Tangail's Bhuanpur upazila, alleged locals.

Excavators were being used to extract sand indiscriminately, especially at night, from at least 10 points on the shoals in Jagatpura, Kuthiboyra, Dakshin Jagatpura and Nalin areas under Arjuna union of the upazila, by managing the local administration, alleged locals.

Sand is also being lifted from a shoal adjacent to a dam of Bangladesh Water Development Board stretching from Nalin to Kuthiboyra area. After extraction, the sand is carried to a part of the embankment using trucks, by cutting a part of the embankment.

In some places, the sand traders are also extracting sand and soil from cultivable lands by paying a nominal amount to the land owners.

Hundreds of truckloads of sand are being sold every day.

Locals fear the unabated illegal sand lifting will eventually worsen Jamuna river's erosion in the monsoon.

According to the Sand Quarry and Soil Management Act-2010, no underground sand or soil can be lifted by pumping

or dredging or any other means. Sand mining is prohibited near bridges, culverts, dams, barrages, embankments, roads, highways, forests, railway lines and other important public and private structures or within a minimum of one kilometre from residential areas.

Violations of the laws are punishable with imprisonment or fine or both, while dredgers, trucks and other related materials used in the offence are supposed to be seized by the authorities concerned.

"Every year, these sand lifters extract sand from the shoals. If someone does not want to give their land then they would forcibly extract sand from his land," alleged Manzur Ashraf of Jagatpura village.

"Later, during monsoon, severe erosion occurs in these areas. However, the authorities seem to have turned a blind eye to this menace," he added.

Mofazzal Hossain Sarkar of Arjuna area said, "Due to the indiscriminate sand lifting, Bhuanpur-Tarakandi dam is under threat. Some local Awami League leaders are managing the authorities concerned to carry on this sand trade worth crores of taka."

Sanwar Hossain of Jagatpura village echoed them.

### Fire breaks out at electronics market in Ctg

A fire broke out at the Rifle Club Electronics Market in Chattogram's New Market area yesterday evening.

Four fire engines have been engaged to douse the blaze, according to Chattogram Divisional Fire Service Headquarters.

Assistant Commissioner AC (Kotwali Zone) Atanu Chawkrabarty of Chattogram Metropolitan Police said police and firefighters are working on the spot.

Smoke engulfed the whole area where firefighters were trying to bring the situation under control, he said.

Witnesses said the fire originated at the UCB Bank Rifle Club branch office on the ground floor of the four-storeyed building at around 7:00pm.

The Chittagong Rifle Club building houses hundreds of electronics shops. The reason behind the fire could not be known immediately, he added. No casualties were reported so far.

## Delay in dyke construction threatens Boro harvest

Farmers say only 60pc work completed despite extended deadline, BWDB denies claims of anomalies

Farmers in the haor (wetland) areas under Sunamganj district have alleged that the government has failed to complete the construction and repair works of dykes for protecting croplands on time.

As a result, flash floods may cause significant damage to their Boro harvest... again.

According to officials of Bangladesh Water Development Board (BWDB), 90 percent construction and repair works of crop protection dykes was completed by the February 28 deadline and 98 percent by the extended deadline on March 7.

However, farmers and rights activists observed that only around 60 percent works have been completed by March 7, bringing allegations of negligence and low-quality work.

They also said that the government had also failed to complete the works even after extended time in the previous two years.

According to the BWDB, 591 kilometres of dykes at 38 haors in Sunamganj are being constructed and repaired under 735 projects, with an estimated budget of Tk 125 crore.

According to the Department of Agricultural Extension in Sunamganj, Boro paddy is estimated to be cultivated on 223,245 hectares of land in the district this year - including 165,350 hectares in low-lying haor

Located at the foothill of India's Meghalaya state, Sunamganj has a unique ecosystem due to the haors, which allow irrigation water for Boro paddy cultivation during the dry season, before being harvested within April-May.

However, excessive rainfall in Meghalaya often triggers flash floods during the harvest season, damaging the crops.

To address this, the government started constructing dykes to protect the Boro crops. After the flash floods of 2017 that revealed the anomalies and corruption in dyke construction, the government revised the "Kajer Binimoye Taka (Kabita)" rules, dictating formation of project implementation committees by November 30 every year to

build or repair the dykes.

The new rules also stipulate that the work must be started before December 15, and completed by February 28.

Talking to this correspondent, at least 10 farmers from Dharmapasha, Madhyanagar, Jamalganj and Jagannathpur upazilas of the district said most of the dykes were not constructed or repaired timely this year.

"It has become a common practice that they

budget this year was the highest compared to previous years, the works are marred with anomalies and irregularities," said Bijon Sen Roy, general secretary of Haor Bachao Andolon's central unit.

"Visiting the dykes, we have found that the compaction is not correct, the grass is not planted, important closures are vulnerable and many other anomalies. We will take legal action against those responsible," said Bijon,

Since December 15 last year, many allegations of anomalies in forming project committees, intentionally delaying works, and using substandard materials have surfaced.

However, Mamun Howlader, executive engineer of BWDB in Sunamganj and member secretary of the district committee, refuted the allegations.

"Around 98 percent works has been completed while the finishing touches like grass plantation, correcting compaction and strengthening important parts are on progress," he added.

He also termed the allegations of irregularities as baseless.

### AL leader hacked to death

A local Awami League leader was hacked to death in Barishal's Hizla upazila yesterday. Police recovered the body of Jamal Majhi from a soybean field in Barishal's Hizla upazila.

He was the acting president of Ward-7 of Dhulkhola union Awami League.

Hizla Police Station Officer-in-Charge Zubair Ahmed said the body was recovered around 12:30pm. "He was hacked to death. We can' say who did it after an investigation," he added.

The OC said Saydur Rahman, another local AL activist, was assaulted on Friday night, allegedly by Jamal Majhi's son and his associates. Saydur's wife subsequently filed a complaint at the police station regarding the assault. This incident has sparked tension between the two parties since then.
