Capacity to outpace demand

Says UK-based BMI Research; idle facilities rack up capacity charges

Bangladesh will end up with surplus LNG regasification capacity by the end of this decade, said the UK-based BMI Research -- a development that will ultimately cost the exchequer in fees similar to capacity charges for power plants.

At present, there are two floating storage and regasification units (FSRUs) -- which re-gasifies the imported liquefied natural gas and supplies to the national grid — with a combined annual capacity of 7.6 million tonnes (mtpa).

The government has planned four more LNG terminal projects: one onshore in Matarbari with the capacity to regasify 7.6 mtpa LNG, two FSRUs with the same capacity in Moheshkhali and Payra, and extending the capacity of one of the two existing FSRUs.

Based on the planned projects, an additional 21 mtpa of LNG regasification capacity will be added before the end of the decade, said BMI Research in its latest commentary SEE PAGE 2 COL 3

4 suspected robbers beaten to death

Villagers beat four people to death and severely injured another one in Narayanganj's Sonargaon upazila on Sunday night on suspicion that they were robbers.

After noticing a group of strangers in Baniabari area around 9:45pm, locals announced on loudspeakers of mosques that there were robbers in the area, police said.

Hundreds of people from at least seven villages then gathered with sticks, sharp weapons and spears and

caught the five men and beat them up. A team from Sonargaon Police Station reached the area around 12:05am and saw that the mob had left.

After searching the area, police found the body of a man and two severely injured others in a ditch. Of the two, one died at Dhaka Medical College Hospital hours later and the other was admitted to National Institute of Traumatology and Orthopaedic Rehabilitation (Nitor).

After daybreak, police found the bodies of two other men in another

The man who died at the DMCH was identified as Zakir Hossain, 40, of Sukhertek area in Sonargaon. Zakir was previously accused of robbery in at least three cases and he was arrested before, said Sheikh Billal Hossain, additional superintendent of police in Narayanganj.

The men whose bodies were found in the morning were Araihazar residents Abdur Rahim, 48, and Nabi Hossain, 35. They were also previously accused in robbery cases, Billal said.

The man admitted to Nitor is Mohammad Ali, 45, of Araihazar upazila. He is also accused of robbery in cases filed earlier.

The body found on the night of the incident has not been identified vet.

The men who were killed and wounded were stabbed and hit with sticks, police said.

HIJACKED MV ABDULLAH Somali forces, foreign navies prepare raid

Reports Reuters citing Somali cops; ship-owning firm opposes move

Somali police and international navies were preparing to raid Bangladesh-flagged commercial ship MV Abdullah that was hijacked by pirates last week, Reuters reported vesterday citing comments made by Somali police.

The ship, with 23 crew members on board, was hijacked off the coast of Somalia last week, the latest of more than 20 attacks since November by Somali pirates who had been dormant for nearly a decade.

On Saturday, the Indian navy rescued a cargo vessel, the Maltese-flagged MV Ruen, which had been seized in December, freeing its 17 crew members and arresting 35

The police force from the semi-autonomous region of Somalia's Puntland, a base for many pirate gangs, said it was on high alert and prepared to participate in an operation against the pirates holding the Abdullah,

"Puntland police forces are ready after they got reports that international navies are planning an attack," the police said in a statement.

India's navy, which has disrupted several other attempted hijackings, did not immediately respond to a

A Cumilla court yesterday placed Jagannath University student Raihan Siddique Amman and suspended assistant proctor Din Islam on a twoday and one-day remand respectively in a case filed over the alleged instigation of law student Fairuz Sadaf Abontika's suicide.

Police had prayed for a five-day remand for Amman and a two-day remand for Din Islam.

Senior Judicial Magistrate Abu Bakar Siddique passed remand order. He also ordered police to submit the investigation report within the next seven working days.

The two were produced before a Cumilla court around 10:45am.

Exim-Padma Bank merger to take at least 18 months

Two banks sign MoU

The planned merger of Shariah-based Exim Bank and struggling Padma Bank is likely to take between 18 months to two-and-a-half years to complete, according to central bank officials.

Yesterday, the two banks signed the letter of intent to merge, which is the very first stage of the merger.

Now, the banks will have to submit a formal application to the Bangladesh Bank with a copy of the scheme of merger with documents, The Daily Star has learnt from central bank officials informed with the proceedings.

The documents include the secured and unsecured debts. In the case of secured debts, particulars of the securities and their value have to be provided. The value of the property, the assets and the liabilities of the two banks must be furnished too.

If the central bank is satisfied with the draft scheme, it will give the go-ahead to the merger, as per the existing guideline on merger and acquisition.

While there is a guideline for merger or amalgamation of banks and financial institutions from 2007, it needs to be updated for the current times. The updated guideline will be published soon, the BB officials said.

After examination of the draft scheme, the central bank will appoint auditors in those banks for the valuation of assets and liabilities, said BB Spokesman Md Mezbaul Haque yesterday.
