Preferring not to dwell on past disputes, Apurba hinted that everything that needed

fellow artistes. Earlier on March 14, Apurba was accused of embezzlement, breach of contract, and schedule manipulation. This complaint was made by the production company Alpha i Studios Limited.

According to the production company, after signing a contract for 24 dramas on the remuneration of Tk 50 lakh, Apurba participated in the shoots of only nine fictions, and received Tk 33 lakh from the company in advance. They also claimed that after receiving the advance money, Apurba suspended all kinds of communication with the company.

However, all litigations against the actor, including breach of contract and embezzlement, were resolved after a meeting with the members of Telepab and Actors Equity, which took place on Saturday (March 16).

The meeting, which lasted approximately six hours, was attended by key figures including Alpha i Managing Director Shahriar Karim Bhuiyan (also known as Shahriar Shakil), actor Ziaul Faruq Apurba, Actors Equity President Ahsan Habib Nasim, Actors Equity General Secretary Rawnak Hasan, Telepab President Monowar Pathan, and Telepab General Secretary Sazu Muntasir.

Bangladeshi director Furukh dead in London car crash

Bangladeshi director GM Furukh, known for his work in TV series, passed away in a car crash in London on Sunday.

He was taken to the Royal London Hospital after being severely injured in the accident. Tragically, the artiste succumbed to death

after nearly four hours of surgery.

Shadhin Khosru, another expatriate filmmaker in London, confirmed the news via a post on Facebook.

London expatriate Furukh was a resident of Sylhet's Beanibazar area. He used to direct local dramas in London in his regional language. He was also a member of Bangladesh Film Directors

JnU student, asst proctor remanded

Abontika's mother alleged that Amman sexually harassed her daughter both online and offline, while the assistant proctor reportedly verbally abused her when Abontika informed him about the matter.

Before her death by suicide on Friday night, Abontika wrote down the allegations on her Facebook

Meanwhile in Dhaka, the JnU law department has declared a suspension of all academic activities for two days, protesting the incident.

The declaration was followed by a human chain in front of the vicechancellor's office building around 11:00am, demanding justice for

Sumaiya Soma, a student of JnU's theatre department, said, "A culture of impunity has been prevailing in the university for a long time, leading to the deaths of Abontika and others.

"The university administration is responsible for this. If it had kept the anti-sexual harassment cell functional and taken action based on a fair investigation, then no student would have lost their life."

She added, "We lost Abontika and others due to the lack of a fair trial in previous incidents and the absence of proper action. We demand justice for all such incidents, including Abontika's death."

Taukir Ahmed, another protesting student, said, "We demand the punishment to the culprits as soon as possible. Without a fair trial, there is no guarantee that such incidents will not recur."

Following the human chain, the protesters also staged a sit-in in front of the VC office until 3:00pm.

Speaking to The Daily Star, Advocate Nurur Rahman, former president of BLAST (Cumilla unit), said, "The culture of bullying has been on the rise. The Jagannath University administration cannot avoid the responsibility for Abontika's death due to bullying. Exemplary punishment should be meted out to the culprits."

PSC to be revived

Besides, to ensure consistency in recruitment practices, the report suggested establishing a research unit to assess district quotas, pay grades, recruitment rules, and qualifications for various positions.

"This unit will help identify any discrepancies and streamline the recruitment process," it said.

Several officials involved in the process, wishing anonymity, told The Daily Star that the Constitution tasked the PSC with the recruitment of all government employees.

They said that a separate PSC was used to recruit employees of classes three and four after independence, but then the process went to the government's hands.

The Constitution mandates the PSC to appoint employees at all levels of the government.

Article 140(1)(a) says the PSC is "to conduct tests and examinations for the selection of suitable persons for appointment to the service of the

Regarding the formation of employees, Article 137 of the Constitution says that "provision shall be made by law for establishing one

for Bangladesh, each of which shall consist of a chairman and such other members as shall be prescribed by

Public administration expert and a former additional secretary Firoz Mia lauded the government initiative.

"I think it's the best way. However, class four employee recruitment can be kept at the divisional level, and if the PSC thinks they can appoint them as well, then I don't see any problem," he told The Daily Star.

Contacted, Public Administration Minister Farhad Hossain said the plan, however, was yet to be finalised.

"Maybe the employees of classes one and two will be recruited under PSC-1, and those of classes three and four under PSC-2. Maybe the recruitment will be done after strengthening the existing PSC. Everything will be confirmed when this plan goes to the implementation

A senior official of the public administration ministry said that the report would be submitted multiple PSCs to recruit government to the secretary committee on administrative development, headed by the cabinet secretary.

No plan to raise train fares soon

travelling over 100km.

Currently, the BR gives a 20-30 percent rebate for those travelling over 100km. Once the BR cancels the facility that has been in place since 1992, the fares will go up, said

Talking to The Daily Star on Saturday, Sardar Shahadat Ali, who is serving as BR director general as part of additional charges, said Prime Minister Sheikh Hasina already gave the go-ahead to BR's proposal to cancel the rebate.

He added that they were planning to implement the decision from April 1 and once the rebate facility is scrapped, train fares would increase.

Besides, this correspondent has obtained a document that is actually the synopsis of the rail ministry's proposal.

Zillul and Railways Ministry Secretary Humayun Kabir signed the proposal on February 13 and the prime minister on March 2, shows the

At yesterday's meeting, the minister, however, said the news on the move to hike the train fares is a "rumour. "People know who spread rumours ... who torch trains and destroy railway lines.

"The BNP is hatching conspiracies, and the party killed people by setting fire to train in Gopibagh recently. The entire nation knows it.'

Although the minister held the BNP responsible for the fire, probe committee of railways authorities is yet to identify the culprits behind the arson attack on Benapole Express on January 5 that killed four people.

Talking about the derailment of Bijoy Express in Cumilla on Sunday, Zillul said the man who uprooted fishplates of the rail line fled the spot leaving an ID card and a bag after being chased.

"He did it in exchange for some money. BNP and its ally Jamaat usually do such things," the minister said, without giving any details.

BR has formed a committee, led by Anisur Rahman, divisional transport officer (Chattogram), to investigate the incident and asked it to submit the report within seven working days.

HC scraps stay

Islam Talukder and Justice Kazi Ebadot Hossain said the bail of the accused will remain in force as per order of the Labour Appellate Tribunal and they must inform the tribunal if they go abroad.

The bench also stayed the labour court's directive that asked Yunus and others to comply with relevant rules in respect of the jobs of the workers till disposal of the appeals.

The HC delivered the verdict after holding a hearing on the rule that questioned the legality of the Labour Appellate Tribunal's stay order on the sentences of the accused.

DIFE lawyer Khurshid Alam Khan told the HC bench that the US Ambassador Peter Haas has made a contemptuous remark when he said that the cases against Prof Yunus may represent a misuse of the labour law to harass and intimidate him, which is

contradictory to a Vienna Convention. Khurshid, however, could not place any media report to support the claim and said that he read the comment online.

The HC bench then said foreign diplomats should be careful while commenting on sub-judice matters.

According to media reports, the comment Khurshid talked about was made by US State Department Spokesperson Matthew Miller on February 12.

During the HC proceedings yesterday, Prof Yunus' lawyer Abdullah-Al-Mamun Khurshid's move before the bench.
