

OUR DYING PADMA

Poor upstream flow turns the river dry, farmers and fishers in trouble

in the flow of water from upstream, fishermen from the area echoed him. along with deposition of silt, has choked the riverbed, rendering it nearly unrecognisable.

The depletion of its flow along with the lack of rainfall has exposed vast stretches of the riverbed, where millions of tonnes of silt accumulate every year. The water in the river is now visible for only three to four months. The Ganges-Kobadak project has remained remaining eight to nine months see the water level plummet to its lowest point, revealing miles of sandy char lands 4.5-metre for pump operation in the G-K across the river's expanse.

"Earlier, even during dry season, I could catch at least 3-4 kilogrammes of fish daily. Now, catching barely 1kg of fish is difficult due to poor water flow in the river," he said.

According to hydrology experts, the mighty Padma dried up significantly this year due to poor water flow from upstream, adversely affecting the livelihoods of hundreds of fishermen from the areas adjoining the river.

Irrigation has been badly affected as the operation of pumps of the suspended due to poor flow.

months this year as per the Ganges Water Sharing Treaty due to poor flow of water at Farakka Point, said Md Rezaul Karim, executive engineer of Department of Hydrology, Pabna division.

According to the Joint Rivers Commission report, the flow of water at Hardinge Bridge point recorded at each 10-day cycle between January 1 and March 10 this year were 63,113 cusecs, 48,518 cusecs, 48,359 cusecs, 43,926

cusecs, 34,697 cusecs, 35,751 cusecs and 36,818 cusecs.

Around the same time in 2023, the figures recorded in the JRC report were 85,316 cusecs, 70,827 cusecs, 69,990 cusecs, 67,364 cusecs, 59,376 cusecs, 47,891 cusecs and 42, 372 cusecs.

"Due to poor discharge of water at Farakka Point, water flow reduced by 10-20 thousand cusecs at Hardinge Bridge point in the last couple of months. The poor upstream flow, alongside poor rainfall, is drying up the river alarmingly," Rezaul Karim also said.

According to the Ganges Water Sharing Treaty, both Bangladesh and India will get 50 percent share of water if the available water level at Farakka Point is 70,000 cusecs or less. If the level is 70-75 thousand cusecs, Bangladesh will get minimum 35,000 cusecs and India will get the rest. If the level is 75,000 cusecs or more, then India will get a minimum of 40,000 cusecs and Bangladesh will get the rest.

Both Bangladesh and India will surely get a minimum 35,000 cusecs water from March 11 till May 10, according to

Experts, however, opined that the treaty should be reshuffled considering the present perspective of the river's





'Bangabandhu took inspiration from Netaji Subhas' Sugata Bose tells event on Liberation War Museum's founding anniversary

During the Liberation War of 1971, Netaji Bhawan, the house of Indian nationalist Netaji Subhas Chandra Bose, became the heart of the activities in support of the war, said Netaji's grandson Sugata Bose yesterday.

Bangabandhu himself, alongside students, farmers, and youths of Bengal, who came to Netaji Bhawan during the war repeatedly mentioned how inspired they were by Netaji Subhas, Sugata also said.

Sugata, Gardiner Professor of Oceanic History at Harvard University, made the remarks while delivering a commemorative speech at an event titled "Memory and Preservation of the Liberation War", organised by Liberation War Museum marking its 28th founding anniversary.

'My mother Krishna Bose wrote in her diary that one day many unknown faces, including five boys from Kushtia and two students from Rajshahi University, were sitting at Netaji Bhawan with signs of disappointment and fatigue over their faces. Then she showed them the Netaji Museum,

TRAIN TICKET BLACK MARKET Rab uncovers syndicate inside Shohoz

Rab has arrested nine members of a train ticket black market syndicate -- including four employees of Shohoz Synesis Vincen JV -- a Shohoz-led joint venture -- the ticket selling partner of Bangladesh Railway.

The arrestees include -- Mizan Dhali, 48, the alleged kingpin of the syndicate; his nephew Sohel Dhali, 30; Md Sumon, 39; Jahangir Alam, 49; Shahjalal Hossain, 42; Md Rasel, 24; Joynal Abedin, 46; Sabur Hawlader, 40, and Newton Biswas, 40.

According to Rab, Mizan and Sohel are office assistants of Shohoz, while Newton and Sabur were server operators of the platform.

Rab-3 with members of National Security Intelligence arrested the group on Thursday night, Khandker Al Moin, Rab's Legal and Media Wing director, told a press briefing yesterday.

The arrestees admitted to collecting tickets and selling those at 2-3 times higher prices, he said.

"We have information on transactions worth Tk 1 crore in various mobile banking accounts of the syndicate members in the last six months," he added.

Mizan has been selling tickets on the black market since he joined as office assistant of the then ticketing partner

"Daffodil" in 2003. When Bangladesh Railway later partnered with Cnsbd, Mizan found a job there due to his experience. Then, in 2020, when the contract was given to Shohoz, Mizan moved there, Moin said.

Newton and Sabur, along with two other server operators who went into hiding, would provide details about tickets to Mizan and Sohel.

Then, Mizan, Sohel and other gang members - who had the passwords to many existing users' accounts – would log in and book tickets online or from ticket counters with the help of countermen, the Rab official said.

Moin said that agents across the country would place orders for tickets with Mizan and Sohel. After collecting tickets, Mizan and Sohel would send soft copies to the agents through messenger or WhatsApp. This gang were putting 500 tickets on

the black market daily, Moin said. Agents received 50 percent of the profit, while Mizan shared the rest with his syndicate members. During Eid season, Mizan and his gang

would sell around 2,000-3,000 tickets

through the black market. Moin said they will investigate whether any top officials from Bangladesh Railway or

Shohoz are involved in these illegal activities. SEE PAGE 4 COL 5

Is a government official above the law?

Doctor gets caught smuggling gold, not behind bars yet

Despite being caught red-handed with gold bars at the airport, the authorities concerned are dillydallying in taking any legal action against a physician of Chattogram Shah Amanat International Airport.

Officials of Bangladesh Customs and Directorate General of Health Services have said they are waiting for the findings of the probe committee of DGHS in order to take legal action.

However, the two-member probe committee has yet to submit its findings.

On January 29, customs officials arrested Dr MZA Sharif, a health officer at Shah Amanat International Airport, while he was carrying four gold bars.

Sharif, a Cadre (Health) of 27th BCS, used to work at the airport's Medical Services Emergency Department. After the incident, he was closed from the airport and was later attached to Chattogram Divisional DGHS office.
