

JAILED IN MALAYSIA
Three Bangladeshi workers released

Malaysian police released the three Bangladeshi workers who were arrested on March 21 after they lodged a complaint to the Labour Department of Malaysia.

However, the three workers are now concerned about their safety and well-being.

Malaysian Socialist Party (PSM), which has been supporting jobless, unpaid, and indebted Bangladeshi workers in the country, confirmed this to the media yesterday.

Dang Wangi Police Station arrested Jahirul Islam, Maruf Hossen, and Mofiz Sheikh, who were among those who filed complaint to the labour department and police against their employing companies – Suria Harmoni Resources SDN BHD and Beaks Construction SDN BHD.

M Sivaranjani, head of PSM's head of labour bureau, in a statement, said the three workers were released by the police on bail but were asked to appear in court tomorrow [Monday]. PSM lawyers are trying to ascertain the reason why they should be present in court unless that is an attempt to charge them.

"PSM views the arrest as a form of intimidation to create fear among the other workers who, in recent weeks, have lodged numerous police reports against the employer for multiple offences," Sivaranjani said.

EID JOURNEY TO NORTH
Gridlock feared near Bangabandhu Bridge

Transport workers have expressed concern over severe gridlock near Bangabandhu Bridge during Eid journey this year, despite various steps taken to facilitate a hassle-free journey.

According to associations of transport owners and workers, as well as Highway Police personnel, the Dhaka-Tangail highway, known as the gateway to the north, connects 26 districts through 116 land routes.

During normal times, around 15-20 thousand vehicles pass through Bangabandhu Bridge daily. However, the number increases several times before Eid, leading to huge pressure of vehicles on the road, with long tailbacks on both ends of the bridge, and thereby causing much suffering to the homebound passengers.

For around 60-65 kilometres between Chandra of Gazipur and Elenga of Tangail, vehicles can cross with normal speed. However, the narrow 13 km long two-lane Eastern Link Road after Elenga slows down vehicle movement, causing tailbacks

till Bangabandhu Bridge toll plaza. "Along with excessive pressure of vehicles, unfit vehicles and reckless driving are also major problems on the road," said Delwar Hossain, traffic inspector in Tangail.

"If a vehicle breaks down or gets into an accident, it takes at least an hour to remove it with a wrecker. During this time, a long tailback is created," he added.

During a visit to the Eastern Link Road, this correspondent saw work was underway to widen the road to four lanes on four kilometres of the road till Bangabandhu Bridge.

Meanwhile, an inter-department meeting was held at Tangail Police Lines recently to ensure safety of passengers and keep the highway free of traffic congestion during Eid rush.

"Once the link road is widened, it will lessen the traffic congestion. The roads division has assured to complete the work before the Eid journey," said Sarkar Mohammad Kaiser, superintendent of police in Tangail.

For a couple of days before the Eid, the link road from Elenga to

the bridge will be turned one-way, and Dhaka-bound vehicles from north will be bypassed through the old Bhuapur road, the SP added.

But Saiful Islam, a bus driver on the Dhaka-Rangpur route, is not so hopeful. "The Dhaka-bound vehicles were bypassed through Bhuapur road last year too, but it did not make any difference," he said.

Mamun Miah, a bus driver on Dhaka-Pabna route, said, "The vehicles could not return to Dhaka on time due to severe gridlocks formed on the extremely narrow Bhuapur road, causing disruption to the schedule, and sufferings to the passengers."

Kaiserul Islam, deputy commissioner of Tangail, said, "Different measures including increasing the number of toll booths at Bangabandhu Bridge, and setting up separate toll booths for motorcycles are on the card."

Officials of the district administration along with executive magistrates will be on duty on the road to ensure smooth journey for the people, he added.

N'GANJ, MUNSHIGANJ FIRES
100 shops, plyboard factory gutted

Fire engulfs over 100 shops in N'ganj, plyboard factory in Munshiganj Star Report

Two fire incidents occurred yesterday in Narayanganj and Munshiganj, resulting in damage to markets and factories. However, no casualties were reported from either of these incidents.

A fire broke out at Gausia kitchen market in Narayanganj's Rungganj upazila, gutting over a hundred shops.

Saleh Uddin, deputy director of Narayanganj Fire Service and Civil Defence, said, "The fire started around 3:15am. Ten fire engines brought it under control by 5:45am."

Petroleum and plastic hardware products fueled the flames, he added.

Meanwhile, in Munshiganj, a fire erupted at a plyboard factory in Gazaria upazila.

Witnesses reported the fire starting at 1:00pm. Fire service officials deployed twelve fire engines, but the blaze persisted till evening, said Rifat Mallik, station officer of Gazaria fire service.

Hiran Miah, 32, a worker at the factory, sustained burn injuries and was transferred to Dhaka Medical College Hospital.

'No syndicate in Biman'
Says its MD on allegations of ticket hoarding

Biman yesterday refuted allegations of the presence of a ticket syndicate or ticket blocking while selling to travel agencies.

"There is no question of ticket blocking. We don't sell tickets for any routes to an agent without names of passengers. This is beyond our policy," Biman Managing Director and CEO Shaiful Azim said at a press conference at Biman's headquarters in the capital's Kurmitola.

He made the remarks while addressing allegations of the presence of a ticket syndicate, alongside the blocking of tickets of the national flag carrier.

"We don't spare anyone who is involved in any irregularities or corruption. Biman takes the highest action against its officials if someone is found involved in any irregularities," said the Biman MD.

As part of good management and success, Biman has incurred operations profit in the last

MEGHNA TRAWLER CAPSIZE
Death toll rises to 6 as 3 more bodies recovered

The death toll from Friday's trawler-bulk carrier collision on Meghna rose to six as three more bodies were recovered from the sunken trawler yesterday.

Three people remain missing following the incident that took place between Kishoreganj's Bhairab and Brahmanbaria's Ashuganj, said Superintendent of River Police (Kishoreganj) Abdullah Al Mamun.

The three deceased are Mahmuda Sultana Iva, 7, daughter of Bhairab Highway Police Station's constable Sohel Rana; Rupa Dey, 30, of Bhairab; and Anika Akter, 18, a college student in Narsingdi.

The three missing are constable Sohel Rana, 34, his five-year-old son Raisul and Belon Dey, 45, of Katiadi upazila in Kishoreganj.

The three bodies were found inside the sunken trawler around 3:00pm, hours after the trawler was recovered yesterday noon.

Two killed in Ctg road crash

Two people were killed after a pickup van hit a truck from behind on Dhaka-Chattogram highway in Nizampur area under Chattogram's Mirsarai upazila yesterday morning.

The deceased were identified as Masum Billah, 40, driver of the pickup van, and Abdur Rahim, 42.

"The Chattogram bound pickup van hit the truck from behind around 7:15am, leaving two dead on the spot," said Abdul Hakim Azad, officer-in-charge of Kumira Highway Police Station.

"The bodies were sent to CMCH for autopsy," the OC said.

"We seized the pickup van, but the truck and its driver managed to flee the scene," he added.

Police have been asked to remain alert so that the teenage boys cannot get involved in any crimes forming 'teen gang'.
