

Huge cache of narcotics recovered in Thakurgaon

Law enforcers recovered a huge cache of illegal drugs and narcotics during anti-narcotic drives conducted in five upazilas of Thakurgaon over past eight months.

At least 48,175 contraband yaba pills, 8,871 illegal painkiller Tapentadol tablets, 2,399 bottles of phensidyl, 38 kilogrammes of marijuana and 73 grammes of heroin were recovered during the drives.

Police also arrested 835 people in this connection, said Uttam Prasad Pathak, superintendent of police in Thakurgaon, during a press briefing recently.

Also, 160 people were rescued after abduction, and 76 stolen mobile phones were recovered by police during separate drives, the SP also said.

Furthermore, police realised a revenue around Tk 2 crore from different vehicles under transport law and disposed of about 3,500 arrest warrants, he added.

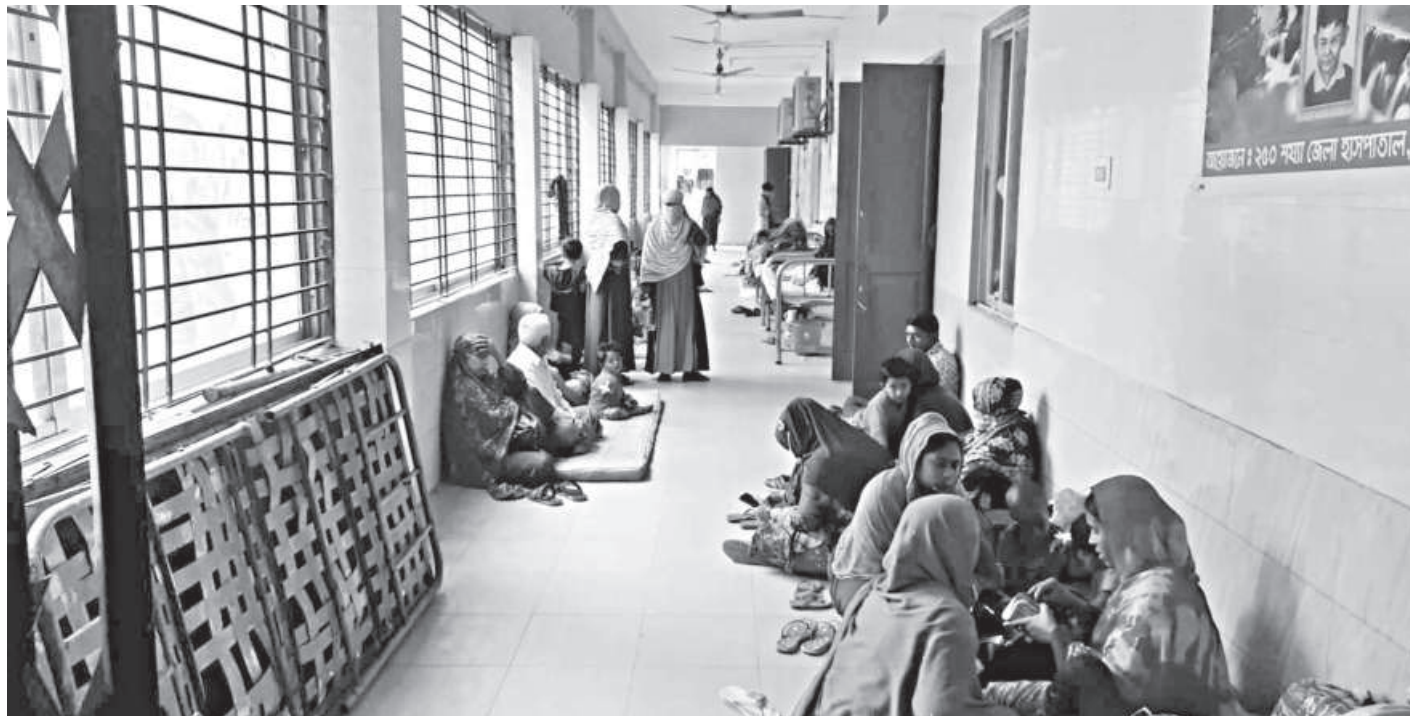

## BAGERHAT 250-BED HOSPITAL

# Services in jeopardy amid acute manpower shortage

An acute shortage of doctors and staff has left patients at the Bagerhat 250-bed hospital deprived of much needed medical care.

The lone public hospital, that serves 17 lakh people in the district, is currently running with less than half of its required manpower.

The hospital was originally established in 1970 with 50 beds. Later, it was upgraded to 100 beds in 1997 and 250 beds in May of 2022.

Of the 56 posts of doctor at the hospital, 30 are vacant at present, including the posts for assistant director, consultants for ophthalmology, anaesthesia, surgery, and cardiology.

Additionally, 28 out of 109

posts for nurses, and 44 posts of second, third and fourth grade employees remain vacant.

As such, patients are being deprived of the services of essential specialist doctors, diagnosis and medical care. Patients from Bagerhat are often having to travel to Khulna and Dhaka seeking medical treatment, bearing a burden of expenses that many find difficult to afford.

According to hospital sources, 700-1,000 patients are treated daily in its outdoors area, while 300-450 patients are regularly admitted against the 250 available beds.

Amid the shortage of manpower, the doctors and nurses often struggle to serve patients adequately.

The shortage of manpower even left the hospital's maintenance aspects, including cleaning and

hygiene, in utter disarray.

"I admitted my father here a week ago. The doctor says all tests are not available here. So, I am taking him home today. If we can arrange the money, I will take him to Khulna for treatment," said Rabiul Islam of Hazrakhali village under Kachua upazila.

Patients Ranu Rani and Masnu Sheikh shared similar experiences.

Waiting at the ticket counter with his ill child on his lap, Ruhul Amin Sheikh said, "There are many counters, but tickets are being sold at only two, while the rest are empty, including the one for pregnant women. As such, patients have to wait in long queues before getting admitted."

Serajul Sheikh, an attendant for a patient at the hospital, said the toilets are so dirty that it is difficult to use those, especially for the patients.

"There has not been the desired development in Bagerhat's health sector. The district's main hospital does not even have CT scan or echocardiogram facilities, or specialist doctors for consultation, which tells much about the sorry state of healthcare in the district," said Babul Sardar, convener of health sub-committee of Bagerhat Sachetan Nagarik Committee.

"Of the 58 first-grade posts, 32 are vacant at present. There are also some crises regarding pathological services. The number of patients the hospital has to deal with daily is also high. Yet, we are trying our best to serve the patients despite the limitations. The manpower crisis has been reported to the higher authorities," said Dr Asim Kumar Samaddar, superintendent of the hospital.



## Drive to recover Louhajang river continues

### District admin constructing walkways on riverbanks

With the drive to recover the Louhajang river in Tangail municipal area continuing in full swing, the once beautiful river is gradually returning to its previous shape.

The Tangail district administration began the drive on March 1. On the first day, around 2,000 members of BD Clean, a voluntary organization, took part to clean-up around 1.5km stretch of the river in the municipal area.

The district administration then started constructing walkways on both banks of the river after removing most structures on the riverbanks from Housing Bridge to Stadium area. Local environmental activists Ratan Ahmed Siddique and Nur Mohammad Rajjo are assisting the administration in the works.

Earlier, the then district administrations evicted illegal structures from both sides of the river during drives in 2016 and 2020.

Tangail Sadar UNO Hasan Bin Ali, who is coordinating the river recovery drive, said they are following the Water Act 2013 in carrying out the drive.

The people living in vicinity of the river are helping the administration spontaneous, with many of them having removed their structures from the river's land on their own, the UNO also said.

"The construction of the walkways may be completed by next week. The district administration is bearing the cost of the works so far," Hasan Ali added.

Gautam Chandra Chanda, divisional coordinator of Bangladesh Environmental Lawyers Association (BELA), lauded the initiative and recommended the authorities to keep the riverbanks free of traffic movement. "We request the authorities to follow the instructions of the higher court in this regard," he added.
