iftar mahfil organised by the Ziaur Rahman Foundation (ZRF) at the Ladies Club in the capital yesterday.

The 78-year-old former prime minister has long been suffering from various ailments, including liver cirrhosis, arthritis, diabetes, and issues related to the kidney, lung, heart, and eye.

On January 11, the BNP chief returned home from Evercare Hospital after receiving treatment for various health complications for over five months.

Since then, she has been receiving treatment at her Gulshan residence under the medical board that was

formed earlier at the Evercare receiving treatment at the hospital Hospital.

On August 9 last year, she was admitted to the hospital as she fell sick.

On October 26, three US specialist doctors completed the hepatic procedure known as transjugular intrahepatic portosystemic shunt (TIPS procedure) to stop water accretion in Khaleda Zia's stomach and chest, and bleeding in her liver.

Khaleda's doctors have been recommending sending her abroad since she was diagnosed with liver cirrhosis in November 2021.

Since her conditional release from jail in 2020, the BNP chief has been

under a medical board. Khaleda was sent to the Old Dhaka

Jail after a lower court sentenced her to five years imprisonment in the Zia Orphanage Trust corruption case on February 8, 2018. Later, she was found guilty in another corruption case the same year.

Amid the coronavirus outbreak, the government temporarily freed Khaleda Zia from jail through an executive order suspending her sentence on March 25, 2020, with the condition that she stay in her Gulshan house and not leave the country.

That has since been extended multiple times to keep her out of jail.

## Baltimore bridge being cut up after ship collision

The crumpled Baltimore bridge was being cut up in preparation for its removal, Maryland's governor said yesterday, promising "progress" was being made after it was destroyed by an out-of-control ship.

Demolition crews using blow torches sliced through the top part of the Francis Scott Key Bridge, which collapsed when the Dali cargo vessel lost power and struck it on Tuesday,

### killing six people.

"Progress is beginning to happen despite the fact that it's an incredibly complicated situation," said Maryland Governor Wes Moore, adding that weather conditions and debris in the water meant divers were unable to assist with the recovery operation.

"We now do have cranes, the Chesapeake 1,000, which has capacity of lifting a thousand а pounds," Moore told CNN yesterday. "(Workers have) begun to cut up

the remnants of the bridge that we can then prepare for removal."

Video footage shared Saturday by the Unified Command -- the overall response team that includes the US Coast Guard -- showed sparks flying as crews suspended in cages cut through an upper section of the steel structure.

The Unified Command said the wreckage will lifted away and processed at a Baltimore shipping site before being taken to a disposal site.
