

DUAL MASTER'S PROGRAMME BuEt, Irish univ sign MoA

University of Limerick (UL), Ireland and Bangladesh University of Engineering and Technology (BuEt) have signed a joint Memorandum of Agreement (MoA) to start a dual master's programme.

Prof Nigel Healey, vice president (global and community engagement) of UL, and Prof Satya Prasad Majumder, vice chancellor of BuEt, signed the agreement recently.

"BuEt has a very strict admission policy to admit the top talents from Bangladesh. These students need formal conduits of higher education. UL, with its industry network located in Ireland, offers top-ranked graduate training and skill development through its world-class educational facility, and world leading research in advanced technology," said Prof Majumder, a renowned expert and leading academic in the field of fibre-optic communication.

Both Bangladesh and Ireland have seen positive economic growth and technological developments in the last two decades. Their relationship deepened following a St Patrick's Day visit this year by Simon Coveney TD, minister for enterprise, trade and employment of Ireland.



Vermicelli makers in overdrive for Eid

With Eid-ul-Fitr knocking at the door, vermicelli (semai in Bangla) makers in Chattogram city are having a busy time.

Vermicelli is a widely popular dessert item, served commonly consumed by people from all walks of life on Eid day.

There are two types of vermicelli - regular and laccha. Regular vermicelli is produced using flour and water, while laccha is produced with oil or ghee, flour, sugar and water.

Vermicelli traders in the port city Chaktai, Rajakhali and Chawkbazar areas said their profits have been curtailed due to high prices of flour, gas and electricity, alongside extra payment to the workers, putting the traditional profession at risk.

Visiting Rajakhali area, this correspondent saw workers at several factories drying vermicelli on rooftops.

"Vermicelli business has become more challenging as big companies are also producing item while prices of ingredients are on the rise sharply. We mainly target lower-income people

in the port city and upazilas," said Md Akbar Hossain, owner of a factory.

"So far we sold 2,500 buckets of vermicelli, each weighing 35 kilogrammes, which is a lower quantity compared to previous years," he added.

SM Harunor Rashid, a leader of Chaktai Industries and Traders Association, said there are around 10-15 vermicelli factories located in Chaktai-Rajakhali-Khatunganj areas where around 10,000 to 15,000 buckets of vermicelli used to be produced every Ramadan, with the demand increasingly sharply two or three days ahead of Eid.

Meanwhile, a section of unscrupulous businessmen in the port city are busy manufacturing sub-standard vermicelli, using unrefined palm oil, animal fat, and even toxic chemicals and colours, to cash on its high demand ahead of Eid, he alleged.

While all factory owners have been asked to maintain healthy conditions and using proper ingredients to produce the food item at the factories, it is difficult to monitor everyone, Harun added.

Pointing figure to BNP, Quader said as long as Tariq Rahman remains at the helm of BNP, it will not go in the right direction.

He asked Tarique to come back to do politics. "If you have courage, come home and do politics. Have the courage to go to jail. The people will not respond to your call from London," Quader added.

The meeting was scheduled to discuss organisational issues and celebration of Mujibnagar Day on April 17.

Earlier, Quader, at a discussion marking the 104th birth anniversary of Bangabandhu Sheikh Mujibur Rahman, emphasised improving overall healthcare in rural areas.

The AI spokesperson said the hospitals in rural areas seem like "stables for horses."

"Hospitals shouldn't be like stables. There are doctors, but no medicine in many areas. Emergency facilities like ICU should be available at the upazila level," Quader said.

He said the poor state of hospitals was exposed during the pandemic and stressed the need to prioritise the Ministry of Health among all the ministries.

one of us are facing such threats," the statement reads.

"Proof of these threats has been submitted to the university administration. We want help from the Prime Minister in this regard. We [students of all faiths] want a normal and safe campus. We want freedom of expression. We don't want our campus

to become a hub for terrorists," it added.

Earlier, during a press conference last Tuesday, many BuEt students appealed to Prime Minister Sheikh Hasina for a campus free from student politics.

In an open letter, they said that the environment of BuEt without student politics is most safe and education-friendly.

including Baushia-Nalbunia channel, Kirtankhola near Shaistabad in Barishal, estuary of Arial Khan river, between Hijla and Babuganj, and from Ulania to Sheora in Mehdinganj, among others, where the launch operation has been closed for a long time due to lack of navigability.

"There are shallow waters in at least six places between Barishal and Chandpur alone. As a result, these places cannot be navigated by the vessels without tide," said Zakir Hossain, manager of MV Sundarban Navigation Company, confirming the matter.

Excavation of river at different points on the route will solve the problem, said Abdur Razzak Miah,

supervising engineer at BIWTA Dredger Base in Barishal.

However, Saidur Rahman disagreed.

"Even though the BIWTA dredges at some places on this route every year, they dump the river sand back in the river, eventually forming shoals underwater. As such, we do not reap any benefit from the dredging," he said.

Islam said that after initially dispersing the protesters, a meeting was held involving workers, labour leaders, and factory authorities.

"Factory authorities assured disbursement of all salaries and bonuses on April 8," he said, adding that additional police personnel were deployed to prevent any disturbances.

Despite repeated attempts, factory's managing director, Abu Bakar Siddique Khan, could not be contacted over phone.
